

Dear Mr. Crain:

One of my investigators and a sex crimes investigator from the DeKalb County Police Department interviewed the above-named individual in our office this afternoon between 2:30 and 5:00 PM. Mr. Zegel admitted and we have evidence of conduct inappropriate for one involved in a leadership position in scouting. These matters involve improprieties in the area of sexual conduct and substance abuse. After consultation with the parents of the boys involved and upon the conditions that Mr. Zegel immediately enter into psychological counseling and resign his position as Scoutmaster for the troop located at St. Andrews Presbyterian Church in Tucker, Georgia, no criminal charges will be pressed at this time.
