June 4, 1987 - 4:30 PM

\_\_\_\_\_ calls me and tells me that Mr. John Brown sexually molested her nephew \_\_\_\_\_ - I told her I would call her back --  
I talked to Dale Holbrook and got the information on how to handle this --

I called the minister of the Methodist Church in Maineville - The Chartered Partner and informed him. I told him that I was going to meet with the Troop Chairman and that after that meeting I would call him back. Pastor Dayton told me he was going to call his Church Chairman and Legal Counsel to inform them. He expressed his concern about the incident and the potential fallout to this New Day Care Center.

I called \_\_\_\_\_ back to let her know what had happened so far and to tell her about the meeting I was going to have with John Rogerson, the Troop Chairman.

About 9:15 PM I met John Rogerson at his house and reviewed the situation with him.

I recommended that he and I meet with \_\_\_\_\_ on June 4th. John Rogerson called \_\_\_\_\_ at the end of our meeting and set up a meeting for Thursday, June 4th at 7:30 PM at her house.

I talked to Joe Quick about 10:15 PM and brought him up to date on what was happening.

June 4th, 1987

About 9:45 AM - I called Pastor Dayton to inform him about the meeting with John Rogerson and invite him or another representative from the church to the meeting at \_\_\_\_\_ house that evening. He could not attend but his Church Chairman, Mr. Mike Proud, could and would be in attendance. Pastor Dayton told me that Mike Proud was an Eagle Scout and very concerned about the total situation, i.e., family, church Troop and Scouting's image.

I talked to Dale Holbrook and updated him.

I talked to Joe Quick again and got two letters from him, one from the Church, one from The Boy Scouts, to be used to inform the Scoutmaster he was out of Scouting. (See attached copies)

At 7:30 PM Mr. Rogerson, Mr. Proud and I met with \_\_\_\_\_ and \_\_\_\_\_

\_\_\_\_\_ reviewed the story she had told me over the phone the day before.

May 18th the troop camped out at Oders Lake - \_\_\_\_\_ Her nephew (not a Boy Scout) stayed overnight and slept with Mr. John Brown, Scoutmaster, in his Camper Pickup truck.

The next Monday, [REDACTED] didn't go to the Troop meeting.

The next Monday the Troop didn't meet.

May 30th, John Brown came out to visit [REDACTED] about another troop mother and [REDACTED] again.

John Brown, [REDACTED] and Phil Walker, [REDACTED] son, went to visit another potential Scout in Johns truck.

One June 1st [REDACTED] went to a troop meeting and met with John Brown in his car after the meeting.

After dinner [REDACTED] and [REDACTED] and [REDACTED] were talking and [REDACTED] told them that John Brown had put his hand between [REDACTED] on the May 18th campout.

[REDACTED] told [REDACTED] to call Mr. Brown and tell him he didn't want to join the Boy Scouts and tell him why and tell him that he told [REDACTED] what happened.

After this conversation, John Brown told [REDACTED] that he wanted to talk to [REDACTED]

[REDACTED] told us that John Brown admitted doing this and was sorry - he told her it would not happen again and that she shouldn't tell anyone.

Tuesday, June 2nd, [REDACTED] called the Boy Scout office and no one was in but was told to call back on Wednesday and talk to Dale Holbrook or Mike Creagh.

Next we talked to [REDACTED].

[REDACTED] told us that he stayed in John Brown's truck/camper at the campout. That night when they went to bed John Brown touched between his legs and [REDACTED] told him to stop. John Brown did it again and took [REDACTED] hand and had him touch John Brown private area. After some rubbing, they stopped.

The next morning before they got up some more rubbing took place and John Brown put his arms around [REDACTED] and had [REDACTED] do the same to him.

Note: The best we could gather that's all that happened. The rest of the day [REDACTED] fished. The next time [REDACTED] saw John Brown was Saturday, May 30th.

When [REDACTED] John Brown and [REDACTED] went to visit another boy about joining the troop John asked [REDACTED] to go talk to the other boy and John and [REDACTED] sat in the car (or truck). [REDACTED] said that John touched him again.

After the troop meeting, Monday, June 1st, John Brown and [REDACTED] talked in his call about getting together again about oral sex and some other kind of sex that [REDACTED] had never heard of.

██████████ also said that at sometime John Brown had asked to go to Scout Camp, with him and that he could stay in Johns tent. John also told him that a Camp Scholarship might be available.

██████████ also told us that John had told him that he reminded John of another boy he had done this with that looked like him and had longer blond hair - that this boy had quit the Scout Troop.

I told ██████████ I would call her and update her on what would happen after we review all this.

Mike Proud offered the total support of his church to the family.

Mike Proud, John Rogerson and I met at the church and all agreed that they (the ██████████ and ██████████) were telling the truth.

We met with Pastor Dayton and reviewed the meeting with the family.

I reviewed the Boy Scouts actions and shared both letters with the Pastor.

John Rogerson called John Brown and asked him to come down to the church.

Pastor Dayton, John Rogerson, Mike Proud and I confronted John Brown.

John Rogerson, Troop Chairman, ran the meeting.

Mike Proud informed John Brown why the church as involved.

John Rogerson told John Brown that we had just met with ██████████ and ██████████ and that they made a very serious charge against John Brown.

Note: I can't recall whether ██████████ told John Brown what the charge was or not.

John Brown told us that ██████████ was correct.

After he talked to her Monday, he got physically sick and cryed himself to sleep.

Tuesday, June 2nd at work his Foreman sent him to the Doctor because he wasn't felling well and John Brown spent two hours talking to the Doctor. He told him what had happened. The Doctor told him he was going through Metapause and that his type of action could be caused by that relating to something that happened when John was younger. John Brown said that he thought ██████████ looked like James Dean and he idolized him as a youth.

John said that the negative response Monday night (talking to [REDACTED] about this) would trigger a reaction so he could never do something like this again.

John said the Doctor thinks he could be suicidal. John said he was on medication (from the visit Tuesday) to calm him down.

John Rogerson told him that he would have to resign.

John Brown said he hoped he wouldn't have to but he understands.

I showed him a copy of the letter from the Boy Scouts told him to read it and ask if he understood. He said he did - he asked if he could ever be involved in Scouting again, and was told NO.

I told him I would deliver his copy of the letter to his house Saturday morning.

John Rogerson gave him the name and phone number of the County Mental Health Agency and told him to call if he feels he needs help.

I told John Brown that John Rogerson and I would go back to [REDACTED] and let her know what his response is.

Note: [REDACTED] and [REDACTED] have not told [REDACTED] father yet. They think he may file Civil or Legal action against John Brown. He will not be in town until June 6th or later.
