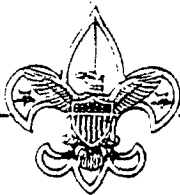

Following this limited encounter and your requests, I have ask for additional information from the following sources:


Valley Boys & Girls Center

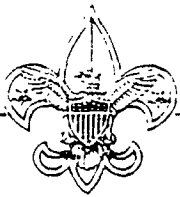

Dear Paul:

In reference to your letter of November 10, 1987 concerning John D. Mebane, I am sorry to inform you that I cannot complete the confidential record sheet you have requested.

At my request, the Lewiston Police Department did a records check and Detective Tom Greene told to me "Drop him(John D. Mebane) like a Hot Potato".

I have been informed that this person has two prior arrest and at least one conviction:

8/5/82 Prescott, Arizona
1/13/83 Phoenix, Arizona

During an interview with Mr. Mebane, he informed me that he had been a Boy Scout in Fresno, Calif. "Many years ago" and that prior to moving to Lewiston he had lived in Tuscon, Ariz. for one and one half years. He has never been a volunteer Scouter. He has been involved with the Big Brother's Program. He was referred to us by the Volunteer Bureau.

On 9/18/87 I talked to Richard R. Harrington, Western Region Director, requesting the assistance of the Regional office in tracking down the information necessary for a Confidential record sheet. I gave Dick the above dates and locations.

The man does reside in my Council, but has not made any further move to register with the B.S.A. although un-official and without any record, it is my belief that certain members of the Lewiston P.D. visited Mr. Mebane and instructed him to stay away from youth organizations in the Lewiston Clarkston Valley.

Sorry I cannot be of any further assistance. I wish these things were easier to handle. Mr. Mebane is not listed in the Lewiston Phone book, but I did verify his employment with St. Joseph's Regional Medical Center in Lewiston.
