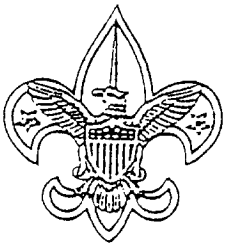

Thanks for your help in completing this case.

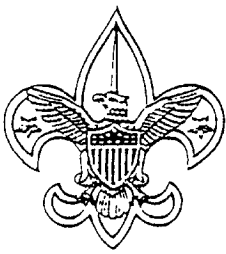

Re: John Finch

Attached is a copy of my letter to John Finch suspending his registration, etc. This was personally delivered to Finch by Capt. Steve Ford, Leon Valley District Commissioner and myself.

Finch says that the only thing he knows about the incident (copy of my notes attached), is that he was contacted by TDHR and was told by them what the charges were against him. He also stated that their investigation would take around 30 days.

After the letter was delivered, Capt. Ford and I visited some on the issue. He told me that the girl's father, who also happens to be a Scouter, told him about the incident in passing. His comments were, "The craziest thing happened the other night. My wife and I got a call from the emergency room at Darnell Army Hospital that they had our daughter there and suspected that she'd been molested." Capt. Ford and I wondered, "What is an eight year old girl doing out late at night?"

The investigation should clear all this up. I am convinced that something took place and also that John Finch reported himself because he indeed knew, through the Youth Protection Training, that someone would report the incident to me.

Will keep you informed of future developments.

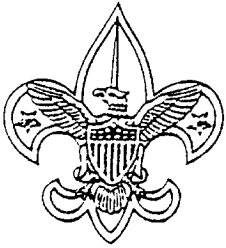

Dear Mr. Finch:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

Finch found out that he'd been accused when a rep. from Texas Dept. of Human Resources showed up at his home last evening and confronted him with the allegations.

He supposedly fondled the girl during a game - dodge ball, Volley ball & Finch says he just patted her on her rump - "Good shot" type deal.

Finch is registered in several positions in the Leon Valley District. [redacted] father, [redacted] is also a district unit volunteer.

Finch is well aware of our procedures regarding the reporting of child abuse. & along with District Commissioner Steve Ford will deliver the letter of suspension today at 1:30 p.m.
