Dear Mr. Tade:

In answer to your inquiry in the above-captioned matter, the defendant plead guilty on four separate Bills of Indictment, charging Sodomy and Corrupting the Morals of Minors and was sentenced by the Honorable Robert W. Honeyman, one of the Judges of our Courts, on March 17, 1967. The sentence imposed was four months to twenty-three months in the Montgomery County Prison on one Bill of Indictment. He was also sentenced to three years probation on the three remaining Bills of Indictment in order to give a long period of supervision and control over the defendant. Since his original arrest occurred on December 3, 1966, his minimum sentence will expire on April 3, 1967, at which time he will be eligible for parole.

I trust this will answer your inquiry.
