Troop Leader Admits Sex Abuse with Scout

By Martha Ellen

PIERREPONT — A former scoutmaster admitted in court here Tuesday night to having sexual contact. With a 13-year-old member of his troop.

John H. Brown, 54, Route I, Russell, pleaded guilty to second-degree sexual abuse, a misdemeanor, before Pierrepont Justice Michael A. Jackson.

Sentencing was adjourned pending an investigation by the St. Lawrence County Probation Department.

Brown, former scoutmaster for Troop 42, Russell, was arrested in what was the culmination of a three-month investigation at about 9 p.m. Tuesday by Sheriff's Investigator John W. Manning.

The case involved a 13-year-old boy who had been a

member of Troop 42 when Brown was the leader of the troop.

After his arraignment, Judge Jackson ordered Brown held on \$500 bail. Brown was jailed, but was released after an hour and a half when bail was furnished.


Investigator Manning said Brown is accused of having sexual contact with the boy more than once last fall in Brown's pickup truck in either the town of Pierrepont or Russell.

He declined to be more specific.

"E Brown, who has been involved in scouting for 25years, has been relieved of all his scouting duties and Troop 42 began reorganizing itself Monday night.
