Please let us know if we may be of further help to you.

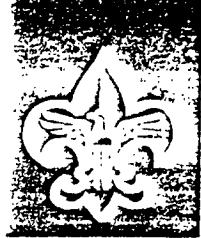


