SUBJECT: JOHN HILLER

On July 10 at 3:00 P.M., I talked to [REDACTED] from Gainesville, FL. She indicated that Mr. Hiller had sexually abused her son and his own step-son. Both boys were approximately 10 years old when the sexual abuse started occurring, and it lasted for approximately 2 years until [REDACTED] moved to Florida where she now lives in Gainesville.

The abuse apparently took place both at Cub Scout meetings and activities as well as other times, since the two families were neighbors. As far as [REDACTED]'s son knows they were the only two boys involved at that time.

[REDACTED] son who is now 24 years old has an emotional age of approximately a 14 year old and has been in therapy since last fall when this first came to surface. Over all the years it was known that her son had problems, but it was not known why these problems existed until October 1988 when he admitted to a therapist that there were some problems of sexual abuse in his childhood.

Apparently [REDACTED] showed pornography magazines and materials to the boys as well as sexually molesting them. According to the information, there was no oral sex.

I will pursue this further with the Scout Executive of the Fairfield County Council, so that we can establish a file to make certain that this does not occur in the future with any Scouts.

Dear Bob:

I appreciate the information you have sent concerning the above named individual. This has been most helpful to us and we feel that a Confidential File should be established, so that Mr. Hiller cannot become registered in the future with the Boy Scouts of America.

I did talk by phone with [REDACTED] and she indicated that sexual abuse went on for quite some time until they left the area and moved to Florida. Apparently the sexual abuse occurred at both Cub Scout meetings and other activities. This apparently was also possible at other times, since the two families were neighbors.

[REDACTED] indicated that her son now is at an emotional age of approximately fourteen and has been in therapy since last fall when this first came to light through communication with the therapist. For many years their son had problems, but no one knew why these problems existed until this time.

Please complete the enclosed Confidential Record Sheet with as much information as you have available, so that we can identify Mr. Hiller should he attempt registration at another time and location. We understand that he still lives in your council and is listed in the phone book for the area.

living at [REDACTED] in Bridgeport, Ct.

John Hiller, was registered with Troop 211 sponsored by a
group of citizens and met at its John Wintlings School in
Bridgeport in 1976 as the Scoutmaster.

in 1974-75, he worked with a Den in Cub Scouting with [REDACTED]
[REDACTED] who also had a son living with John Hiller. Pack 111

During this time from 1975-76, John Hiller abused both [REDACTED]
[REDACTED] and [REDACTED]. John Hiller dropped out of T211
after 1977 and has not been registered again.
