The 12-year-old reported that a second boy had also been molested the previous week but he had already returned home. John Cadwallader, Scout Executive and the Scoutmaster of the boys' troop are at the Jamboree and could not assist.

Steps taken.

Pete Barbernitz informed the registration service.

In the absence of Paul Ernst, Claire Miller (extension 2517) handled contacts.

John Hoenes, staff member, Northeast Illinois Council, arranged contact with the parents of boys.

Parents do not wish to pursue or press charges.

Action.


The Hunter youth had a previous offense with a nephew 2 years prior to this incident and has had psychiatric counseling. His parents have arranged for an immediate counceling appointment.

A full report is being prepared and will be sent to Registration Service so that he may be placed on the confidential file. Paul Ernst concurs that he should be.

Ken Miller will report to the Children's Service Bureau in Wisconsin to cover legal requirements per the advice of Dave Parks, National Attorney.
