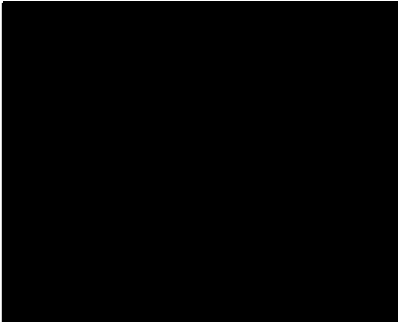

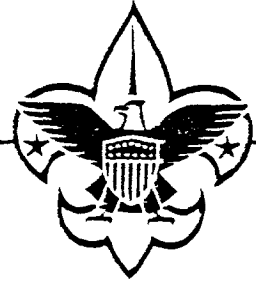



It is my understanding that Borelli will be sentenced the end of April. We will keep you posted.

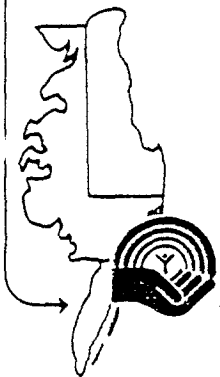

We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

Couple held on child porno charges

FRUHLAND — A Fruhlund couple accused of running a child pornography ring was being held in the Wicomico County Detention Center Tuesday night on \$100,000 bail each, according to Maj. Kirk Daugherty, the Wicomico County Sheriff's Department.

Charles Keith Borelli, 37, and his wife, Linda Borelli, 26, both of the Bohunk Trailer Park, were arrested after their trailer was searched Tuesday around 5 p.m., Daugherty said.

Members of the sheriff's department, the Salisbury Police Department and the Wicomico County State's Attorney's office got arrest warrants and a search and seizure warrant, after getting a tip from the U.S. Postal Service, he said.

The postal service was alerted to the possibility the Borellis were involved in the production of child pornography after California authorities raided a San Diego house and charged James E. Hines with several child pornography violations, according to John Sternberg, of the postal service.

"We found some correspondence from the Borellis at his (Hines's) house," Sternberg said. However, he would not say what sort of correspondence was found in the home, nor would he confirm it was child pornography.

"I don't want to get into specifics because we're still in the preprosecution stage, but it is common in these types of cases for people to exchange child pornography with other people," Wicomico County State's Attorney Davis Ruark said. "We don't know if there was an exchange for profit."

The Borellis were each charged with 14 offenses, including child pornography, filming children in a sex act, perverted sexual practice, second- and third-degree sex offense with an underage victim, and child abuse of a child under 18, Daugherty said. John Borelli was additionally charged with second-degree rape of an underage victim, sodomy and incest with a minor, he said.

During the raid investigators confiscated literally thousands of photographs and at least 14 videotapes.

"Now we're not sure that all of this is child pornography," Daugherty said. "We still have to view all of the videotapes and look at all of the pictures."

A number of small children were involved in some of the confiscated material and some of those children have been turned over to protective services in Salisbury, Ruark said.

However, since he did not want to traumatize the children any further he would only say they were close to the Borellis.

The investigation is continuing, Ruark said.

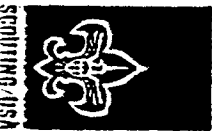
