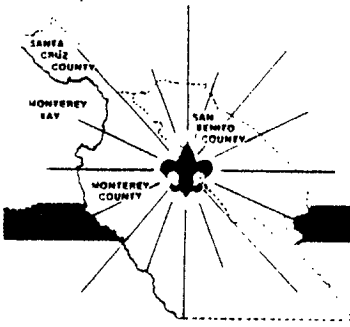

Dear Paul:

As per our conversation, enclosed is copy of a letter that my assistant and the district executive hand delivered to John L. Kelleher on January 19, 1990.

What initiated the letter being written and delivered was first a call from Scott Waterman who is an investigative officer with the Air Force. Scott stated to me that he was investigating John Kelleher for child molestation that occurred two or three years earlier at a military facility outside our council territory. I believe he said it happened at Castle Air Force Base or in Europe, I don't recall which.

He stated that there was a preponderance of evidence that would conclude that Kelleher should not be associated with Scouts or with young boys.

Having received that information, I contacted my Area Director Steve Perry and then initiated the letter signed by our Council Commissioner which was delivered to Kelleher on the same day.

Kelleher is about 5' 10" tall, about 35 years old, has brown hair, heavy built and wears glasses. He was formerly registered in our Troop 178. While registered in the troop his major activities were with the Order of the Arrow.

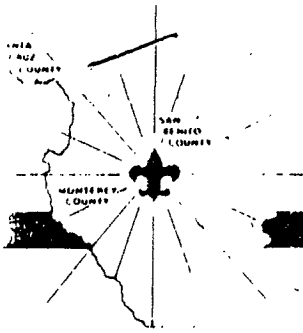
