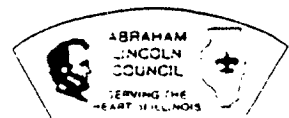

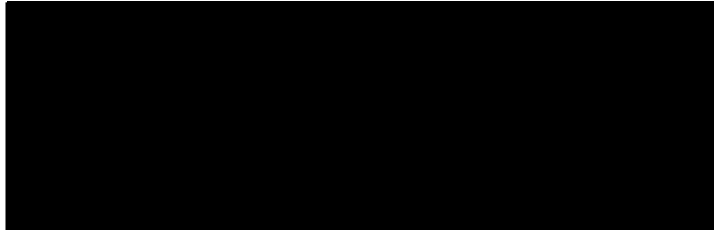

- 6. Respondent is ordered to return the minor child/children _____ to petitioner not to remove the minor child/children from the [redacted]

Inquiry Summary

Monday, December 7, 1987

- Received the attached letter concerning John Sanford, leader in Cub Scout Pack 354, chartered by Owen Marsh School PTA.
- Contacted Mr. Ed Cotton of Department of Children and Family Services, State of Illinois. No history of a John Sanford, white male, born January, 1938 in central computer file. Files and records are kept for the past five years.
- Mr. Cotton recommended we contact local police about additional information.

Tuesday, December 8, 1987

- Contacted local police - no public disclosure files available.
- Referred by the Springfield police to circuit clerk's office.
- Circuit clerk had no public disclosure files and we were referred to the Sangamon County State's Attorney office.
- Spoke with Cheryl Essenberg, attorney in State's Attorney office. No record existed of a John Sanford. Records were only for Sangamon County of Illinois.
