Please confirm that this is or is not the same individual, so that we know the direction to go on these other registrations.

Dear Mr. Isiace,

I have come here to face with a problem that can not be ignored because the safety of all the scouts in pack 60 are at stake. On Saturday March 11, 1989 my son [REDACTED] who is a boy scout went with Mr. Marshall our scout master to do some work for him. Mr. Marshall took my son to Tuskegee, Ala. to help work, my son said - the only work he did was pick up a few pieces of paper off the floor in a hotel room where he and Mr. Marshall were. He was asked to lay on the bed to watch the ball game with Mr. Marshall. He did so and Mr. Marshall began to put his under [REDACTED] shirt and began kicking on him. [REDACTED] told Mr. Marshall he didn't like that. So when they left coming back home Mr. Marshall showed [REDACTED] a sheet of paper with a cartoon on it that said if you're tired of your parents fussing come run away with me. He asked [REDACTED] if there was anything he wanted and [REDACTED] said he wanted

A Nintendo game which costs at least \$100.00 so they went to Walmart to get the Nintendo but Walmart were sold out, so Mr. Marshall bought [redacted] a \$40.00 remote control car and game then a \$20.00 bill, when [redacted] got home he told me what happened and said the night before when Mr Marshall, [redacted] & I went to Churches Church to get chicken in the Blue & Gold Banquet Mr. God given \$2.00 to put in his pocket and was playing large sums of money and tried to hold hands with [redacted] He said, Mr Marshall was funny (Gay), when [redacted] told me this then [redacted] came to me and told me what had happened to him the Saturday before which was March 5, 1989. After the pack meeting Mr Marshall took the boy scouts & Cub Scouts to Diamond Jim's in the money trail on a field trip I did not go along with them. When Mr Marshall brought [redacted] home I was in the house, he did not come in, but sent [redacted] in to ask me if [redacted] could go with him to his job to take something, at the beginning of the school year Mr Marshall told me he worked for Burger King on Madison and sometimes filled in

At the Burger King on Atlanta Highway.
 I agreed to [redacted] going with Mr.
 Marshall this was 5 p.m. in the
 evening, well 7 p.m. has come
 and I know it should take that long
 but I waited until maybe 8:30 then
 I called both Burger Kings to
 check with Mr. Marshall to see what
 was keeping them. I was told Mr.
 Marshall did not work at either
 of the stores. I got worried and called
 Mr. Marshall's wife to find where
 he worked and she said in Tucker
 I don't remember where she told me,
 but he did not bring [redacted] home
 until 9:30 p.m. that night, Mr. Marshall
 gave no explanation for his behavior
 and all [redacted] said was Mr. Marshall
 gave him \$5.00 for taking a jar of
 jelly into a lady. well after [redacted]
 told what happened to him then
 [redacted] said when coming back
 from Tucker Mr. Marshall
 put his hand in his pants and touched
 his penis. My boys both know the
 seriousness of an accusation like
 this and I don't believe they are
 lying. I have thought about
 this since the last several weeks
 and I have watched Mr. Marshall
 and I am convinced my boys
 are telling the truth. [redacted]
 has been working with me since

I confided in her and she noticed
 as I have the strange behavior
 that Mr Marshall some time display
 while with the boys. such as eyeing
 or pinning clothes. he has been called
 a faggot by one of the boys. Also
 there is another boy in our
 group who has been to Tuskegee
 with Mr Marshall. please look
 in to this matter because I'm
 very very concerned for
 all of the boys in our unit.
