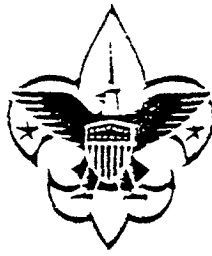

Dear Paul:

Please find attached the documentation of the incident involving John Nykamp as stated by Stan Klevan, then Scoutmaster of Troop 168, Stockton. Mr. Klevan is a police reporter for the Stockton newspaper and as such has provided a rather thorough accounting of the incident. Also find attached the required form for removal from membership.

Since this incident occurred in 1986 before the current procedures were established we thought it would be appropriate to forward this information to you. We also were able to secure recently the disposition of this case from the Nevada County, California, District Attorney's office.

When I first received word of the incident I instructed the camp director to notify the authorities - which he did. In addition, John Nykamp was suspended immediately. After consulting with the Associate Regional Director, Richard Parker, we then proceeded to talk to the parents and inform them that John had been immediately suspended and that the BSA would not tolerate this type of conduct. We have just recently acquired the information regarding the disposition of the case: John Nykamp was sentenced to 2 years of Supervised Probation by Nevada County. Case #M87550 and probation #A870158. The parents of the victims in this matter seemed relieved and satisfied with our actions. We have not heard from them since my original contact.

Paul, I hope this is all you will need to process this - please let me know if I can be of any further assistance.

(Aug 7, 1977) Mixed party of campers (17 adults) and scouts
[redacted] out for Lake Skauldins and an overnight
campout. The party consisted of 22 Boy Scouts from Stockton
Troop 168, plus their asst. Scoutmaster, David Ladesso; a camp-
staffer named [redacted] (last name available from Camp director
Dick Hacke); and John Nicamp (a 17-18-year-old staffer from
Camp Tamarancho currently staying with his own troop at Camp
Marin Sierra).

[redacted] was enlisted by some of the boys in the troop because
he had gone with them on the camp trip last year. Ladesso
brought [redacted] to my attention about Monday or Tuesday of that
week because I was concerned about water safety procedures
while the group was on the campout. [redacted] had said he was a
qualified Scout Lifeguard and was bored in camp and would enjoy
the opportunity to have something to do. Meanwhile, he had
offered his services to the Camp Marin Sierra aquatics director
and was working as one of the guards on the swimming dock.
I still insisted on one more adult leader to at least supervise
the Lake Skauldins campout and Camp Program Director Dave
Arnett assigned an adult named Ned to that job. By arrangement
with [redacted], he was to guide the whole group down the trail to
Skauldins, supervise a controlled swim and then depart back to
camp, coming back the next morning to Skauldins to be certain
the group returned early to the main camp and without delay.
On the day of the trip, one of my scouts, [redacted]
was injured at about noon and Ned had to transport him to Grass
Valley's hospital for stitches on his chin. Ned advising me
that he would not be back in time to take charge of the trip
and that the two young men with [redacted] could handle the trail
and supervise the swim.
My scouts and their helpers walked out of camp at about 2:45
p.m. Thursday, Aug. 7.

The following info was furnished me by two of my boys whom I
list as Victim 1 and 2 (Victim 1 is [redacted] and V-2 is
[redacted]). All of this I learned from the two boys upon
their return Friday morning about 9:45 a.m. (Aug. 8). Each boy
freely spoke to me about what had happened. It went as follows:

[redacted] said that it was just before the swim that [redacted]
pointed to his own sleeping bag, placed a short distance away
from the rest of the group, and asked [redacted] to put his bag
next to it and keep him company for the night. [redacted]
refused, saying he already was bunking next to a friend.
A short time later, [redacted] was seated on a large rock and had
encouraged [redacted] to sit next to him. [redacted] said Nicamp
began tickling him (the boy showing me that the location was on
both sides of his body above the hips - well above the
beltline). Then Nicamp told him there was another place he was
ticklish and pointed to [redacted] groin and offered to tickle
him there. With that [redacted] quickly left (he explained to me
that he and his sister had been through a sex abuse incident
some time ago at the hands of a baby sitter and was well
familiar with courts and procedures in that regard). [redacted]
said he then stayed away from Nicamp. On two later occasions, I
chatted easily with [redacted] about the incident and learned
that Nicamp never placed his hands on the boy's private areas,
but was trying to convince the boy to let him do so.

It was a short time later that Nicamp induced [redacted] to sit with him on the same rock. [redacted] said Nicamp asked him if he had ever "Jacked off" and that he, [redacted] replied that he didn't know what he meant. Nicamp told him of the fun and the great feeling and urged the boy to join him and they would masturbate together. [redacted] said no and started away, but Nicamp grabbed his arm to hold him there. The [redacted] boy yelled and yanked loose and fled the rock. His yelling attracted others and (Lagesse said later it was the first he knew that something was wrong) they all came up to the rock. [redacted] described Nicamp and sitting on the rock, hunched over and holding his upper torso and head between his two forearms. When he was told to get out of there, he stood up and his privates were plainly visible hanging outside his open pants-fly.

The angered boys went after him. Particularly upset [redacted] describing him as losing his mind) was Heselton's younger brother Danny. Nicamp is about a six footer and has a stocky build, but he fled when that many people came after him.

[redacted] told me the boys attacked [redacted] equipment, but he insisted they leave it alone and he bunched it all together and placed it further away from the campsite. Sometime later Nicamp came out of a hiding place, took his gear and fled the general area, apparently returning to camp. Later, on at least three occasions, I chatted with [redacted] about the incident, but there was no variation in the description. Again, here too, there was no talk of direct touching of the boy's private areas by Nicamp. Again, I finally asked a direct question about touching his private parts and was told "No" by each boy.

This is the extent of what I could learn from talks with the two boys and Lagesse. It should be noted that [redacted] is small in size and is about age 11. [redacted] is about 12 or 13, but very small and wiry for his age..... [redacted] scoutmaster.

1. The named staff member will serve as Den Counselor for the camp season and other duties as determined by the Camp Director.
2. The Camp Director reserves the right to cancel this agreement in full or part:
 - a. In the event of unsatisfactory service.
 - b. For personal conduct not in accord with the standards of the camp or of the B. S. A.
 - c. In the event registered attendance at camp makes it necessary to discontinue the services of all/or part of the camp staff.
3. The staff member agrees to the provisions of the camp policies which are established in accordance with the principles and policies of The Boy Scouts of America. This includes the need to be properly uniformed and to abstain from using alcohol or drugs.
4. The staff member will provide for the Camp Director upon/or before arrival at camp: A certificate of good health (B.S.A. Health & Medical) and a medical treatment release and rifle range permit.
5. If the staff member is under 18 years of age, the approval of parents or guardian is required on this agreement.
6. All volunteer camp staff members will be covered by health and accident insurance - the premium will be paid by Marin Council. (Volunteers are not covered by Workman's Compensation - AB 58, State of California).
7. The Camp Director or an appointee will notify the parents of a staff member in the event of sickness, injury, or discontinuance of service.
