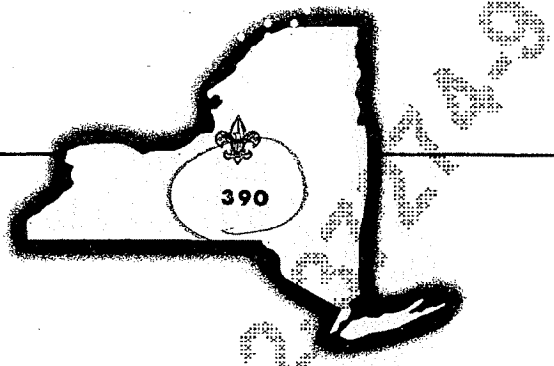

Dear Mr. Pannell,

Briefly, I would call to your attention several instances recited to me by my son [redacted] relating to conduct of his scoutmaster of Troop 21.

\*  
On a fall overnite camping trip he and another scout were confined to a small shack and requested to take their pants off by the scoutmaster...after waiting for "punishment" the boys were told that would be all, and to put their pants on again.

A few weekends ago on a camping trip the boys constructed a monkey bridge across a small creek. My son was asked to disrobe and cross the stream after the bridge was taken down. In his mind he questioned the scoutmaster's order, because he could have waded across a short way upstream.

On this same camping trip my son reported that another scout \*\* was taken out in the woods by the scoutmaster and "taught the facts of sex".

to my son  
Another scout \*\*\* related in detail the sexual advances made to him by the scoutmaster at or near the home where the scoutmaster boarded in Warners N.Y. The occasion was on a Saturday last fall when instead of helping him \*\* with mapping in the cemetery a few blocks from the scout's Syracuse home, he drove him out to Warner's.

The scoutmaster has repeatedly invited my son to come out to his house and get help with his merit badges. The most recent was this past Saturday morning. It was such suspicions born of these invitations that we as parents have harbored for some months. After the Christmas holidays I called the Rector of the church sponsoring the troop about my and another neighbor's suspicions, I asked for a report back, but never received one.

Dear Mr. Pannell,

Mr. [REDACTED] and I feel that Boy Scout Troop #21 should be disbanded at this time. The support of the parents and the church has been minimal. Most of the burden has fallen on one adult and Mr. Jack Murrell, whose services were enlisted through your office.

Last winter, Mr. [REDACTED] and I had serious doubt as to the moral character of Mr. Murrell. We spoke to some of the interested members of the church and committee, who assured us that we were in error. Some of the other parents shared our feelings. We felt that if a shadow of a doubt existed, and, as the troop was not getting much active support from the parents or the church, that it should be dissolved. This was not done in an effort to give it "one more try." Our son was made Senior Patrol Leader. He took the job very seriously, and to push for dissolution met with violent resistance at home.

Events drifted along until recently.

Our son has told us that he has not been involved in anything improper with Mr. Murrell, but that he has heard that others have been involved. To quote, "Jack is a good guy, I did not see anything." "I have heard that he has done things he should not have done."

This is about as close to a condemnation as one can get from a 13 year old, when he thinks the principal is a "good guy."

There is no question that the troop should be dissolved in view of the lack of interest on the part of the parents and the sponsoring agent, namely the church. I am sure your office will see that Mr. Murrell is excluded from any future activities with scouting if the child's inferences are substantiated.

If I can be of further assistance, please let me know.

On a scout overnight hike of Troop 21 on the weekend of April 21 to 23, reported by my son [REDACTED] the Scoutmaster John Mural isolated him from the others in the group and initiated and engaged in improper sexual activity with him.

According to reports by my son [REDACTED] Mural also engaged in highly questionable practices with other boys on the hike, notably requiring them to take down their pants for spankings administered privately.
