Military duties: He has served in military police and as medical tech in Hawaii, and in emergency room medical tech at Laughlin AFB, Del Rio, Texas.

He is currently receiving treatment at USAF hospital-Wilford Hall in San Antonio, Texas.

There have been no charges filed at present date. The USAF office of Special Investigation at Laughlin Air Force Base, Del Rio is conducting an investigation at this time.

The parents of the youth involved have stated they want the military to conduct the investigation and the Court Martial.

The youth involved is a Scout and his parents are in the military (USAF), the Scout Troop is chartered to 47th ABG Laughlin AFB, Del Rio, Texas.

The local District Attorney is Mr. Thomas Lee, past district Chairman of Amistad District and is currently Vice President of the Con. Valley Council. Mr. Lee is knowledgeable in all the specifics in this case and will follow-up on this case.

Your Views

'Pornography has claimed a young victim here'

Editor:

I have had some very positive response to the "Forum" column on pornography published Tuesday, Aug. 19, in the *Del Rio News-Herald*. I am gratified to see there are people in Del Rio who are concerned, active citizens. Not everyone is afraid to get involved!

As a result of that article, information has been passed on to me regarding an incident which occurred several months ago here in Del Rio. It quite graphically illustrates the point I was making in the "Forum" article.

An item appeared in the *News-Herald* a few months ago about a Laughlin Air Force Base staff sergeant being court martialed for "indecent acts with another."

It is a fact that this man was a Boy Scout leader and the "indecent acts" were done to a member of his troop.

It seems that the man had been behaving "funny" and had even shown pornography to the boys over a period of about a year before the actual molesting took place.

Some of the boys reported this, but their story was poo-pooed by adult scouters, who refused even to investigate. Objecting parents and other concerned individuals were dismissed as troublemakers.

Even after the court martial and the man's sentence to prison, one adult scouter reportedly said, "What he did was no big deal."

Something is gravely wrong here! Adult leaders who blinded themselves to the truth, then refused to admit there was a serious problem even after the truth was brought to light. And, the parents who dropped the matter and quietly took their kids out of the scout program. Only one "troublemaker" continued to wage a letter campaign to local leaders, and finally, after months of seeing nothing done, dared to face this man in confrontation, leading him to turn himself in to authorities and make full confession.

And the *News-Herald* covered part of the story. What happened to investigative reporting?

At any rate, pornography and all it leads to have claimed a victim right here. He is just a young kid and seeing a therapist in San Antonio. I wonder if his parents think what has happened to him is no big deal?

Once again, I urge the readers to write to President Reagan and Attorney General Meese. Ask them to implement the recommendations of the Commission on Pornography.

And, while we are at it, write Boy Scout headquarters to ask for a full investigation of what has happened here.

EDITOR'S NOTE: The *News-Herald* printed an article on the court martial from information relayed to the newspaper by Laughlin officials. The incident was considered a military matter. The officer was court martialed based on an investigation conducted by military officials. John Stein, with the public affairs office at the base, submitted the following press release that was issued Aug. 29, 1985 to the media:

On the evening of Oct. 9, 1985, Staff Sgt. John P. Young Jr., arrived at the Laughlin Hospital emergency room for treatment. He was despondent and threatening to commit suicide over his conduct with a member of the Boy Scout troop of which he was a leader. On the morning of Oct. 10, base authorities launched an investigation into Sgt. Young's conduct. Sgt. Young was tried by general court martial on March 11, 1986, convicted of indecent acts, and sentenced to be dishonorably discharged, to be confined for two years, to forfeit \$300 per pay per month for two years, and to be reduced to the lowest enlisted grade.

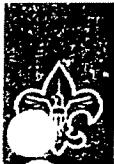



Base airman convicted

A Laughlin Air Force Base airman has been convicted of "indecent acts with another" by a military court-martial, according to base officials.

John P. Young Jr., former staff sergeant, was convicted following a court martial Tuesday at the base.

He was convicted under Article 134 of the Uniform Code of Military Justice, and was sentenced to a dishonorable discharge, two years confinement, reduction to the lowest grade (E-1 pay grade), and \$300 per month forfeiture of pay for two years, said Laughlin Public Affairs official Capt. Claude Morse.

Young was assigned to the U.S. Air Force Hospital at Laughlin.

He served as a Val Verde County Reserve Deputy Sheriff.

Val Verde County Sheriff J.R. Koog today described his former reserve deputy as a man with a "good brain, good worker and outstanding reputation."

Koog learned of possible misconduct of Young from an acquaintance in early October, the sheriff said. "We ran an investigation on it, but it was dropped in favor of Laughlin handling it."

At that time, the military Office of Special Investigation was already working on the case, Koog noted. Young was suspended from duty then, and was later dismissed from the reserve force.

1. Tom Lee, the District Attorney for the 63rd Judicial District of Texas, requested that I write to you concerning the outcome of the trial in the above captioned case. SSgt Young was a Boy Scout leader in the troop sponsored by Laughlin Air Force Base.

2. On 11 March 1986, before a general court-martial, SSgt Young entered pleas of guilty to, and was convicted of, committing indecent acts upon the body of a military dependent who was in the local Boy Scout troop. He was sentenced to a Dishonorable Discharge, two years confinement, forfeiture of \$300 pay per month for two years, and reduction to the lowest enlisted grade (E-1). I must caution you that despite his pleas, the conviction is not final, nor has it been approved by the general court-martial convening authority.

The enclosed data is regarding Staff/Sgt John Philip Young, Jr. registered as Scoutmaster in Troop 280 chartered to the 47th ABG Laughlin AFB, Del Rio, Texas.

The District Commissioner has been very suspicious of this man for several months but could not develop any specific proof of misconduct, until last week in a telephone conversation between S/Sgt Young and the District Commissioner, the District Commissioner stated that some of the boys in Troop 280 hev been talking about S/Sgt Young and his "wierd" behavior.

After their telephone conversation S/Sgt Young telephoned the District Executive, Daniel Stim and asked him to come visit him at approximately 11:00 P M on Wednesday night October 9, 1985. Mr. Stim went to his trailer home and during their conversation S/Sgt Young related his sexual relations with a specific youth recently.

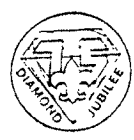
He then became very upset and made statements regarding his intent to commit suicide.

The District Executive, Dan Stim, promptly persuaded S/Sgt Young to go with him to the Laughlin AFB, clinic, where the S/Sgt was examined by a physician and treatment was started.

Dan Stim reported the incident to the military authorities and left S/Sgt Young in the clinic.

Tom Lee, Vice-President of our Council, is also the District Attorney in Del Rio located near the Laughlin AFB. Mr. Lee has continued to monitor this

event and has reported that the parents want the office of Special Investigation to conduct the investigation and proceed with the Court Martial.


To date there has not been any civil charges, but Mr. Lee has advised me to initiate the proceedings to remove S/Sgt Young from all Scouting functions and relationships with the BSA based on his knowledge of the events related.

I feel confident that Mr. Lee will monitor and follow-up on this case in the event the air force will not.

Therefore, I recommend S/Sgt Young be placed in the confidential file.
