2 sentenced in rapes

News-Messenger reports

A 58-year-old Clyde man who pleaded guilty to raping three boys was sentenced Tuesday to up to 100 years in prison.

In an unrelated case, a former Fremont resident brought back here to stand trial was sentenced to life in prison on rape charges.

John R. Van Allen, 151 Washington St., was sentenced by Sandusky County Common Pleas Judge Harry Sargeant Jr. to 7 to 25 years on four counts of raping three boys under the age of 13. The rapes reportedly occurred in 1981 and 1982.

Van Allen was one of the eight men indicted earlier this year on sex-related offenses. He was the fourth man to be arrested as the result of an investigation by the Fremont and Clyde police departments, the Sandusky County Sheriff's Department and the county children's services department.

Van Allen was indicted by a Sandusky County grand jury on seven counts of rape but pleaded guilty last week to four of those counts.

For the past 2½ years, Van Allen had been employed by the city of Clyde as a custodian.

He will be sent to the Medical Reception Center in Chillicothe and then sent to prison.

A former Fremont resident found guilty of two counts of rape was sentenced Tuesday in Sandusky County Common Pleas Court to life in prison.

Mark A. Hall, formerly of 1623 Fangboner Road, was accused of having sex with a girl under age 10. He was living in Arizona when he was indicted by a Sandusky County grand jury last November.

Judge Harry Sargeant Jr. sentenced Hall to 10 to 25 years in prison on the first count of rape

and to life in prison on the second count.

Hall reportedly maintained his innocence at the sentencing.

A jury found Hall guilty of the two counts of rape two weeks ago. The verdict came after more than six hours of deliberation.

2 arrests, 2 more due in sex probe

Police have arrested two more men in connection with sex-related crimes in the Fremont and Clyde areas.

At least two more arrests are imminent in the on-going investigation that now involves at least eight area men. Police say more charges could follow the next meeting of the county grand jury.

Richard Ratliff, 21, 905 Hayes Ave., Fremont, and William B. Engle, 108½ E. Forest St., Clyde, are being held in the Sandusky County Jail.

Ratliff was indicted Wednesday by a county grand jury on one count of corrupting a minor with drugs and Engle was indicted on two counts of gross sexual imposition of boys under 13 years of age.

The grand jury Wednesday indicted the eight men, but two of the indictments remained secret until they are served. Indictments are formal charges and do not imply guilt or innocence.

Cameron Salem Jr., 29, 1438 Alger St., who had earlier been released on bond, is now being held in the county jail on four counts of corrupting a minor with drugs. Salem's bond was revoked after being served with the grand jury indictment.

Although eight have been charged in the sex crime investigation, they are not all directly involved in the same case, said Clyde Sgt. Bruce Gower.

Gower said only three men were involved in the initial investigation, but the list grew as victims were questioned.

Salem, Bryan Zyski, 27, 1438 Alger St., Fremont, and one unnamed man were originally charged. His name will not be released until he has been served with an indictment.

The case then grew to include Ratliff and Robert Lehman, 31, 1109 Bridgewater Lane, Shorewood Village.

Zyski was charged with sexual battery and Lehman was indicted on one count of pandering obscenity involving a minor and two counts of rape.

As the investigation continued, Engle and John Van Allen, 57, 151 Washington St., Clyde, were added to the list. Van Allen was charged with two counts of rape.

Gower said Van Allen, Engle and the unnamed man were not directly connected to the first

came up during questioning with some of the victims.

Gower said more men could be involved with the sex crimes investigation, but probably will not be known until a grand jury meets in March.

"Yes, there could still be more. We're still looking at a few possibilities," he said. "We've been in contact with several police departments."

One of those police departments is in Nebraska. Gower said the Nebraska department assisted him in locating one victim who had moved out of town.

Ultimately, the sex-crime investigation could involve more than 100 minors and an unspecified amount of suspects, he said. "We'll never know them all. It's hard to get them all; everyone you talk to puts you on the trail."

The state statute of limitations also prohibits police from prosecuting crimes from more than six years ago. Police believe the crimes could date back as far as eight years ago.

In addition, Gower said, the counts against the men involved don't "accurately reflect the charges which could have been filed."

Gower said county Prosecutor John Meyers took the more serious charges instead of listing every violation. If convicted, he said, sentencing on the more serious charges will be the same whether the lesser charges were included in the indictments.

Sex crimes case widens

Investigation may involve 100 children; 4th man arrested

A 57-year-old Clyde man is the latest of four local men arrested on charges of sex-related offenses in the Fremont and Clyde areas.

Clyde police Wednesday arrested John R. Van Allen, 151 Washington Ave., Clyde, and charged him with two counts of aggravated rape. He is accused of having sexual contact with boys under 13 years old.

Van Allen is being held in the Sandusky County jail awaiting arraignment in Clyde County Court I later today. Judge John Dewey will set bond.

The charges are both felony I offenses and carry a maximum of 25 years in prison and a \$10,000 fine each.

Van Allen is the fourth man to

be arrested as the result of a continuing investigation by the Fremont and Clyde Police Departments, the Sandusky County Sheriff's Department and the children's services.

Three other men were arrested and charged Feb. 12.

Robert Lehman, 31, 1109 Bridgewater Lane, Shorewood Village, remains in the Sandusky County jail in lieu of \$75,000. He is charged with child pornography.

Bryan Zyski, 27, 1438 Alger St., is free after posting 10 percent of a \$1,000 bond and face charges of sexual battery. He is scheduled for a preliminary hearing in Fremont Municipal Court on Feb. 26.

Cameron Salen Jr., 29, 1438 Alger St., is also free after post-

ing 10 percent of a \$75,000 bond and faces charges of corrupting a minor with drugs.

Salen and Lehman are scheduled for a pre-trial hearing today in Clyde County Court I.

The investigation began in January after a Clyde juvenile, who was arrested for possession of drugs, told police a Fremont man supplied him with the drugs. Police searched the man's home and found the pornographic photographs.

The pornographic photographs depict nude boys, and adults in homosexual acts, and some of the pictures date back to 1976, said Clyde police detective Dennis Hall.

The investigation may involve

as many as 100 children between the ages of 11 and 17, many of whom are now adults, police added.

Police are asking any victims or past victims to come forward. Detective Hall said they have interviewed some of the victims, and the more victims they talk to the more names they are getting.

Sex crimes investigation traumatic for victims, but youths cooperating

The young victims of the continuing sex crimes investigation in the Clyde and Fremont area first deny involvement, then show relief after they have confessed, according to officials interviewing them.

"It is a terribly traumatic occurrence for the youths," said Dawn Yeager, supervisor of children's services at the Sandusky

County Department of Human Services.

The children's services staffers are assisting area police agencies with the interviewing and referring the victims to professional counseling therapy, Yeager said.

Some of the victims interviewed by authorities also are being referred for medical examinations to determine if any internal injuries were sustained

as a result of any sexual activity, she said.

Sandusky County Prosecutor John Meyers said the reluctance on the part of the youthful victims to answer questions is understandable.

"Some of the children had developed emotional relationships with the adults," Meyers said.

Both Meyers and Yeager said

it is being stressed to the children that what happened was not their fault and they are innocent.

So far, three Fremont men have been arrested as a direct result of the investigation, and Meyers said the circle is growing bigger.

Myers also said that as a result of the media attention given to the investigation, a few other cases of youths being sexually victimized by adults have been reported.

The reports apparently have generated some talks among families and children have confessed to being victimized, Meyers said. These new reports have no connection to the current police investigation, and will be followed up separately, he added.

Robert Lehman, 31, Bridgewater Lane, Shorewood Village, remains in the Sandusky County jail after a pre-trial hearing in the Sandusky County Court I in Clyde on Thursday where the case against him was continued. No new court date has been set. He was charged with child pornography.

Bryan Zyski, 27, and Cameron Salem Jr., 29, both of 1438 Alger St., were both charged on Feb. 12 along with Lehman in connection with the investigation.

Salem is free on bond, and at a pre-trial hearing Thursday the charges of two counts of corrupting a minor with drugs were bound over to the grand jury.

Zyski is also free on bond and is scheduled for a preliminary hearing on Feb. 26.

Also in jail is John Van Allen, 57, 151 Washington St., Clyde. He was arrested Wednesday and is being held in lieu of a \$200,000 bond on two counts of aggravated rape. He was arraigned in Sandusky County Court I in Clyde on Thursday.

There is no direct link between Allen's case and that of the others, according to police, although publicity about the investigation may have led to his arrest.

Van Allen is charged with having sexual contact with boys under the age of 13. At the time of his arrest Van Allen was on sick leave from his job as custodian at the Clyde Municipal building, said Clyde Det. Dennis Hall.

Previously he had been a custodian at Clyde Junior High school from 1966 to 1983, said schools Superintendent Stan Mounts. Van Allen at one time also was a Boy Scout leader, Hall said.

The sex crimes investigation is a joint effort of the Fremont and Clyde Police departments and the Sandusky County Sheriff's Department, and has been ongoing since January when police searched a Fremont man's home and discovered pornographic photographs depicting adults in homosexual activities and nude boys.

According to police reports, the boys in the pictures were all between the ages of 11 and 17, and many are adults now. Some pictures date back to 1976, police said.

Police say the investigation could involve up to 100 children.

More arrests are expected, but may not take place until after the grand jury meets on Feb. 25.

2 sex probe indictments still sealed

Two men remain in Sandusky County Jail in connection with an area sex crimes investigation. Two other men arrested with sex-related crimes posted bond Friday while a third remains in jail on an unrelated charge.

Six of eight men indicted by a county grand jury have been served with indictments. The remaining two will remain sealed until the men have been served.

The arrests are part of an ongoing investigation in the Fremont and Clyde area involving sex-related crimes and the cor-

ruption of minors with drugs.

The two men still in jail are: Cameron Salem Jr., 29, 1438 Alger St., Fremont, who was indicted on four counts of corrupting a minor with drugs.

John Van Allen, 57, 151 Washington St., Clyde, who was indicted on seven counts of rape.

Richard Ratliff, 21, 905 Hayes Ave., Fremont, who was indicted on one count of corrupting a minor with drugs. is in jail serving work release time for driving while intoxicated. He earlier posted \$2,500 cash bond for the sex-related charge.

William B. Engle, 108 1/2 E. Forest St., Clyde, who was indicted on two counts of gross sexual imposition of boys under 13 years old, and Robert Lehman, 31, 1109 Bridgewater Lane, Shorewood Village, who was indicted on one count of pandering obscenity involving a minor and on two counts of rape, posted bond Friday. Both were released after paying 10 percent of \$10,000 bonds.
