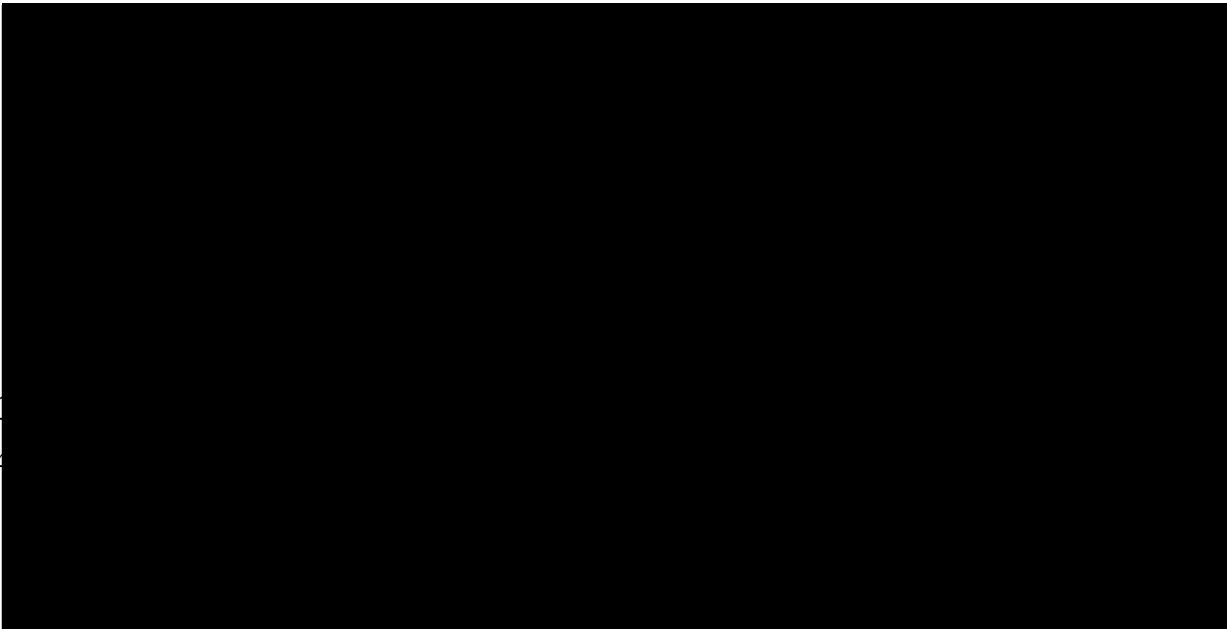

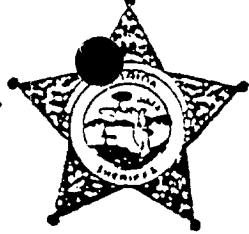

William M. McCuller:

The Putnam County Sheriff's Department is currently investigating several sexual abuse cases in which the alleged abuser is an adult male named John Thomas Chamblee, and the victims are pre-teen boys. Mr. Chamblee is currently incarcerated, after being charged and convicted of a similar form of sexual misconduct. It has come to our attention that Mr. Chamblee was once affiliated with the Boy Scouts of America, Pack 109, in Melrose. As the investigating agency, it is felt that our investigation would not be complete without interviewing all possible victims.

In view of the above, it is requested that you provide our agency with the dates that Mr. Chamblee was affiliated with Scouting, his position at the time, a roster of Scouts that he would have been in contact with, to include names, addresses, telephone numbers, and any other information which might aid our investigation.
