at the training session, my eleven year old son was assisting his mother in "Den Chief. Den Mother Relationship." This session was at 3:30 P.M. Before this session Mr. Beakes persuaded my son to go to the bath room with him. Mr. Beakes showed his privates to [REDACTED] our son, and unzipped his pants and played with him. He made [REDACTED] promise not to tell on the Scout Oath.

After the session was over around 5:30, Mr. Beakes came into the room and started a sexual conversation with two of our Den Mothers. He told them they had problems and since he had studied medicine he would be able to help them, provided their husbands weren't told and they had complete trust in him. He asked them to call him at any time during the day as he was home all

day.

I was very disturbed and was going to call you for advice. The Assistant Scout Master had gone to the Training too and he called to tell me we were sitting on dynamite. He mentioned being with [redacted] the night before and [redacted] that afternoon. My wife questioned the boys and they told us what happened after we told the 11 year old boy if any thing happened he must tell us. He said he promised on Scout Oath not to tell. My wife told him this was a serious matter and could involve lots of boys and lives and the Scout Oath didn't apply to cases like this.

I want this man removed from Scouting and I think by all means he should receive medical attention.
