A 25-year-old self-proclaimed minister from Salem pleaded no contest Monday in Roanoke Circuit Court to the aggravated sexual battery of a 7-year-old girl.

John William Blackiston also faces three counts of sexual abuse in Chestertown, Md., as a result of a videotape that authorities found in his home while investigating the Roanoke case, according to Assistant Roanoke Commonwealth's Attorney Ann Hill.

In that tape, a young girl who is naked from the waist down is seen being sexually abused, Hill said.

In the Roanoke case, Blackiston pleaded no contest to fondling a 7-year-old girl at a Southeast Roanoke home where a man he knew was baby-sitting the girl and her 5-year-old cousin.

Blackiston initially was charged with fondling both girls, Hill said. But because of questions about whether the 5-year-old could testify against him, prosecutors agreed to drop that charge in exchange for the plea of no contest on the other charge.

In accordance with the plea agreement, Judge Diane Strickland sentenced Blackiston to 10 years in prison with five years suspended. The judge placed Blackiston on three years' probation and ordered him to receive counseling designed for sex offenders.

The Roanoke offense occurred April 27 about 3 p.m., Hill said.

While the baby sitter prepared a meal in the kitchen, Blackiston watched the girls take a bath and later fondled them in the living room, she said.

Blackiston told authorities he received a divinity degree from the International Bible Institute of Chula Vista, Calif., Hill said.

Quinn, now 59, said he did not think his conviction would become a campaign issue because it happened more than 30 years ago when he was in his mid-20s.

"I don't think it would be an issue by now," he said. "I guess everybody knows about it anyway."

nabbed Quinn and two men at an illegal distillery in the Endicott section of Franklin County. Quinn later pleaded guilty, was fined \$150 and placed on probation for years.

In 1964, his civil rights were reinstated, making him eligible to vote and hold office.

A Salem man has been charged with aggravated sexual battery of a 7-year-old girl, Roanoke police said Wednesday.

John William Blackiston, 25, is accused of molesting the child at a Southeast Roanoke home where a woman he knew was baby-sitting.

Police said the baby sitter apparently knew nothing about the incident.

In other reports from Roanoke police:
