Mr. Mohr:

After careful review, we have decided that any future registration on your part with the Boy Scouts of America should be denied. We are, therefore, compelled to request that you sever any relations that you may have with the Boy Scouts of America. Your probationary membership, which was granted on March 24, 1986, is now rescinded.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies, or reapplies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

The following information is provided should you desire a review by the East Central Region, BSA, of the decision to deny your registration.

- I. Within 60 days, you must request in writing a review of this decision. Your request should be sent to: East Central Region, Boy Scouts of America, P.O. Box 3085, 230 W. Diehl Rd., Naperville, II. 60566-7085. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
- 2. Upon the receipt of your written request, a committee will be appointed ? to review the situation.
- 3. If the regional committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
- 4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
- 5. You will receive a letter setting forth the decision of the committee.
- 6. If you are dissatisfied with the decision of the a regional review, you may request a further review by the National Council. The decision of the National Council will be final.

Eruce,

As per your request, I'm writing this to help clarify and correct some of the statements made in the troop meeting reports sent to you by , chairman of the troop #430 committee.

Even though most of the accusations are untrue, I have tried not to alter other peoples statements in these reports. The first report was written from memory over ten days after the initial meeting because no notes were made at any time. This was oecause it was suggested that I quietly resign as scoutmaster and no charges would be filed. Everything would be handled quietly and quickly and over with as soon as possible. However, I had to do what I could to protect my reputation in the community and in scouting as much as possible. It was I who reported this to the sponsoring organization, it was I who reported it to the council office and it was I who called the Rock Island County Sheriff's office when I heard that they were asking many questions about the incident.

To make this letter as short as possible, I will just refer to the page number of the report and try not to repeat every state-ment in its entirety.

I have made copies of the original "minutes" and corrected three copies. One of these you have, one was given to and I have the third. And I have double checked his copy and he agrees with the corrections I have made. I hope he has been in contact with you since this meeting to confirm these corrections.

Tirst report dated March 29, 1965. On pages 1, 2 and 3 you can see that the dates are incorrect. Also on page 2 -- The Goys usually swam hade but not always. Many wore their trunks under their scout uniforms and some even swam in out-offs or their undershorts. This included adults. No scout ever swam hade without their parents knowledge and every one had their parents pick them up at my house after swimming.

On page 4 -- When I was called about the committee meeting, I first asked if my wife could also attend. When I was told "no" than I refused to come to the meeting unless I was told the reason the meeting was being held.

Also starting at the bottom of page 4 -- I was the sociomaster in Aledo in 1965 and 1966. Our son was born Feb. 16, 1966 and I delieve I gave up the troop in the late summer of that year. I WAS NOT ABMED TO DEAVE THIS TROOP as stated later in these "minutes". I was transferred to the Rook Taland office of the Argus and did not have the time to devote to the troop and to do a decent job. Continuing on page 5, I was approached by a member on that troop and we did touch each other. However this

sitting with our daughter he did share a bed with me (our daughter was sleeping in the other bedroom) but there was NO sexual activity of any kind. This same boy later took a vacation and several short trips with my family, has been to our home many times and I have even worked with him for two summers. The touching incident only happened one time and was never mentioned again. The man is now over 35 and I believe he is gay. He does live in San Francisco but not in a gay community and he still visits (and is welcomed) our home almost every time he is in the area.

Continuing on page 5 -- I have inspected the boys at summer camp for ticks every year, however, I have only checked the parts of their bodies that they could not see, never their groins. The scouts were always told to check the rest of their bodies, including their groins, before getting into their sleeping bags.

My statement was, (and agrees) "If I'm guilty of anything, I'm guilty of voyeurism." A form of voyeurism is looking at the sexual organs of other people, both male and female, but sexual arousal or sexual gratification is not necessarily a part of it. Even looking at pictures in Playboy, etc. is a form of voyeurism.

A hernia was most definately discovered at the free physical for summer camp. The scout later attended TLT and spent a week at summer camp before he had corrective surgery. The leader at TLT, the camp director and the medics at summer camp and myself were all aware of this and the scout was watched very closely.

When I admitted touching the penis of a scout in troop #130, I was trying to prevent further embarrassment to a slout who has a history of bedwetting. I would check his sleeping day and his underwear during the hight and if he was dry, would wake him so he could go to the bathroom. If he was already wet, I let him sleep. His father was made aware of this as soon as we returned from summer camp and also knew that I checked his son on several other campouts since.

There were six boys (enough for two cars) and it was the Atomic Energy merit badge classes. This is the one that is held every spring.

As I said on page 8 -- I do not doubt that there are several discrepancies between my talks with and Tom and my rebuttal. They will both agree that I was in a very emotional state during each conversation and my rebuttal was written almost two weeks after these meetings. Two weeks in which I had spent many hours finding out who made the accusations and trying to figure out why. (I still believe that the committee should have informed me as to who was making the accusations.) Now that I know who made the accusations I do believe I know why the scout was holding a grudge against me for so long. I have not seen any member of this family since the campout on March 16-17 and I have no intentions, what-so-ever, of seeing them in the future.

To clear up one statement in the report dated April 3, 1985, on page 2 -- As I mentioned earlier in this letter, I was not asked to leave the Aledo troop. My job transfer kept me away from home over eleven nours a day and I wasn't giving the troop the time it recaired. The last summer that I was the scoutmaster, all we

interest and quiting scouts. For the betta ent of the troop, I DECIDED TO LEAVE, I WAS NOT ASKED TO LEAVE. In over fifty years, being scoutmaster of troop #430 was the first position of any kind that I have ever held that I was asked to give up.

I'm sorry to drag this out over so many weeks but I feel that I have been unjustly accused of some very serious offenses and want to do everything possible to clear my name and, if possible, to continue in other phases of the scouting program.

In closing, I would like to call your attention to the closing statements of the troop committee chairman beginning on page 6 of the first report. Please reread them. If the committee chairman indicates that I'm not guilty, the sheriff's office could find no evidence for charges and the parent of the scout refuses to put the charges in writing, I hope that the council office will find more that a reasonable doubt and not send this file to the national office. There has been other people, also unjustly accused who have continued to serve the youth in the scouting program and I hope that I can be considered to be one of these. If you insist, I would have no objections if you should want to set up some kind of a probationary period. The only thing I ask, if you should decide to do so, is that the conditions be put in writing so we both know exactly what is expected of me.

Everyone on the committee is still considered friend and would be made welcome in my home. As a group (a group I insisted on forming a year ago) you had me condemed that night before I ever arrived at home. You were wrong in not giving me the names of my accusers. You were wrong in saying that no information would go outside that meeting. I'll bet that there is not one of you here that didn't go home and immediately tell your wives what had happened. It was also being discussed at great length at the bowling alley in Milan within a couple of days. One of your sons was telling a neighbor that I was gay. Two of the older boys were telling new boys to stay away from me cecause I was "Funny". I have received at least one obsene phone dall at home. You were also wrong in not having the minister at that meeting. As far as the docusations against me are concerned ... Picture in latrine ... There was never a picture taken of a boy in the latrines. Pictures of boys roing to the bathroom ... Yes. There are of the cack view only and did not snow even the stream of water. I have three of these pictures, including my own son. Pictures of boys in underwear ... Yes. All taken either when they were changing clothes outside or when they were first getting up in the morning after sleeping under the stars. Games at the church... I'm glad to near and concerned enough about what happens at the meetings. However, since the game came out of the Scout book, I'd do the same thing again. There was a purpose to the game. Skinny dipping... Yes, Practically every boy in the troop and many adults have skinny dipped in my pool after the meetings. However, no boy ever swam without first getting permission from his parents and having his parents pick him up after swimming. Boys sharing my sleeping bag... Yes. Because one mother sent her son to the caoin in the middle of February with a light bag with a broken zipper. On another occasion, at summer camp when a Scout came into my tent, after parent night, homesick and wanting to go nome immediately. The boy was fully dressed including his shoes. This was the same night was injured and spending the night in the other leaders bunk. Tick Inspection .- Yes. I'v checked the boys head, arm pits, backs and outts. Never their testicles, they checked these themselves. I have found ticks and have either out them out or sent the boy to first aid to have them removed. Hav you ever seen an engourged tick or had an infection from one? I have! Magurbation... did what any mother had to do. I do not think it was handled correctly but I have no hard feelings to-ward her. As for the charges, was on staff at summer damp of 1983 and all staff members sleep in their own beds in their own cabins in the staff area. Not in the campsites with the troops. I did give every reason to be mad at me that summer and hold a grudge. For one thing, I reported him to the camp director for being in the mess hall and serving food with filthy hands, face and clotdes. He had spent the evening with the troop around our campfire and showed up for work the next morning without showering or changing clothes. I was also accused of teaching a boy to masturbate. I doubt that there is a boy in the troop who hasn't masturbated before the sie of ten - even infants do it. I was also accused of mutual masturbation. This I can only deny saying that it never happened. I am happily married and have been for almost26 years and I am definately not homosexual or even bisexual.

I will not de that I have touched sever of the boys, both accidentaly and on purpose. I have touched them accidentaly while wrestling in the swimming pools, both mine and the public pools when the boys were trying to dunk all the adults present. I have also checked for ruptures, checked for wet beds, applied cold packs to a boy who was bruised on a campout and even picked thorns out of a boys privates. If this is to be considered as fondleing, yes, I'm guilty.

Were there any other accusations?

The accusations against me couldn't have been any more serious, yet why

...Was

the only person permitted to talk to the boy?

...Was the younger brother permitted to go on a camping trip with
me the following weekend?

... After permitting the camping trip in the first place, was a meeting called that same night demanding my immediate resignation?
... Was I granted thirty days to resign and than have it denied at the last minute?

... Was I asked to write a letter of resignation, lying to the troop, after spending four years teaching them to be trustworthy?
... Wasn't the minister even notified? She should have been the

first to know.

Let's look at some of the other things that have happened in the troop. Nothing has ever been mentioned about the time...

... I took a sick boy home at 1 a.m., put him to bed and sat with him until 3 a.m. when his drunken parents arrived home.

... Taking the hyperactive boy on a 3-day camping trip with out the parents telling me that he must take medication. And that he would not take it on his own.

... Breaking the snuff and digarette habits of boys before their parents learned of it.

... How about the times I took the troop to activities and couldn't get enough cars to transport them.

... The time I had to take a boy to the hospital and did not have any adult leadership in camp.

... The many times I've reminded committee members of training sessions for the adult leaders and committeemen and Bill and I were the only ones who cared enough to attend.

... The hundreds of dollars the leaders have spent giving a program to your sons.

... The parents who sent their son on a hike to and from the cabin knowing that he had leg and foot problems and could not possibly make it.

One thing you have all probably wondered about is why I'm Still in the troop even after Rick went away to college. The main reason is that I have always liked kids and have always worked with them and have had them around our home when our kids were younger. Also, I know that the position of Scoutmaster is not easy to fill. How many of you would do what I have done for the troop? I haven't seen a one of you at a roundtable or a committee training session. In the community you have a woman doing an excellent job as Cubmaster (a position she does not want) because there is not a man with enough interest to take the job. I also get much personal satisfaction from the position. Including...

... Going rappelling and watching the face of a boy as he touches the ground after being pulled back up several times because he was afraid to go over the edge.

... Seeing the smiling face of the boy, who was afraid of the dark the night before, coming out of cave #11 at Maquoketa.

- ... Knowing the boy who heaped save his family from fire because he had some S at training.
- ... Having our doys volunteer to be color guard because they want to.
- ... Being asked to be color guard because of another joo well done.
- ... Having our troop number called out by other troops and staff members when they walk past out campsite at summercamp or district
- ... Knowing that any event we enter, we'll finish in the top 25%. ... Being told consistantly that we have the cest behaved troop
- attending different activities. ... Being able to leave out boys unattended and know thay will
- perform in the manner expected. ... Having the boys tell me secrets that they will not even tell their parents.

I have carefully reviewed the entire file again. Based on today's world, I do not think we should allow Mr. Moore to register and, therefore, I am going to suspend the probation which he was placed on previously.

If a application comes to our office, we will refuse the registration based on the things he admitted doing, which was certainly not in keeping with leadership standards. I will not get involved in any discussion related to whether he was guilty or not of some of the charges which were never resolved.

Let me know if you have further questions. At this time, we are making this a permanent file, which will not allow registration with the Boy Scouts of America.

At this point, after the passage of some five months it appears that:

- Johnnie Mohr is resolved to no longer being the Scoutmaster of Troop 430, and he indicates that with a few exceptions, his standing remains high in his community.
- believes the committee handled the situation in the best interest of all concerned: Mr. Mohr, Reynolds Methodist Church, complaining family, Troop 430 committee, and the Boy Scouts of America.
- The Rock Island County Sheriff's Department has concluded that since there is no evidence of any foundation to the accusations made, they have not recommended any legal action be taken against Johnnie Mohr.

The remaining issue at this point is Mr. Mohr's request to remain registered with the Boy Scouts of America either as a troop committee member, or serving in a position at the district level.

We would appreciate your review of this matter and welcome your recommendation for further handling.

   June 20, 1985 Memo from Chairman of Troop 430 committee, indicating that he had met on May 16 with Mr. J. Mohr to discuss his rebuttal of the charges levied against him.

At this point in time, after the passage of three months it appears that:

- Johnnie Mohr is resolved to no longer being Scoutmaster of Troop 430, and he indicates that with a few
  - exceptions, his standing remains high in his community. believes that the troop committee
- believes that the troop committee handled the situation in the best interest of all concerned: Mr. Mohr, Raynolds Methodist Church, complaining families, Troop 430 committee, and the Boy Scouts of America.
- It appears that no legal action will be taken against Mr. Mohr.

The remaining issue at this point is Mr. Mohr's request to remain registered with the Boy Scouts of America either, as he indicates, as a troop committee member, or serving in a position at the district level. (see 4/19/85 letter to Al Zenz) He is hopeful that we will keep his file at the council level and not forward it to the national office.



RE: Confirmation of meeting with former Scoutmaster.

This note confirms that I have met with Mr. J. Mohr, Troop 430's former Scoutmaster on 16 May, and we have discussed his rebuttal of the charges that were levied against him. Mr. Mohr obtained copies of my report from your office—and has provided me "corrected" copies, as well as the original draft of the rebuttal letter which was sent to Mr. 3. Pisel, who was then our troop's district executive.

After I had drafted my original report of his dismissal (29 March), I became aware there were some erroneous dates. I had incorrectly looked at the calendar as I attempted to document the various happenings, and while I was correct on the days, I was off by one week on some of the dates. Therefore, I concur with his corrections of the dates.

Mr. Mohr did ask to bring his wife to the Committee meeting wherein the charges were levied against him. I felt it would be better if she did not attend (ref. page 4 of my 29 March report).

I agree that Mr. Mohr made the statement, "If I'm guilty of anything, I'm guilty of voyeurism" (ref. page 5 of my 29 March report). In light of the charges, and his admissions to other incidents, I do not feel this elaboration has any significant impact on the outcome.

With regard to Mr. Mohr's additional details of touching the penis of the sleeping Scout who has a reputation as a bed-wetter. When I asked him where he touched the Scout, he replied "on the pecker." I must point out that I did not know-nor did I ask--if the scout was wearing bedclothes. (Again, ref. page 5 of my 29 March report).

Since the dismissal, I have learned that there are two Scouts—not one—in Troop 430 who attend the same private school (ref. page 1 of the 3 April 1985 memo). I do not feel that elaboration alters anything.

As to Mr. Mohr being asked to leave the Aledo troop, I cannot judge the truth of the statement or the elaboration (ref. page 2 of my 3 April report). The other committee member in whom Mr. Mohr confided related to the committee that Mr. Mohr was asked to leave that troop.

I assume Mr. Monr had given that information to the other Committee member.

Most of Mr. Monr's rebuttal is further elaboration of incidents that he related to me in private discussion, or that led to the charges which resulted in the Committee's action. Those details were not related to me at the time, and I cannot judge their authenticity.

Based on the charges levied against Mr. Mohr in March, and his subsequent comments to myself and one other member of the Scout Committee, I still feel we handled the situation as delicately as possible and in the best interests of all concerned: Mr. Mohr, the Reynolds Methodist Church, the Troop 430 Committee, The Boy Scouts of America, and the complaining families.

Just one more point. I was informed it was necessary that I submit reports of the case to the Scout Office in the event there was legal action. I realize the former Scoutmaster could have obtained copies of my reports if the case had gone to court, but I feel your office was out of line in giving them to him. Even though I refrained from mentioning names in those memos, a person familiar with past and present troop rosters could easily identify many of the people to whom I referred by the simple process of deduction. And in the former Scoutmaster's highly emotional state after being dismissed, action could have been taken against those people. Responsibility in that case would rest directly with the Scout Office.

As per our celephone discussion, this letter will conclude my reports. There seems to me to be no advantage for anyone—the Boy Scouts of America, the Troop 430 Committee, the sponsoring organization, Mr. Mohr or the complaining families—to continue discussions and rebuttals of the incident.

Bruce,

As per your request, I'm writing this to help clarify and correct some of the statements made in the troop meeting reports sent to you by \_\_\_\_\_\_, chairman of the troop #430 committee.

Even though most of the accusations are untrue, I have tried not to alter other peoples statements in these reports. The first report was written from memory over ten days after the initial meeting because no notes were made at any time. This was because it was suggested that I quietly resign as scoutmaster and no charges would be filed. Everything would be handled quietly and quickly and over with as soon as possible. However, I had to do what I could to protect my reputation in the community and in scouting as much as possible. It was I who reported this to the sponsoring organization, it was I who reported it to the council office and it was I who called the Rock Island County Sheriff's office when I heard that they were asking many questions about the incident.

To make this letter as short as possible, I will just refer to the page number of the report and try not to repeat every statement in its entirety.

I have made copies of the original "minutes" and corrected three copies. One of these you have, one was given to and I have the third. I and I have double checked his copy and he agrees with the corrections I have made. I hope he has been in contact with you since this meeting to confirm these corrections.

First report dated March 29, 1965. On pages 1, 2 and 3 you can see that the dates are incorrect. Also on page 2 -- The boys usually swam hade but not always. Many wore their trunks under their shout uniforms and some even swam in out-offs or their undershorts. This included adults. No shout ever swam hade without their parents knowledge and every one had their parents pick them up at my house after swimming.

On page L -- When I was called about the committee meeting, I first asked if my wife could also attend. When I was told "no" than I refused to come to the meeting unless I was told the reason the meeting was being held.

Also starting at the bottom of page \$\mu\$ -- I was the scoutmaster in Aledo in 1965 and 1966. Our son was born Feb. 16, 1966 and I believe I gave up the troop in the late summer of that year. I WAS NOT ABKED TO LEAVE THIS TROOP as stated later in these "minutes". I was transferred to the Rock Island office of the Argus and did not have the time to devote to the troop and to do a decent job. Continuing on page 5, I was approached by a member on that troop and we did touch each other. However this was not enjoyable and I was not aroused. This activity was ended by me very shortly after it began. When the boy was baby-

sitting with our augnter he did share a bed ith me (our daugnter was sleeping in the other bedroom) but there was NO sexual activity of any kind. This same boy later took a vacation and several short trips with my family, has been to our nome many times and I have even worked with him for two summers. The touching incident only happened one time and was never mentioned again. The man is now over 35 and I believe he is gay. He does live in San Francisco but not in a gay community and he still visits (and is welcomed) our home almost every time he is in the area.

Continuing on page 5 -- I have inspected the boys at summer camp for ticks every year, however, I have only checked the parts of their bodies that they could not see, never their groins. The scouts were always told to check the rest of their bodies, including their groins, before getting into their sleeping bags.

My statement was, (and agrees) "If I'm guilty of anything, I'm guilty of voyeurism." A form of voyeurism is looking at the sexual organs of other people, both male and female, but sexual arousal or sexual gratification is not necessarily a part of it. Even looking at pictures in Playboy, etc. is a form of voyeurism.

A hernia was most definately discovered at the free physical for summer camp. The scout later attended TLT and spent a week at summer camp before he had corrective surgery. The leader at TLT, the camp director and the medics at summer camp and myself were all aware of this and the scout was watched very closely.

When I admitted touching the penis of a scout in troop #130, I was trying to prevent further embarrassment to a stout who has a distory of bedwetting. I would oneok his sleeping bag and his underwear during the hight and if he was dry, would wake him so he could go to the bathroom. If he was already wet, I let him sleep. His father was made aware of this as soon as we returned from summer camp and also knew that I oneoked his son the several other bandouts since.

There were six boys (enough for two cars) and it was the Atomic Energy merit badge classes. This is the one that is held every spring.

As I said on page 6 --, I do not doubt that there are several discrepancies between my talks with and Tom and my rebuttal. They will both agree that I was in a very emotional state during each conversation and my rebuttal was written almost two weeks after these meetings. Two weeks in which I had spent many hours finding out who made the accusations and trying to figure out why. (I still believe that the committee should have informed me as to who was making the accusations.) Now that I know who made the accusations-I do believe I know why the scout was holding a grudge against me for so long. I have not seen any member of this family since the campout on March 16-17 and I have no intentions, what-so-ever, of seeing them in the future.

To clear up one statement in the report dated April 3, 1985, on page 2 -- As I mentioned earlier in this letter, I was not asked to leave the Aledo troop. My job transfer kept me away from home over eleven hours a day and I wasn't giving the troop the time it required. The last summer that I was the scoutmaster, all we did was play softball every meeting hight and the boys were losing

interest and quicking scouts. For the bette ent of the troop, I DECIDED TO LEAVE, I WAS NOT ASKED TO LEAVE. In over fifty years, being scoutmaster of troop #430 was the first position of any kind that I have ever held that I was asked to give up.

I'm sorry to drag this out over so many weeks but I feel that I have been unjustly accused of some very serious offenses and want to do everything possible to clear my name and, if possible, to continue in other phases of the scouting program.

In closing, I would like to call your attention to the closing statements of the troop committee chairman beginning on page 6 of the first report. Please reread them. If the committee chairman indicates that I'm not guilty, the sheriff's office could find no evidence for charges and the parent of the scout refuses to put the charges in writing, I hope that the council office will find more that a reasonable doubt and not send this file to the national office. There has been other people, also unjustly accused who have continued to serve the youth in the scouting program and I hope that I can be considered to be one of these. If you insist, I would have no objections if you should want to set up some kind of a probationary period. The only thing I ask, if you should decide to do so, is that the conditions be put in writing so we both know exactly what is expected of me.

For the exact details of these accusations and my answer to them, please see the reputtal in my file. This resourtal was read to the troop committee on Tuesday, April 2nd.

I was given no choice but to resign my position as scoutmaster by the troop committee on March 15th. The committee did not notify the minister of our enurch (the sponsoring organization) or the council office. These were outn notified by myself about ten days later.

At the present time I have no desire to go back into scouting as the scouthaster of a troop. However, with the training and experience I have had, I feel that I could be of service to the boys in the area either as a troop conmittee member or serving in a position at the district level.

Mour records will show that I have earned both the Scouters Key and the Training Award. I have also taken a training course at Philmont. Other records will show that I have helped at many council and district events and several Order of the Arrow functions plus attending most roundtubles and show-and-do's.

My past record will also show that troop #430 was one of the more active troops in the council the past four years. We have also had three Eagle Scouts in the same time period with another coming up during the month of May. There are also six more boys in the troop who have the Life rank and will becoming Eagle Scouts in the term near future. Among these six are two boys who will become Eagle' Socuts before their little birthday in October.

I have had many visits and phone calls from parents of boys in the troop and other scouters in the area all encouraging me to see if it would be possible to stay registered. The accusations against me couldn't have been any more serious, yet why
...Was
the only person permitted to talk to the boy?
...Was the younger brother permitted to go on a camping trip with
me the following weekend?

... After permitting the camping trip in the first place, was a meeting called that same night demanding my immediate resignation?
... Was I granted thirty days to resign and than have it denied at the last minute?

... Was I asked to write a letter of resignation, lying to the troop, after spending four years teaching them to be trustworthy? ... Wasn't the minister even notified? She should have been the first to know.

Let's look at some of the other things that have happened in the troop. Nothing has ever been mentioned about the time...

... I took a sick boy home at l a.m., put him to bed and sat with him until 3 a.m. when his drunken parents arrived home.

... Taking the hyperactive boy on a 3-day camping trip with out the parentatelling me that he must take medication. And that he would not take it on his own.

... Breaking the smulf and digarette dasits of boys before their parents learned of it.

...  $H_0w$  about the times I took the troop to activities and couldn't get enough cars to transport them.

... The time I had to take a boy to the hospital and did not have any adult leadership in camp.

... The many times I've reminded committee members of training sessions for the adult leaders and committeemen and Bill and I were the only ones who cared enough to attend.

... The hundreds of dollars the leaders have spent giving a program to your sons.

... The parents who sent their son on a hike to and from the cabin knowing that he had leg and foot problems and could not possibly make it.

One thing you have all probably wondered about is why I'm still in the troop even after Rick went away to college. The main reason is that I have always liked kids and have always worked with them and have had them around our home when our kids were jounger. Also, I know that the position of Scoutmaster is not easy to fill. How many of you would do what I have done for the troop? I haven't seen a one of you at a roundtable or a committee training session. In the community you have a woman doing an excellent job as Cubmaster (a position she does not want) because there is not a man with enough interest to take the job. I also get much personal sabisfaction from the position. Including...

...Going respelling and watching the face of a boy as he touches the ground after being pulled back up several times because he was afraid to go over the edge.

... Seeing the smiling face of the boy, who was afraid of the dark the night before, coming out of cave #11 at Maquoketa.

- ... Knowing the boy who heaped save his family from fire because he had some Scout training.
- ... Having our boys volunteer to be color guard because they want to.
- ... Being asked to be color guard because of another job well done.
- ... Having our troop number called out by other troops and staff members when they walk past out campsite at summercamp or district events.
- ... Knowing that any event we enter, we'll finish in the top 25%. ... Being told consistantly that we have the cest behaved troop
- attending different activities.
- ... Baing able to leave out boys unattended and know they will perform in the manner expected.
- ... Having the boys tell me secrets that they will not even tell their parents.

2nd meeting on SM resignation

DATE:

3 April 1985

Members of the Troop 430 Committee mer at the Reynolds Church Basement at 7 p.m. last night.

Committee members attending:

Joe DeMarlie Todd Schoonmaker Bill Spence Bill Hartman Tom Williams

The meeting was called as a courtesy to our former scoutmaster, who wished to address the troop committee. He attended with his wife, and of Mrs. Linda Barber, mother of one of the Scouts in Troop 430.

The meeting started at  $7:15\ g.m.$  because two committee members were late in arriving.

The former scoutmaster read a three-page letter to the committee, denying the complaints against him. A copy of the letter is enclosed.

The former scoutmaster and his wife both indicated that the committee improperly handled the complaint session and the request for his resignation. They felt a committee composed of the committee chairman, scoutmaster, complaining mother and her son, and the minister of the church, should have heard the charges, giving the scoutmaster a chance to face the boy and his mother. I, as committee chairman, and one other committee member, indicated that would not have changed the end result; the committee couldn't risk taking a chance that the charges were valid. Our first responsibility was to protect the boys. Our answer did not appeads the former scoutmaster and his wife.

The former scoutmaster's wife charged one of the committee members sons had gone to school and told people his scoutmaster was "gay." We have no way of knowing if that is true, although the son of the committee member charged is the only boy in the troop who attends a private school in an adjacent community. I can't figure out how his telling that at a private school—if, indeed, he did—would result in news leaking out in the Reynolds—Taylor Ridge communities.

Indicating that we could argue the issue all night, the former scoutmaster and his wife left the room. Mrs. Barber stayed long enough to indicate that she, and people in her neighborhood supported the former scoutmaster and that they felt we had not handled the situation properly. She then left, and joined the formers scoutmaster and his wife, presumably to go home.

The committee briefly discussed the meeting. Tom Williams and I noted several inconsistencies between what the former scoutmaster said in his letter and what he had told us in his separate meetings with us. Because of those inconsistencies, I decided to read to the committee the summary I had drafted for you. As a check on the accuracy of my memory, I asked Tom to read it first. He said it was accurate, and elaborated further on one point. With that, the letter was read to committee members who were present. All were caucioned not to repeat any of the material contained therein.

The point Tom Williams elaborated upon concerned the Scout Troop in Alado. He indicated the former scoutmaster had told him he had been asked to leave that troop.

I should point out that while I had refrained from repeating my conversation with the former scoutmaster to committee members, I had asked him on Monday, IS March, if he wanted the committee told of the things we had discussed. He had said at that time he didn't care if the committee knew. I had kept our conversation confidential because I feltified did nothing but harm him, and could further damage his reputation. Because I felt his written denial was inconsistent with his conversation to me, however, I decided the other committee members should be aware of it.

One other item has come to my attention. Earlier this week, the former scoutmaster indicated to Tom Williams that he falt he could still serve—possibly as outdoor chairman—on the troop committee, a position that has been held for more than a year by Tom Williams. While he did not make that request to the committee, and we did not formally vote on it, all committee members present indicated that he should not serve in that or in any other troop capacity.

It is our hope that the meeting of 2 April, and turning these summaries, the former scoutmaster's letter to the committee, and his resignation to the scouts, will end this problem. Again this evening, I will contact the mother who made the original complaint, and ask her to write out a statement. Last week, she indicated she would not. However, since she and her sons are mentioned in the former scoutmaster's letter, I feel she should at least clarify the complaints.

As I returned home from a club meeting at approximately 11 p.m., Tuesday, 19 March, my wife stopped me at the front door, saying there had been some calls during the evening from one Scout's mother. This mother wanted to talk with me immediately about what she said was a critical problem within the troop. I immediately went to her house to see what the problem was.

When I arrived at the Scout's home, his mother proceeded to tell me that her oldest son, who had dropped out of the troop late last summer for no apparent reason, had now confided in her that the scoutmaster had shared a sleeping bag with him and had fondeled or masturbated him.

About 15 minutes later, the boy arrived and I questioned him. He sat on the floor and kept his head down and his voice low during the antire conversation. He said he had quit the troop because of the overtures of the scoutmaster. He said that he had shared a sleeping bag with the scoutzastar, and pinpointed the incident as happening at Minneyada summer camp two years ago. He said that the sleeping bag had become torn. His mother recalled that the bag had been torn when he recurred from camp. There was never an explanation of how the bag became torn, or why the two of them settled into one sleeping bag. The former Scout went on to say that the scoutmaster had discussed masturbation with him at the time of the incident, and had "touched" his penis. The former Scout did not use the word "masturbation." He said the scoutmaster told him he (the Scout) had instigated the action, and if he told anyone, people would believe the scoutnaster, not him. He said that the scoutmaster went on to imply that it was his (the Scout's) fault. The boy (who is approximately 17 years old) went on to say that if the scoutmaster did anything to his younger brother (who is 12 or 13 years old), that he would "get him."

The mother told me the issue had come to light when a father in the neighborhood overheard his son and another scout talking about the scoutmaster's actions. Their discussion was on a game he had the boys play at a troop meeting in the Reynolds United Methodist Church basement, approximately three weeks earlier. It involved dividing the boys into two teams, with one member stripping to his undershorts. The nearly-maked team member them can to a plastic garbage lid at the far end of the Church basement. His teammates were to tie together several

ropes, throw them to him, and pull him back across the basement floor to the finish line. Since there was only one garbage can lid, the teams were timed against a stopwatch.

I was present that night, and should not have allowed the game to be played. It was not popular with the scouts. Several of the older boys refused to be the one who undressed. Then, their knots did not hold. At best, the game was a complete flasco. I later learned that the game idea had been taken from one of the scoutmaster's manuals. I must confess that I did not even think of the boy's embarrassment if the Church's female minister would have walked in.

The mother added that she had talked to another family in the troop, in addition to the family whose father had overheard the children's conversation about the "undressing" game. She brought up the subject of nucle swimming. I was aware that during the summer months, the scoutmaster had usually invited the Scouts to swim at his family pool after the Wednesday night meetings. They always swam aude—in the dark. While she could pinpoint no incidents at these sessions, she did ( point out that the troop members would go willingly for a time, then refuse to go any more. She added that the family whose father had everheard the boys talking about the scoutmaster's game, would soon have a Cub Scout entering the troop. The older brother flatly said the young boy could not swim at the scoutmaster's-but he gave no explanation for his statement. He finally told his parents that on one occasion about four years earlier, he had been swiming with trunks on and the scoutmaster had cold him to pull his trunks down so he could see him. when his mother asked what he did, he reportedly said "Mom, I was only 10". The boy is now either 14 or 15 years old. I do not know if this incident took place at the scoutnaster's pool or somewhere else.

The mother added that the son of the second family to whom she had calked, simply said he would not be alone with the scoutnaster.

The mother then proceeded to tell me of another "incident" that took place last summer at Minneyata Scout Camp, and involved her younger son. At this time, the scoutmaster supposedly put his arm around the boy during a campfire, and let his hand drop to the child's groin.

The mother wanted the incidents brought to the Committee's attention, indicated the scoutmaster should be removed from his post, and that if he were not removed, she would file charges. I assured her that I would look into the matter, and call a special troop Committee meeting, to which she would be invited to air her complaints.

The following night (Wednesday, 20 March), I attended the regular weekly Scout meeting. I observed the scoutmaster put his aim around one of the boys and talk briefly to him—it was the young son of the woman who had complained. I'd seen the scoutmaster do the same thing with other boys many times, but I hadn't thought anything about it. That night the scoutmaster reminded the boys that a weekend winter survival hike was planned to the Scout cabin a short distance outside the Village of Reynolds. Knowing that the mother was talking about possible charges against the scoutmaster, I was faced with a dilemma. I don't normally

The assistant scoutmaster reported he had seen nothing out-of-order on the weekend winter survival hike. He did, however, say that all of

the boys built their winter survival shelters very small, so there was no room for anyone else inside them.

After considerable discussion and a poll of the board members, it was agreed we should ask the scoutmaster to explain the complaints. Committee members also were polled on whether or not we should ask for his resignation. Keep in mind that the mother indicated she would press charges if he did not resign. It was the unanimous opinion of the troop Committee that we would have to ask for the scoutmaster's resignation to protect the boys; that we could not take a chance on whether or not the charges were valid. The parents left, with the exception of the one who was a troop committee member, and the committee decided we should not give out the complaintants names. Committee members expressed concern that the scoutmaster should know who was making the complaints against him, but fait that it was their responsibility to protect the boys.

I called the scoutmaster at approximately 9 p.m., told him there was a special committee meeting at my house, that the committee had heard some complaints against him, and asked him to come over to discuss the complaints. He refused to come unless he knew what the complaints were. I simply told him there were charges that he had been "playing with the boys." He arrived in approximately 15 minutes.

I outlined the complaints against him, as detailed above. We asked him to emplain them. He denied all the charges, saying he had never shared a sleeping bag with one of the boys. I told him that with the complaints that had been made, the Committee could not take a chance on their being true. I asked him to resign. "Do I have a choice?" he said. "Not really," I replied. He gave us his verbal resignation and left. The Committee members discussed how to manage the troop. It was agreed that one of the assistant scoutmasters should take over as acting scoutmaster until we could find a replacement. The meeting adjourned.

Early the following afternoon (Monday, 13 March), I received a call from the newly-resigned scoutmaster, asking me to meet him at his home at 5 p.m. At that time, I asked him if he would be willing to undergo an investigation—that he would initiate—to clear himself. He said yes, but then reconsidered, saying it would have a devestating effect on his family. He then related several incidents to me, and indicated he had also talked about them with another committee member, Tom Williams.

The scoutmaster told me that he had previously been investigated. He said that in the mid '50s, he had served as an assistant scoutmaster of a troop in the west end of Rock Island (troop number unknown), and that while on a campout the scoutmaster had molested two of the Scouts. He said the scoutmaster was charged and served time for the incident. Our newly-resigned scoutmaster claimed he had been cleared in the investigation, and had been allowed to keep the troop for approximately six months until a new scoutmaster could be found—even though he was actually too young to have the responsibility of a troop. He also told me that he had been scoutmaster of a troop in Aledo, III. I don't know when or how long he was associated with that troop, but he implied it was approximately 17 years ago; at the time his son was born. He went on to tell me he had been approached by one of the boys in the troop,

and indicated that they had fondled each other. Later, when his son was born, this same youth was baby-sitting the scoutmaster's daughter. The scoutmaster said the baby-sitter found his way to his (the scoutmaster's) bed. I do not recall if the scoutmaster said anything happened at that time, nor do I recall if he gave a date or a reason for leaving the Aledo troop. He did say that the boy is now a member of a gay community somewhere on the west coast, and that he has seen him since the incidents. He did not say if anything had occurred when he had seen him.

He went on to tell me that he has put his arm around many of the Scouts, but he denied dropping his hand to the child's groin. He admitted to conducting tick checks of the Scout's groins at summer camp, and justified it by saying that ticks can cause a fatal disease. He admitted to having the boys swim nude—at night—in his pool. He did not admit to fondling or touching any of them. He did say some could have been kicked in the groin during that activity, and, in fact, said he, himself, had been kicked in the groin during those swim sessions.

The scoutmaster also related some other incidents to me. He admitted to being guilty of voyuerism (obtaining sexual gratification from seeing sex organs and sex acts). But he continued to plead innocent to the sexual fondling referred to early in this summary. He admitted to touching a Scout's groin with his toe—and asking about a hernia that had supposedly been discovered during the Scout's summer camp physical (this was the same child who said the scoutmaster had fondled him). He admitted to having had another child in his sleeping bag—and scressed that the child was fully clothed. He said he was attempting to comfort the new Scout, who was homesick at summer camp. He stressed he did nothing to the child. He admitted to touching the penis of another Scout at summer camp. This, he explained, was because the child had a history of bed-wetting, and—when he discovered it—he checked the child nightly in an attempt to control the bed-wetting. He assured me the child's father was aware of the incident.

The scoutmaster asked me for 30 days to finish up his Scouting activities. I polled the troop Committee members by phone and got their consent, with the understanding that we always have someone with the scoutmaster and the boys, so that acthing could happen. This would-include taking five boys to Energy Merit Badge classes on three up-coming Tuesday mights, as well as the regular Wednesday might meetings. The Wednesday might meetings would be no problem because two assistant scoutmasters are always present. The Committee decided we would take turns driving the scoutmaster and the boys to the meetings, or sharing driving responsibilities with the scoutmaster. Under no circumstances would we permit them to be alone except in a vehicle in transit to or from the Energy meetings, and then only when there was a Committee member's vehicle immediately behind. The scoutmaster readily agreed to our conditions.

But the mother of the two Scouts did not agree. She indicated that the scoutmaster could have only one night to-handle his resignation and good-bye to the troop. Saying "We don't owe him anything," she threatened publicity and charges if he was involved in troop activities

beyond Wednesday night, 20 March. Reluctantly, I called the scoutmaster on the afternoon of 20 March, and told him he would have to wrap everything up that evening. He told make would turn in his written resignation, and would not stay for the entire meeting. I contacted the assistant scoutmaster, and asked him to put together some activity for the boys.

The scoutmaster has repeatedly asked me for the name of the complaining family, and has suggested two or three names as people who might make such complaints to the committee. He has said on two occasions that he does not want to persecute an innocent boy. The scoutmaster has reportedly met with his attorney, with you, and with the pastor of the Reynolds United Methodist Church. He has requested another meeting between himself and the troop Committee. He wants to deny all of the charges in a written letter. I have slated another troop Committee meeting for Tuesday night, 2 April at 7 p.m. in the Raynolds United Methodist Church Basement. We will give him time on the agenda.

It was the intention of the troop Committee to keep this problem quiet, to prevent charges against the scoutmaster, and to save the scoutmaster's reputation. We have no way of proving or dis-proving the allegations. Unaware that we should have contacted the Church's minister, we were negligent in making the initial contact. I should point out, however, that the Scouting Co-Ordinator is a member of the Church Board, as well as the troop Committee, and was present at the meeting.

I have the following comments about things as they now stand.

- I have personally known the scoutmaster for more than 10 years. I feel he has never lied to me. He denies the charges.
- The former Scout who made the complaints about being fondled by the scoutmaster has reportedly been caught in lies in his neighborhood, according to one committee member.
- 3. The mother who was willing to publically press charges when the issue initially came to light, refuses to write out those charges for submission to the Scout office, nor does she want her name or her children's names given to the Scout office. Still, she contends she will publically confront the scoutmaster if the troop Committee deems it necessary. Her complaints were the ones the committee felt were "crucial" complaints. Because of her feelings, I have not used her name, nor the names of any of the other complaining families in this report.
- 4. The youngest son of the woman who made the original complaint, is approximately as high as my shoulder. I'm 6'l, approximately the same height as the scoutmaster. I can't envision how I could put my arm around the meck of someone who is as tall as my shoulder, and let my hand drop to his groin. I don't know how much this child has grown since

summer camp. I think he would have to have grown quite a bit to have been small enough then for the scoutmaster to accomplish such an act, and such familiarity for two people of that approximate size seems to be hard to accomplish, undetacted—even if they were sitting down at a campfire.

- 5.. The scoutmaster has repeatedly asked me and one other troop committee member, what family made the charges. We have refused to give him the name, reasoning that if the charges should be true, we must protect the boy. Still, if he is guilty, he certainly should know who made the charges. His attempts to find out the boys name could be a ruse, but if so, he is playing it very convincingly.
- 6. The scoutmaster has devoted four years and countless hours to making Troop 430 one of the outstanding troops in western Illinois. Over those years, our troop has participated in repelling, canoeing, balloning, troop and patrol weekend campouts, and Merit Badge classes, in addition to the normal council activities. We have an extremely active troop. The scoutmaster has been the driving force behind all of this activity. There is no logical reason why he would work so hard to make the troop so active, then risk it on activities like the charges outlined above. Still, we seem to have a fairly high dropout rate among the older boys. I don't know why they choose not to continue. The scoutmaster indicates the dropout rate is no higher than in other troops.
- 7. Although troop Committee members and complaining parents accounted for one-half of the troop members at the 17 March complaint meeting, other parents have reportedly called the Scout office and complained that the scoutmaster's resignation was mishandled. Parents have also called other parents, an assistant scoutmaster, and—unknowingly—some Committee members. They have reportedly asked for:
  - A. An investigation, including questioning of all the Scouts.
  - B. A pecition to retain the scoutmaster.
- S. At the 27 March troop meeting, several older Scouts were cautioned by the acting scoutmaster against loud and obnoxious behavior; something we had seen coming on in past weeks. They indicated to the assistant scoutmaster that they had acted in that manner in an attempt to get the scoutmaster to resign.
- 9. I can't help feeling something is wrong with this whole scenario. I have not related the details of my conversation with the scoutmaster to other committee members. We asked him to resign over one "crucial" complaint, one "less-crucial" complaint, and reports of several "grey area" incidents that could have been mis-incorpresations. The original complaint

seems to me to carry some question of authenticity. Yet the scoutmaster's confession to other items related above, makes me feel that he should not lead our Scout troop. He may be innocent of the charges—and he may be guilty. But there is no question that he has become a victim—partially by his own confession.
