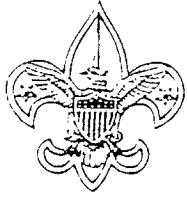


The St. Clair County, Missouri Prosecuting Attorney has tried this case in two preliminary hearings.

We are pleased to advise you that your employment as a Turkey Wing Gun Club Counselor at the RP-Bartle Scout Reservation has been approved. Your salary will be \$ 80.00 per wk which will be paid on 6/15,6/30,7/15,7/31,8/15. You will report for work on June 7 and continue employment until Aug. 8,1987, or earlier if reduced camp attendance causes staff reduction.

Your signature on all copies of this agreement will indicate your acceptance and agreement to the following terms and conditions of employment:

1. You are currently a registered member of the Boy Scouts of America in good standing.
2. You will obey the Scout Oath and Laws at all times.
3. You agree to provide a current medical examination by a physician, licensed to practice medicine, when reporting to work.
4. You agree to accept and to satisfactorily perform any assignment at the Camping Director's request, at any camp, for any camp activity at the compensation scheduled for that assignment.
5. You agree to be in proper uniform at all times:
 - a. FIELD UNIFORM: Scout shorts, short-sleeved Scout shirt or staff T-shirt, Scout belt, long stockings and garters, when appropriate.
 - b. DRESS UNIFORM: Official short-sleeved Scout shirt, shorts, long stockings and garters, when appropriate, and staff neckerchief.
6. You agree to refrain from the use of alcoholic beverages, drugs, narcotics, and to use all tobaccos only in permitted areas.
7. You agree to read and abide by all the policies stated in the camp staff manual.
8. You will be provided with room and board, two (2) staff T-shirts, and a staff neckerchief.
9. You will be covered by Workman's Compensation Insurance for on-the-job injuries.
10. The Council may terminate your employment if dissatisfied with your performance, or if violations of this agreement occur. You may also terminate your employment on 24-hours notice to the Camp Director.

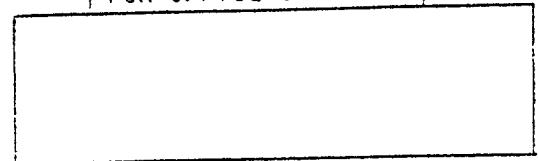

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be reinstated.


This is to advise you the agency's investigation on the report of sex abuse has now been completed. We found "Reason To Suspect" on three of the scouts who admitted being victims.
