
Dear Mr. Agarand:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

It has been brought to my attention that one of our Volunteers need to be placed on the Ineligible list. I am enclosing a copy of the registration and the necessary form for you.

Mr. Joseph A. Agarand Jr. of Bentonville, Arkansas was registered as a Webelos Leader with Pack 36 chartered to The First Christian Church. It has been discovered that he has been convicted of Child Abuse in St. Louis and has served 2 years in prison and has just been released from probation. On his adult application he did not indicate this and was accepted in January. However, after discovering his past record the leadership of the Cub Pack has asked him to resign his position. He has done so and has not been registered since March of April. He has not caused any problem for us but the fact of his past record and falsification of his application I recommend he be placed on the Ineligible List. Agarand Jr., Social Security # [REDACTED], address given as [REDACTED] Bentonville, upon reviewing his Adult Application dated January 8th, 1990, we have discovered a discrepancy in his answering Item #6 (Addition Information). Several questions were answered "No" when it has been brought to my attention that the answer should have been answered "Yes" by Mr. Agarand. It is my highest recommendation that you "immediately" ask Mr. Agarand to resign his registration with Boy Scouts of America until this matter can be looked into for validity of this information.

Mr. Towner may I assure you that my main interest is in the protection of our Scouts and our Leadership. Therefore with our shared interest is this matter we can resolve it at the earliest possible time. Thank you for your excellent work in service to our youth through Scouting.
