DEPOSITION SUMMARY OF [REDACTED] TAKEN 8/16/88

Calvin

Date of birth [REDACTED], lives with his grandmother and seems to be a defense witness. The only appearance at the deposition was State Attorney Howard Pohl.

He met Joseph Carol 14 years prior when [REDACTED] was transferred from Scout Troop 2 to Carol's scout unit. [REDACTED] was 10 years old at the time. The transfer was due to some vision problem that [REDACTED] had, and he had been a scout a year prior to the transfer.

The troop was meeting in a church across from Barry University. The troop moved around a lot until they finally moved into the old mission.

[REDACTED] became an Eagle Scout at age 19. He said that he should have been an Eagle Scout at age 18, but there was a mixup in his records. He was also a patrol leader and an assistant scout master at age 18.

He advises that there were several trips to Washington, D.C., Disneyworld and to the Star Trek and Comic Book Conventions. He alleges that he always went on these trips. They would all stay in one room. It would always be two adults and from four to six boys. It is very confusing as to when they went but it seems that they would go every year from 1982 until the time of this incident. It seems that [REDACTED] was age 18 at the time and went everywhere with Carol. The boys would sleep on the floor, beds or cots, and Joseph Carol would sleep by himself. The group was always together and during the questioning the State Attorney tried to see if they were ever separated, but Mr. [REDACTED] kept repeating that they were always together and there would be at least two of them together at all times. This would be one adult and one scout would be considered a pairing.

Mr. [REDACTED] did not relate these trips as being related to scouts as they did not want to complete all the forms that would be needed if it was a scouting activity. But during the questioning which was very leading from the State Attorney. It was finally determined that there was no way to differentiate between a scout outing or trip and that of the children's mission. Mr. [REDACTED] would advise that the trips to Washington, D.C., were business where they would go to meet people but could not state who they met and if they, in fact, every met anyone.

They questioned him as to his knowledge of the scout requirements to be a lifeguard and how many lifeguards were required per troop. Mr. [REDACTED] kept saying that he knew all the scout requirements but per his answers he knew very little of the scout requirements. Everything that he knew was hearsay, but he could not state who told him what was needed and what was not. It seemed that he was in charge of recordkeeping but very little records were kept. They did not seem to follow the scout policy as to the recordkeeping. He states that the age group for scouts was 11 through 18 and that no one under age 11 was admitted and once you became 18 you are automatically out of the scouts.

At age 18 he was put on the Board of Directors of the children's mission and was considered their treasurer but did very little recordkeeping as Mr. Carol would take care of everything.

IN MANAGEMENT

There was questioning concerning a child named [REDACTED] who lived with Carol from age 7 to 14. Per Mr. Carol the boy was put in his care from the state agency until such time as he could be reunited with his family or adopted.

It seems from the statements in the deposition that Mr. [REDACTED] was to bring all the financial records of the scouts and the mission but he didn't have anything of any consequence.

He alleges that Carol took care of everything and [REDACTED] knew little of what was happening within the mission and the scouts. He could not differentiate as to what was a scout activity and what was a mission activity.

In an overview they did not ask any questions of Mr. [REDACTED] as to Mr. Carol's activities with the other scouts. This seemed to be a deposition concerning the financial records of the scouts and/or children's mission of which Mr. [REDACTED] had very little information. It is noted that when Mr. Carol was put in jail Mr. [REDACTED] made himself director of the children's mission and was filing papers with the Internal Revenue but it was obvious he knows very little about that the position or operation of the mission concerned.

DEPOSITION SUMMARY OF IRVING SCHOENFELD TAKEN 8/16/88

He met Joseph Carol in a 1978 scouting outing near Davie which is known as Camp Seminole. Mr. Schoenfeld was the leader of Troop 700 and was a scout master for 45 years.

Has some activity with Joseph Carol at the mission and also saw him at different scout functions.

From the questions it seems that Mr. Schoenfeld was accused of picking up a 15 year old girl and stated that she wanted to have sex with him, but he denies this, stating that he made those statements under pressure, and that's why he said them, but they were not true.

The scouts pulled his affiliation after this incident with the young girl. Basically, there was nothing of any consequence regarding Mr. Carol and Mr. Carol's affiliation with the scouts.

She is a real estate broker and rented the house to Joseph Carol for 20 years prior to this incident. Rented the house for five years and left. Has been doing handyman work for Ms. Ransone and her husband. She and her husband donated money to the mission.

Her personal opinion is that Joseph Carol did not do these things, and that the boys are making this up because Mr. Carol was so strict.

DEPOSITION SUMMARY OF [REDACTED] TAKEN 8/11/88

[REDACTED] was 15 at the time of this deposition and has known Joseph Carol for many years.

Went on three trips with Mr. Carol and that was to Washington, D.C., Disneyworld and the Comic Book Convention.

After the last trip two detectives came to school to question [REDACTED] about Joseph Carol. The detectives asked if Carol had ever molested [REDACTED] and he advised them that nothing had taken place.

On the Washington, D.C., trip [REDACTED] assistant Scout Master, [REDACTED] and another person went to D.C. and all stayed in the same room with Carol.

Carol would take pictures of [REDACTED] while [REDACTED] was in his bathing suit, Carol said he needed the pictures to show that [REDACTED] was a lifeguard so he could get a trophy. Also took pictures of [REDACTED] while they were at the mission.

Carol would give the boys money for the trips and movies.

[REDACTED] never told [REDACTED] that Joseph Carol did anything bad to [REDACTED]

There was an incident in which a kid named, [REDACTED] was saying that [REDACTED] was doing it with Carol. [REDACTED] was going to fight him because this was not true.

Deposition took place on August 23, 1988. [REDACTED] birthday was [REDACTED]

He met Joseph Carol at age 10 or 11 through his cousin, [REDACTED] is also his cousin.

[REDACTED] saw Joseph Carol in uniform and wanted to join. [REDACTED] mother talked to [REDACTED] parents to get him to join.

After a year Joseph Carol asked [REDACTED] to come to Carol's house to try on some bathing suits. Carol took polaroid pictures, [REDACTED] would try on another suit and more pictures were taken, he would change again and more pictures were taken. [REDACTED] would always go to another room to change when Carol asked him to change right there in front of Carol but [REDACTED] refused.

About two months later at Camp Seminole, [REDACTED] was in charge of the food and Carol told [REDACTED] to put his sleeping bag in Carol's tent to sleep with Carol. During the night Carol opened [REDACTED] sleeping bag and grabbed his penis over his clothes. [REDACTED] told him to stop and Carol did never saying a word. [REDACTED] got up and left and never reported this to anyone.

He told his mother about this incident and the picture incident, and she stated he was out of the troop. She did not pursue this any further; did not call the police or anyone else.

[REDACTED] did not know about Carol taking any other pictures.

Did state that the pictures were in a yellow bag. Did not see many of the pictures only saw one and the pictures show a bunch of kids having a good time on the beach.

She has known Joseph Carroll for ten years as her husband was a scout master, this was Irving Shoenfeld. Went to a few parties at the Mission her husband would bring his scout and cub troop to these parties for either Halloween, Thanksgiving and Christmas.

The deposition then focused on asking her about her husband the problems he had with a child molesting charge against him.

## DEPOSITION SUMMARY OF ██████████ TAKEN 8/23/88

His date of birth is ██████████ he was 23 at the time of this deposition. He met Joseph Carroll through his cousin ██████████ who had met Carroll through a boy named, ██████████

██████████ was 11 years old at the time that he became a scout and was in the scouts for two years. He went on trips to Washington, D.C. and to Camp Seminole. States that the trip to Washington was a scouting jamboree. There were seven or eight people on this trip and they stayed at the hotel. They had three rooms and this was in May of the year that he joined the scouts. While they were in the room alone, Carroll pulled down his pants and began to "jerk off" and told ██████████ to watch. Then asked ██████████ to suck Carroll's penis, ██████████ said no and that was it. Did not report this to anyone.

At Camp Seminole, Carroll tried to get ██████████ to put on a bathing suit so that Carroll could take pictures but ██████████ refused. Also never reported this to anyone.

██████████ quit the scouts at age 13 because he was bored with it and was not aware of any other incidents between Carroll and the other scouts.

DEPOSITION SUMMARY OF HARLEM RANSONE TAKEN 8/16/88

He is a 71 year old real estate broker who was working for Lakeside Realty. Met Carroll in 1968 as he rented a house to him. Mr. Carroll lived there thru 1972. He was always late on his rent but Mr. Carroll would do some handyman type of work for Ransone on a part-time basis to help pay for his rent and other expenses. The kids from the Children's Mission would help Mr. Carroll sometimes.

Knew of no problems that Carroll had with the children was not aware of anything until this incident came up.

He believes that the children are after Carroll because he kicked out a bunch of them for not going to school and dealing with drugs. But Mr. Ransone could not state which kids were kicked out and which ones were making the charges against him.

Feels that Carroll is a very honest individual but has no information as to his reputation in the community.

She is the grandmother to [REDACTED] who was an eagle scout and treasurer of the Children's Mission for Mr. Carroll. Her date of birth is [REDACTED]. She was very confused throughout the complete deposition kept saying she was glad her grandson was in the scouts and that Joe Carroll was a very good man.

[REDACTED] began living with her when he became 11 years old at his request he called her and told her that he would live with her for the rest of his life. [REDACTED] never told her of any problems he had in the scouts or at the Mission. She states that Joseph Carroll was a very good man and very good to her grandson [REDACTED].

## DEPOSITION SUMMARY OF DR. SALIH YASIN TAKEN 8/23/88

She is an assistant professor of obstetrics and gynecology at the University of Miami and is the staff doctor at Jackson Memorial Hospital. She also worked at the Rape Treatment Center from June 13, 1985 to June 30, 1987. On May 20, 1987 she saw [REDACTED] and he stated that Carroll did nothing to him but that the detective wanted him checked. The doctor checked him and found nothing wrong with him. Also did blood test and there was nothing wrong in that area as well.

On May 20, 1987 she saw [REDACTED] and he advises that Carroll "he put his penis in my mouth. He put his penis in my butt and something white came out of his penis."

"He did that lots of times."

"He took pictures of me with and without clothes on."

His examine was normal except for his rectum where two large healed lacerations were noted. She also found that the sphincter muscle was lax thus meaning it had been damaged. The blood test came out negative for this individual.

On May 27, 1987 she saw [REDACTED] whose date of birth was [REDACTED]. The boy states "he used to touch my body, my penis and butt. He used to put his finger in my butt. He took pictures of me, some with my clothes and some with no clothes."

The last time this was done was when he was 12 years old.

The rectum showed two old lacerations and his rectum was lax.

On June 4, 1987 she saw [REDACTED] date of birth [REDACTED]. This boy stated he was not touched by Carroll. And his test were negative.

It was pointed out that the doctor could only state that the injuries were caused by trauma but could not state when the injuries were caused and what caused them.

## DEPOSITION SUMMARY OF ██████████ TAKEN 8/23/88

He was 17 at the time of deposition and his date of birth was ██████████. He became a scout at age 11 and stayed until he was 15 or 16 years of age. About six months to a year after joining the scouts while at the Mission, Carroll took pictures of ██████████ in a bathing suit so that ██████████ could get a lifeguard trophy. This was done just prior to going to the beach or to the movies. He took pictures between ten and twenty times and they were all with muscle type bathing suits. Carroll would then call other children into the room and they would take pictures as well. This is what ██████████ assumed.

Also took ██████████ pictures while he was nakid. Carroll never touched ██████████ or asked him to do anything he just took pictures over a two year period. ██████████ did not think this was wrong. ██████████ did state that he used marijuana as a scout but Carroll never knew.

He went to trips to Disney World in Washington, D.C. ██████████ does not know of anything happening on these trips.

While on a camping trip, ██████████ came into ██████████ tent stating that Carroll had made a move on ██████████. So ██████████ told him to forget it and sleep in ██████████ tent. ██████████ never reported this to anyone until this time.

She was in the sixth grade at the time of the deposition lives with her mother, stepfather, and two brothers. She went to scout meetings with her older brother, ██████████. She went about four or five times also went to conventions in Miami and to Disney World. She also went to the Star Trek and comic book conventions. She would stay in the motel with her brother, other scouts and Carroll.

While on a trip Carroll told her to change into a two piece bathing suit so that he could take pictures of her. He told her how to stand, then he told her to take off her suit and had her to lie on the bed. He then stuck his finger into her. Then he took more pictures of her as she was lying in bed nakid.

It is not clear when ██████████ told her mother it also seems that something occurred at the Mission as pictures were taken there as well but pages 31 thru 38 of the deposition are missing.

## DEPOSITION SUMMARY OF ██████████ TAKEN 8/15/88

He was 12 years old at the time was 6 years old when he first met Carroll through his brothers ██████████ and ██████████. He then joined the scouts when he was 8 years old.

Went to Disney World, Washington, D.C. and other trips. As a scout, Carroll took pictures of him at the Mission and he would be wearing a bathing suit that had no back. This happened many times. Also took pictures when they went on conventions. Carroll would also take pictures of other kids as they talked about it and no one liked it.

Took nude pictures of him at a convention at the Holiday Inn this was the Star Trek convention. Carroll would give him money when he took pictures. At the Star Trek convention Carroll asked if he wanted his picture taken. ██████████ replied "yes, for more money." He then had him get nude, rubbed all on his body, laid him in bed while Carroll took pictures. Carroll then asked ██████████ to give him a "blow job" but ██████████ refused.

At the comic book convention at the Howard Johnson Hotel Carroll rubbed all on ██████████ body and took pictures of him while he had his bathing suit on. Nothing else occurred at that time.

██████████ never told anyone until this matter came up. Carroll was arrested. He is aware of other boys in the area having their pictures taken in a bathing suit.

Mrs. [REDACTED] states her son, [REDACTED], joined the scouts at age 10 and was in the scouts until this incident which would put him between 13 and 14 years of age. [REDACTED] joined the scouts through a friend named [REDACTED]. He got his scout uniformed after being in the scouts for two years, went to the scouts every afternoon.

Mrs. [REDACTED] did not think Joseph Carroll was a bad person but did not know him very well. Her son never said anything about Mr. Carroll.

The first time she became aware of a problem was when she heard that Mr. Carroll was in jail.

[REDACTED] never told her or his father about what was happening with Mr. Carroll.

Christina and Mary from the state attorney's office came to the house and had [REDACTED] to tell [REDACTED] that Joseph Carroll molested [REDACTED].

When the boys went to Washington, D.C. Joseph Carroll would say that they stayed in separate rooms.

[REDACTED] and the other kids never said anything bad about [REDACTED] Carroll.


Dear Paul:






