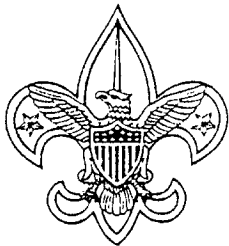

Rape charges were filed against Joseph Casey, 20, of Ogden Avenue Bensalem, in connection with an incident after a party on April 21, police said.

Casey was charged with rape, indecent assault, simple assault and indecent exposure. He was arraigned April 22 before District Justice Susan

McEwen and was released after posting \$5,000 cash bail. A preliminary hearing had not been scheduled. Police Sgt. Koszarek gave this account: Casey attended a party on April 21 at a house in the 5800 block of Neshaminy Valley Drive. An 18-year-old woman fell asleep at the house, she awoke the next morning as Casey was raping her, she told police. The woman screamed and pushed him off. Casey ran from the house, Koszarek said; the woman's boyfriend, who also had been sleeping at the house, chased him but Casey escaped. Casey turned himself in that evening.
