I hope this information will be sufficient for you to make an adequate decision. Please inform us of your decision so we may act accordingly here in Detroit.

## INTERVIEW [REDACTED]

The victim was interviewed at his residence in the presence of his parents on this date. The child was found to be more comfortable in his ability to relate what transpired on the night he slept at the KITTSTEINER residence. He related the following: As stated previously, he spent the day with the KITTSTEINER's, got home late and went to bed. [REDACTED] advised he was in the top bunk, with KARL Jr. in the bottom bunk. Victim advised he was awakened by the suspect and carried to the couch. Clad in his pajamas, and KITTSTEINER dressed, the suspect touched his stomach and his "privates" while [REDACTED] was lying on his back. After a short time, KITTSTEINER took him into the suspect's bedroom. During this time, the suspect was seen clad only in his undershorts. The victim advised that he and the suspect were in bed when the suspect took his [REDACTED] and told the victim to rub his "butt", and the victim complied. The victim further advised that the suspect moved on his side and exposed his penis (described as private parts by the victim). He instructed the victim to rub his penis and [REDACTED] advised he complied with the suspect's instructions. Victim advised there was other physical contact between he and the suspect but could not recall what it was.

## USE OF ROUGH DRAWING:

During the interview when the victim advised he was lying on the couch and the suspect touched him in his "private parts," the interview stopped momentarily and a rough drawing was shown to the victim. This handwritten outline of a human being was shown, and the victim asked to draw an "x" where he was touched. The victim drew an "x" in the crotch area and an "x" on the stomach area of the drawing.

When the victim alluded to the activities in the suspect's bedroom, three rough drawings were made. The first depicting the victim in bed. [REDACTED] advised he was directed to rub the suspect's buttocks with his hand. The victim [REDACTED] drew an "x" on the right hand. The two additional drawings represented to the victim the suspect. When asked where the suspect put his hand and one drawing depicting the suspect on his side/stomach, the victim drew an "x" on the buttocks. On the second rough drawing depicting the suspect on his back, the victim drew an "x" on the crotch area. The victim advised that his hand was placed on the suspect's penis by the suspect. At this time, an addition to the drawing representing to the victim a penis. The victim advised that he was instructed to touch this part of the suspect which was presently exposed.

ARTHER CON'T:

The parents indicated that they would pursue prosecution if it is in order, and that [redacted] would be willing to give a statement to undersigned on this date.

DATES/TIME/VENUE OF OFFENSE:

According to statements made to undersigned during the undercover meetings and letters he wrote, it is believed that the assault took place in early January, 1982 at the suspect's residence, 33910 Orangelawn, Livonia, during the nighttime hours, and on a Friday evening. m= 42159

INTERVIEW [redacted] VICTIM:

[redacted] was interviewed at his residence in the presence of his parents. [redacted] was evasive at the onset, and had trouble remembering certain instances. He is able to communicate well and relate the events in chronologically good order. [redacted] admitted being fondled or "played" with on just about every cub scout meeting he attended. When questioned as to the extent of this fondling and hugging, [redacted] advised Mr. KITTSTEINER was always putting his hands on me or having to sit on the suspect's lap.

A statement relative to the night [redacted] spent at the KITTSTEINER's residence was addressed. [redacted] advised that it was a cold Friday. On this day, KITTSTEINER picked up [redacted] and he and the suspect's son went to a BMX race where the suspect's son participated. During the activities, the suspect and [redacted] played various video games. During this time the suspect kept telling [redacted] that, "you owe me a favor", however, KITTSTEINER never indicated what the "favor" was. After the races were over the three went to the suspect's home. Upon retiring for the evening and being asleep for a short time, the suspect came into the bedroom and woke [redacted]. Further advised that the suspect carried him into the living room area and began hugging and touching him. After awhile, the suspect had [redacted] touch him. [redacted] advised he may have been crying and was upset at what transpired and what KITTSTEINER did was wrong and touched him where he shouldn't be touched.

[redacted] advised that whenever he would go to the KITTSTEINER's residence, the suspect would always be hugging and grabbing him. On one occasion, KITTSTEINER picked him up and carried him into a back room, and according to [redacted], KITTSTEINER began playing with him. [redacted] advised he broke free from the grasp and ran off. [redacted] advised during his encounters with KITTSTEINER that the suspect would change his actions and voice dramatically. [redacted] further advised that after this encounter (sleep over) he dreaded going to cub scouts and would become ill and even have to miss school. He further advised that during the fondling, the suspect advised [redacted] "This is the favor you owe me."

FURTHER:

Per the mailing of a letter to Insp. GROZA by the suspect on 1-22-82, KITTSTEINER detailed the activities he had with [redacted]. He further advised that the encounter occurred two weeks prior to January 22, 1982.

## NATURE OF COMPLAINT:

D/Sgt. [REDACTED] reports possible Child Molesting in Livonia, MI.

## JOURNAL:

None.

## FURTHER INVESTIGATION:

Undersigned officer made contact with the registered owner of a vehicle which was seen in the area of the suspect's house on February 1, 1982. The vehicle contained a young white male of cub scout age. The owner, who wishes to remain anonymous, advised that she does have a son who is a cub scout and was back on the day in question but does not attend meetings at the suspect's home on Orangelawn. She advised that her son attends meetings at 9206 California, Livonia, this being the SZAAL residence. An attempt to contact the SZAAL's proved nil. Several neighbors advised that the SZAAL's have two sons in scouting but neither is named [REDACTED].

NOTE: The suspect names the child he molested as being [REDACTED], attends his scout meetings and the boy's father is a lawyer. A source in the neighborhood advised the following. There is a [REDACTED] age nine or so, who attends cub scout meetings and the child's father is a lawyer. Source further advised that they live in the area of Berwick and Elmira Streets in Livonia. Contact made in that area and the [REDACTED] residence located at [REDACTED].

## INTERVIEW [REDACTED] AND [REDACTED]

Undersigned apprised the parents of [REDACTED], the extent of the investigation and the likelihood that their son had been assaulted by KITTSTEINER on at least one occasion when [REDACTED] had stayed overnight. The parents did confirm that [REDACTED] did stay overnight but did not tell them of any trouble he had with the suspect. They did advise that on hindsight they recall [REDACTED] being ill several times on the day he had cub scout meetings. They also thought it odd that KITTSTEINER would call them the following morning from the factory and inquire as to what was wrong with [REDACTED]. They also know that their son is KITTSTEINER's favorite. The parents agreed to question their son as to his involvement with KITTSTEINER in regards to sexual encounter.

INFORMATION GATHERED CON'T:

Reads books about the availability of children for sex, would like to go to California, New York, Spain or Mexico, maybe even Arizona.

Has or still is getting out of work, going home to clean up then "cruises" Six Mile and Woodward area in Detroit for children.

Will introduce his friend, "MIKE", from Ohio to undersigned and tell MIKE he can meet a guy who likes to play games.

Goes to video arcades with a handful of quarters and hands them out in hopes of finding a boy and to get in a few "feels."

Advised he goes to some arcades and "feels more ass in one night than he could handle in ten years."

Sometimes he watches boys playing games and they get so involved that they don't realize he is behind them feeling their bodies, etc. Further advised that when he meets kids for the first time, he has to find out where they live in case they don't come back to the BMX tracks or arcades.

ADDITIONAL:

Suspect advised that on 5-28-82, he was at a BMX track with his son and he met a 12 or 13 year old boy at an arcade there. After giving the boy some money and playing the games, he got to know the boy and got a "few feels in". Further advised that he has plans to meet the boy on 6-4-82 at 24 Mile Road and VanDyke in Shelby Township where there is an indoor track and arcade room. With the use of a concealed taping device (Niagara) #42986, undersigned commenced the conversation at 11:25 AM and concluded same at 12:40 PM. Tape recording placed into evidence this date with UD-14 being submitted. No search warrant return to be made at this time.

INFORMATION GATHERED:

The following statements were obtained during the course of the conversation. The following relate to his past alleged sexual contacts and another scheduled for the near future. The following is not verbatim and are the high points of the meeting and are listed as such. The suspect expands on sexual encounters he has told undersigned in the past.

The nine year old boy in Roseville he had met never came back, but before he was interrupted by the appearance of his son, the boy was ready, and before he had lured him into his car he had him pinned up against a fence and fondled him to get things started.

About two weeks ago, he was doing some plumbing work for a friend, the friend was in an upstairs room doing some work, the suspect was downstairs with the friend's six year old son. Suspect advised that he put the child on his lap and fooled around with him. Suspect advised while laughing, "I thought he was 18."

During winter, [redacted] from cub scouts spent the night, boy was staying the night, suspect went to him, the boy cried but didn't say anything to anyone the next day, "could of gotten in trouble over that one."

INTERVIEW WITH SUSPECT - Continued:

Suspect went on to say that the boy indicated he wished he (suspect) was his dad. Suspect advised he would be going back to Roseville on 5-16-82 and will try to find the boy and hopefully score.

FURTHER INFORMATION:

Suspect allowed officer to read sexually explicit letters he has obtained from a BOBBY GENE ACKERMAN of Stockton, California, who is a self-described homosexual and "chicken hawk" who wrote to the suspect detailing his amounts of sexual activities with boys (8-10 years) and tips on how to score with boys here in Michigan. KITTSTEINER indicated the letters make him jealous and somewhat frustrated. KITTSTEINER sounded quite hopeful in making contacts with his "boys" in Oxford and Roseville. Suspect continues to express his dislike for "porn", and remains cautious in the way he goes looking for "chicken". Suspect readily admits his need for children but is afraid of the consequences.

Additional meetings with this suspect is planned.

D/Sgt. MATTIOLI, acting in an undercover capacity, met with the suspect, KARL KITTSTEINER this date and learned of the following information:

On Saturday, 5-1-82, or 5-8-82, the suspect was in a Video Arcade in Oxford, Michigan, and met a white male, 13 or 14 years of age. Suspect advised that a few words with the youth revealed the boy might be interested in a further relationship. KITTSTEINER did not mention any sexual overtures being made by he or the youth.

On the following day, he took his son to a BMX race on Little Mack Ave. in Roseville, Michigan. At that time, he met a 9 year old boy who was also a participant in the bike race. Under the guise of showing the boy his car, the boy entered the car and they were talking a few minutes when the suspect's son came to the car and interrupted them. Suspect advised he liked the boy and would have liked to had him, but his son came upon the scene.

SURVEILLANCE:

Surveillance was conducted on Monday, February 1, 1982 by D/Sgt's. GENTRY and R.J. ANDERSON, Postal Inspectors PAUL GROZA Jr. and DON WYSE. Surveillance revealed a small number of boys entering 33910 Orangelawn at 6:00 PM.

At about 7:10 PM, KITTSTEINER left the residence with one young male in the car. At 7:30 PM, they entered the Dawn Donuts shop on Ann Arbor Road at I-275. At 7:41 PM, KITTSTEINER left and drove home. The young male left with a white female in a white Ford van, OH/82/KRP-144. This vehicle was followed south on I-275 to Ford Road and then allowed to proceed without surveillance. DETAILS OF INVESTIGATION

On 9-16-81, KARL KITTSTEINER mailed a letter to U.S. Postal Inspector PAUL GROZA, who was acting in an undercover capacity. Mr. KITTSTEINER advised, "I am interested in boys 11-15 years old. If you know how to find one, or have any literature or magazines, please write as I have had no luck with 'chicken' in the last 10 years."

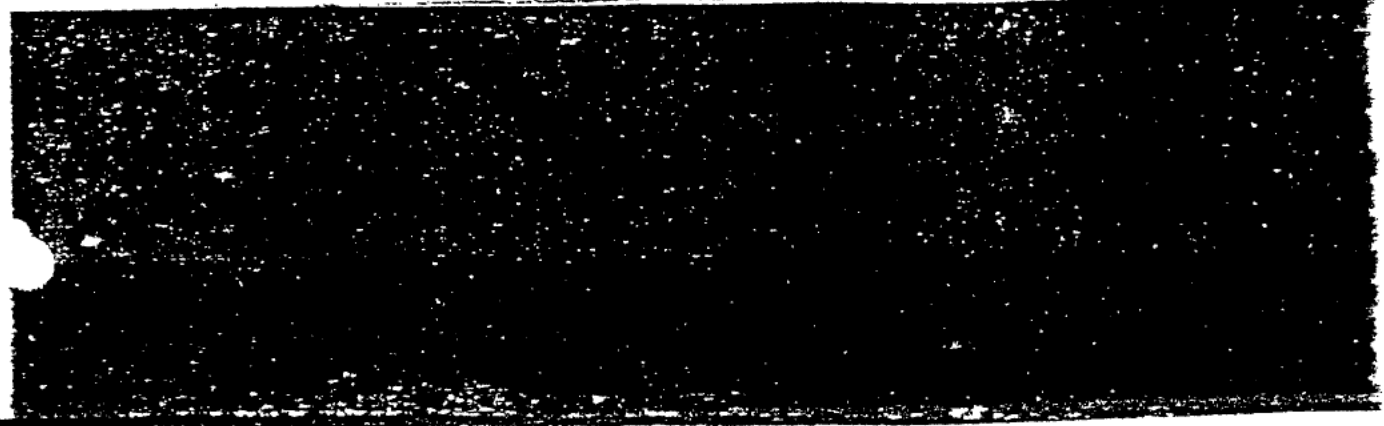
On 12-23-81, he writes to Inspector GROZA and part of his letter was as follows. I have had my eye on a nine year old who is part of my cub scout den. He enjoys my playing his ass and feeling him up all over. Further advised he was sitting on the floor and began fondling the child and obtained an erection.

On 1-22-82, KARL KITTSTEINER writes, I have alot of contact with boys, but let me tell you about the cub and you'll know what I mean. KITTSTEINER advises that again he fondled the legs and crotch of this boy and again obtained an erection. Further stated that after taking his son and the cub, [REDACTED], to bike races, [REDACTED] stayed over night and after putting the boys to bed, he woke [REDACTED] and took him in the family room, sat him on his lap and started playing with his penis. KITTSTEINER put the boy in his bed and got in with him and had an erection at that time. Further stated that he had [REDACTED] put the boy's hand on his penis, and at the same time he, KITTSTEINER, rubbed [REDACTED] buttocks and penis. After a short time, KITTSTEINER put his penis against the boy's buttocks and rubbed the boy's stomach and penis. KITTSTEINER further advised that, "I then asked him to suck me and put his head down by my d--k. boy started crying and said he was sick." Further advise that since that meeting with [REDACTED] he has touched him a couple times since then. Further that if [REDACTED] hasn't told anyone by now, he wouldn't.

On 2-15-82, KARL KITTSTEINER writes he has had no further luck with [REDACTED] and that KITTSTEINER feels [REDACTED] gets sick every time he, KITTSTEINER, makes advances. That it's a sticky situation being that [REDACTED] father is a lawyer.

On 2-24-82, he wrote a letter indicating he got some good feels in with some of his cub scouts, and hopes to make headway with [REDACTED].

On 3-1-82, Michigan State Police Officers received a note from KITTSTEINER requesting our assistance in finding "chicken", a term known as children for sexual relationship.

D/Sgt. MATTIOLI had six undercover meetings with KARL KITTSTEINER. On all occasions, he asked for help in finding boys. He also repeated his sexual encounters with the cub scout.

On 6-2-82, a search warrant was executed in that a conversation between KITTSTEINER and D/Sgt. MATTIOLI was to be recorded. KITTSTEINER alluded to several sexual encounters he has had with various children. Also offered suggestions on how to secure children for sex. In this recorded statement, KITTSTEINER advised that during the winter [REDACTED] from cub scouts spent the night and advised he got the boy to cry and, "could of gotten in trouble over that one."

On 10-15-82, D/Sgt. MATTIOLI interviewed [REDACTED]. The boy advised that nearly every time he went to cub scouts, KARL KITTSTEINER would hug and sit him on his lap. On the night he, [REDACTED] slept over, he remembers the suspect waking him up and being carried into the front room. Some type of argument ensued and [REDACTED] became upset as to why he, KARL KITTSTEINER, was touching him or why KARL wanted him to touch Mr. KARL KITTSTEINER. [REDACTED] further advised that many times during the day KITTSTEINER told [REDACTED] that he owed him a favor but would not specify what it was. During the encounter in the living room, KITTSTEINER told [REDACTED] "this is the favor you owe me for being your den leader." [REDACTED] advised that KITTSTEINER did touch him and what he did was very wrong. Further advised that the hugging and fondling and the walks to another room where some hugging took place was a common occurrence throughout the cub scout year by KITTSTEINER.

[REDACTED] summarized in saying that KITTSTEINER did in fact hug and touch him and that their argument was over the fact that KITTSTEINER was touching him where he shouldn't. KITTSTEINER instructed the youth not to tell anyone about what happened and that [REDACTED] still owed him a favor. [REDACTED] concluded his statement by advising that one time KITTSTEINER picked him up, carried him into a back room, and started "playing" with him and acting weird and he had to slip out of his grip to escape.

**SUMMARY:**

Sexual activities with the boy are discussed in detail in letters written by KITTSTEINER to Inspector GROZA, U.S. Postal, using the alias of "TODD". Undercover meetings with KITTSTEINER corroborated what he wrote in the letters and that he was writing to "TODD." A search warrant revealed an admission of contact he had with [REDACTED].

The letters and meetings with KITTSTEINER revealed his desire for investigators to get children for him. The interview of [REDACTED] revealed that KITTSTEINER as stated in his letters and conversations, was very fond of the child. KITTSTEINER, according to the boy, hugged and played with him every time they were together. On the night he slept over, [REDACTED] remembers being touched by KITTSTEINER, being asked to touch the suspect, and becoming upset and shaken as to what was happening. He remembers being told that he owes the suspect a favor and was instructed not to tell anyone what happened this night. [REDACTED] advised that since the contact with KITTSTEINER, he has dreaded returning and sometimes would be sick so he wouldn't have to attend meetings.
