## Former Teacher Pleads Guilty

DANDRIDGE — A former Jefferson County school teacher Thursday pled guilty to two counts of sexual battery involving two young boys. Kenneth D. Richey, 33, of White Pine, entered the plea before Circuit Judge Ken Porter in Jefferson County Criminal Court.

Richey, a former music teacher, resigned his position following his arrest in 1987. The indictment alleges the defendant fondled the teens while on camping trips.

The plea agreement provided for a three-year sentence which was suspended, providing the defendant maintains good behavior. He was placed on supervised probation and ordered to continue in psychological counseling.

## Jefferson Co. Teacher Faces Molest Charges

DANDRIDGE — A Jefferson County school teacher has taken a leave of absence after being named on two criminal warrants charging him with sexual offenses.

Kenneth Daniel Richey, 33, of North Maple Street, White Pine, had taught music at Dandridge Elementary and Maury Middle School since 1986.

Richey is charged with aggravated sexual battery and sexual battery on the warrants filed Monday in Jefferson County Sessions Court.

Richey allegedly fondled a 14-year-old boy while on a Boy Scout camping trip in the spring of 1987. He also is accused of fondling the boy in the spring of 1986 while on a camping trip on a Jefferson County farm.

The aggravated sexual battery charge stems from an incident in which Richey allegedly fondled an 11-year-old boy while on a Boy Scout camping trip.

Richey, who is not married, is free on a \$10,000 bond.
