I suggest that Kenneth J. Krakow, 886 Cleveland Avenue, Dubuque, Iowa, be placed in the confidential file. It seems that for many years he has been engaged in homosexual activities with boys in our area. This fact he admitted freely to me in a conference. We have taken appropriate action here.

He was a Scout in Troop 23, sponsored by Summit Congregational Church, Dubuque, from 1933-1938. He attained the Star rank in 1936. He served as: Assistant Scoutmaster from April 1938 to April 1951; Scoutmaster July 1951 to July 1958; Explorer Advisor July 1958 to October 1965; Assistant Scoutmaster October 1965 to the present time. These positions were in Troop 23 and Explorer Post 23.

He was awarded the Silver Beaver in 1954 and the Vigil Honor December 15, 1963. He is single. He belongs to the Masonic Lodge in Dubuque. He is 5' 7" tall and weighs 165 pounds. He is 49 years old and a native of Dubuque.
