The crime involved a 16 year old male and consisted of Drury fondling the privates of the boy. The investigation indicated there were other similar occurrances with other boys and included furnishing liquor to minors. Drury on Nomvember 10, 1982, pled quilty to the charge and was sentenced to one year formal probation and ten days in jail. I further add that Drury was at no time an employee of the J-J Ranch, but was returning the boy to the Ranch after a Boy Scout outing. Drury was apparently then registered as an adult leader in that council area.

Public record further indicated that Drury's drivers license has been suspended for a DUII conviction and is presently partially reinstated to permit him to drive for employment purposes.

I too am concerned that this individual has now begun appearing at our local council functions and request that you take steps to prevent him from doing so. I also request that you inform the

National Soy Shout Office of this person so that they may be alent for his attempted registration in any Scout unit.

Public record also indicates that on October 4, 1986, Drury was cited by the Grants Pass Police Department and charged with Felony Driving while Suspended, but has not been convicted at this time.

The attached letter from First Sergeant Ron Jones of the Oregon State Police documents that James Kenneth Drury sexually abused a 16 year old male at the T-T Youth Panch near Bend Oregon.

Fublic record in Deschutes County shows that Drury was cited on September 3, 1982 and charged with second degree sexual abuse. On Movember 10, 1982 Drury plead guilty to the charge and was sentenced to one year formal probation and ten days in jail.

To the best of my knowledge Mr. Drury is not currently registered with the Boy Scouts of America. Pending any guidance from you to the contrary, I am taking steps to ensure that he does not register through the Crater Lake Council. In addition he will not be permitted to participate further in any Scouting activities.

I recommend that Mr. Drury not be granted registration with the Boy Scouts of America and that proper steps be taken to ensure he does not register in some other part of the country.

The data on Mr. Drury's height, weight, etc. is contained in Sergeant Jones latter. If you need additional information please let me know.

On the same day your letter was written, we received a telephone call from Council No. 491 indicating that they were concerned about Ken Drury since he had been arrested in November of 1982 for contributing to the delinquency of minors. Apparently, he was sentenced to a one-year probation at that time.

We are getting ready to set up a file and as soon as more information is secured, we will set up a file and refuse registration based on the information which we have. We would like more information either from you or from the other council so that we have a complete file and can substantiate our refusal.

I believe this individual should be kept from Scouting since he has the conviction which I indicated.
