

Dear Mr. Hanigan:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

On the above date, Ron MacLellan and I arrived at Mr. Hanigan's home at 6:00 p.m. We were met at the door by his wife, and invited in. She informed us that Mr. Hanigan had just arrived home and was taking a shower. She showed us to the living room where Ron and I waited for Mr. Hanigan. Mr. and Hanigan joined us a few minutes later, - 6:15 - where upon I introduced Ron and informed Mr. Hanigan that I had been sent by the Council Executive to deliver a letter which I had to read to him in the presence of Ron. I read the letter aloud, and at the end asked if he had any questions. He had none. I handed Mr. Hanigan the letter and an envelope showing him the check enclosed in it as I explained that it was the registration fee of \$7.05 he had paid when he started the troop in October of 1986. I further told him that if he wished to appeal the suspension, to get in touch with Mr. Preus, the Council Executive. I also told him that he was to cease all Scouting activity, and not be in touch with any of the members of the troop. I further stated that the troop's charter partner head and the troop's committee chairman would be informed of his suspension, without detail of why he was being suspended. He asked who had informed us. I told him that I had been telephoned by Detective Vance of the Modesto Police Department and that he was conducting an investigation into allegations brought against him. He acknowledged with an "Oh". I said the Boy Scouts of America was not making any accusations, but that in light of the facts revealed to us, we had no other choice but to suspend his membership until the matter was cleared. I added that if all went well, he could ask to be reinstated. That in the meantime, all information will be held strictly confidential. Mr MacLellan then asked if he would mind giving us some further information (Confidential Record Sheet) for the record. Mr. Hanigan said he wouldn't mind. Ron then handed him a copy of the Confidential Record Sheet. I told Mr. Hanigan he was not obligated to fill it out, but if he would, it would certainly help us. He took the sheet and willingly filled it out, but not in its entirety. When he completed the form he handed it to me, and Ron and I left at approximately 6:40 p.m.
