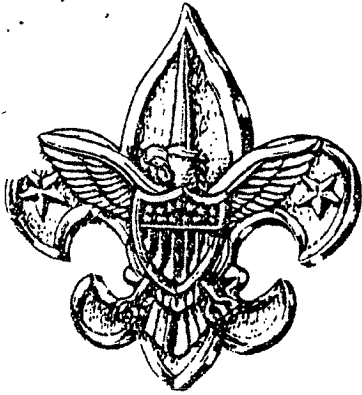

SUBJECT - REMOVAL OF KEN SMITH.

REASONS -

LATE IN MAY 1974 A GENTLEMAN AND FORMER SCOUT CAME INTO MY OFFICE AT THE MULTIPURPOSE CENTER IN SAGINAW.

HIS NAME WAS [REDACTED] ([REDACTED]) (PHONE [REDACTED]). HE WAS A NEW SECURITY GUARD AT THE MPC.

HE QUESTIONED ME ON HOW WE COULD ALLOW KEN TO REMAIN IN SCOUTING. HE SAID THAT BECAUSE OF INCIDENTS BETWEEN KEN AND HIS TWO BROTHERS HIS FAMILY WAS CONTEMPLATING PRESSING CHARGES AGAINST KEN.

I DID NOT TALK TO [REDACTED] AGAIN UNTIL MID JUNE. AT THAT TIME HE PHONED HIS BROTHERS AND I TALKED TO ONE [REDACTED]. [REDACTED] SAID THAT KEN HAD TRIED TO PLAY WITH HIS ORGANS AND HAD SUCCEEDED WITH HIS YOUNGER BROTHER [REDACTED]. ALSO HE SAID THAT KEN OFTEN PLAYED WITH ANOTHER BOY NAMED [REDACTED].

[REDACTED] ALSO RELATED AN INCIDENT DURING WHICH KEN WITH THE BOYS SPENT AN EVENING SHOOTING AT RANDOM AT PASSING

DURING THE O. A. WEEKEND AT CAMP ROTARY I CONFRONTED KEN WITH MY SUSPICIONS OF HIS CONDUCT. HE SAID THAT HE WAS WILLING TO RESIGN IF I WOULD NOT PUSH THE INVESTIGATION ANY FURTHER.

(KEN ALSO INFORMED ME THAT HE WAS PICKED UP IN LATE JUNE FOR QUESTIONING BY THE POLICE IN AN OBSCENE PHONE CALL COMPLAINT BUT THAT THEY COULD NOT PROVE ANYTHING.

WITH THIS INFORMATION ALONG WITH REPORTS THAT I RECEIVED OF PAST PROBLEMS AND INCIDENTS PRIOR TO MY ARRIVAL IN ARROWHEAD DISTRICT. I RECOMMEND THAT KEN L. SMITH (12121 BIRCH RUN RD BIRCH RUN MI. 48115, AGE 34 CAUCASIAN,) BE REMOVED FROM ALL AFFILIATION WITH THE B.S.A.
