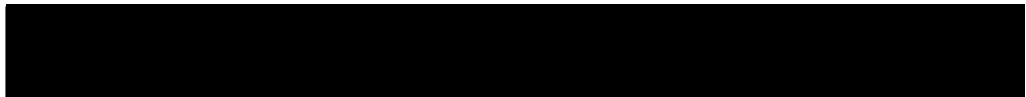

Memorandum of Conversation
February 11, 1988

On February 10, 1988. 5:40 P.M., David Smith, Council Vice President, and myself met with Keven B. Nelson. Our purpose for meeting was to hand deliver a letter to him suspending his registration in the Boy Scouts of American for moral related reasons. The meeting took place in my office at [REDACTED] Idaho Falls, Idaho.


After entering my office, Keven was asked to sit down. I handed him the original of the attached letter and requested that he read it. It appeared to me that he just glanced over it and then looked up. I asked him, "Did you read the whole letter and do you understand it?" He replied, "Yes I did."

I told him that I was aware of the fact that he had some keys belonging to our office and that I needed them back. He then removed 3 keys from his key ring, explaining what they were each for as he handed them over. I asked him to look at the two checks, made out to him, which were attached to the letter. He was asked if there were any other obligations that we should settle up with him. He replied, "No".

I pointed out to him that the request in the letter to "sever any relations... with the B.S.A." meant from this moment on. Keven said that he understood that.

David Smith commented that everything transpiring regarding this matter was being handled confidentially. Keven had no other matters to discuss.

We then shook hands and Keven departed.

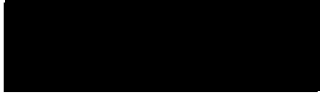

Dear Keven:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is attached.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to us explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

Tuesday, February 9, 1983

40 P.M.

Tonight at 8:45 P.M., Ken Helms and I visited the home of [redacted] in [redacted] to allow him a chance to convey some important and confidential information to us. The visit was made after obtaining permission to talk confidentially with [redacted] from his mother. We met privately with [redacted]. I explained to him that whatever information he told ~~us~~ ^{us} would be treated in a confidential matter. He ~~is~~ said that he knew why we were there.

[redacted] comments were that he "had been over to his office and he would bring out magazines and then proceed." I asked him who "he" was. [redacted] answered, "Kevin Helms." He went on to explain that the magazines were pornographic. I asked him to explain what was meant by then would "proceed." [redacted] said it was masturbation and that he jined in a few times. I then asked him if Kevin had ever touched him. He told us that he was touched in private areas ~~and~~ briefly on a few occasions. To [redacted] knowledge this peddled in the Spring of 1981.

I asked him if he knew anything about tanning lights. [redacted] said ~~Kevin~~ had one. He went on to explain that the procedure was to strip naked and tan with the light. over →

I asked him if he knew anything about sweat lodges. He said that [redacted] had one in his backyard but that he had never gone there. He gave us two names of boys he knew who had gone to [redacted] homes to use the sweat lodge and [redacted] had been in the sweat lodge on an OA outing to Fort Bridger. Most of the boys went naked into the lodge on that occasion.

He also said that on the way home from a meeting, ~~from~~ they stopped in Blackfoot where [redacted] bought a pornographic magazine. He asked [redacted] to drive so he could read it, but [redacted] declined inasmuch as he didn't have a license.

[redacted] [redacted]
[redacted] came in & talked to me on 9 Feb 88 at 4:30 P.M., on my invitation. When he arrived, he knew what was on the agenda.

- I told him that I was interested first of all in anything he had first-hand (what he had heard or experienced) and then what he had heard via others.
- [redacted] confirmed that it was Kevin Nelson, Lodge #1 of Advisor ^{who} that we would be talking about.
- First-Hand Intimacy

1) [redacted] first started sun-tanning w/ Kevin at his Knighton Optical office on [redacted] [redacted] This took place 3 or 5 a year through 1986. Sun tanning consisted of, inside back room, removing clothes and laying or sitting in front of a tanning lamp. During these sessions Kevin would look at pornographic literature and other it to who ever was with him. He would often masturbate himself and on one occasion touched [redacted] in a private area. [redacted] reaction was such that Kevin did not try it again. The lamp was portable so [redacted] attended one session at Kevin's home. No other boys were ever involved. It was always one on one.

This took place around Feb. 1985

2) Other First-hand intimacies include Kevin tending to talk loosely about sexual things;

2nd Hand Investigation

1) [redacted] is aware of other boys, on the CA
- dance team, who have individually been regular
participants in sun tanning sessions. Those he
knows have been involved are [redacted]

[redacted] (moved out of town) [redacted] feels
these boys' experiences have happened since he
stopped in 1986. [redacted] has asked some
questions of some involved, [redacted]
concluded that he had been touched [redacted]
(know no other details).

2) There is a practice of assembling a sweat
lodge, which started around August of 1987.
This involves building and [redacted] [redacted]

[redacted] (is optional, but). This has been done
on a few CA activities and [redacted] also has
one in his backyard. The only other
adult that [redacted] ever knows of being
around other than [redacted] his wife, was [redacted]
[redacted] went in with a swimming suit on
and hasn't been in since. The sweat lodge
is dark inside. [redacted] is aware that
the sweat lodge routine is still active; quite
often involving [redacted]
tells that sometimes they go ~~over~~ there alone.
