ORDER OF COURT


NOW, this 22nd day of June 1990, this defendant appearing in open court with his counsel Timothy J. Lucas, and after plea bargaining for the offenses charged to the above-captioned case, specifically corruption of minors, 18 Pa.C.S.A. Sec. 6301(a), misdemeanor of the <sup>FIRST D+R</sup> ~~third~~ degree, and Count 2, indecent assault, 18 Pa.C.S.A. Sec. 3126(1), misdemeanor of the second degree, this Court being satisfied that this defendant's plea bargain and resultant plea are all made knowingly, intelligently and voluntarily, the same are accepted and approved and he is adjudged guilty accordingly. It is the sentence of this Court this defendant shall be confined this date at the Western Diagnostic and Classification Center in Pittsburgh, Pennsylvania, as to the corruption count for a term of no less than 2 1/2 years nor more than 5 years, and as to the indecent assault count a term of no less than 12 months nor more than 24 months, the same to be consecutive for a total term of no less than 42 months nor more than 84 months.

Additionally, a fine in the amount of \$5,000 for the use of the County of Cameron is sentenced, and he shall pay costs of prosecution of \$141. This defendant is to be given a credit for time having been severed of 398 days.

This Court being aware that as to the indecent assault offense, the sentence imposed is within the aggravated range of sentencing guideline, and as to the corruption charge the sentence is outside the sentencing guidelines, all of which has been made known to this defendant and he has acknowledged same. This Court's reasons for doing so are as already stated of record in this plea proceeding, but for sentencing order, we find the offenses charged to be more serious or onerous than usual, we find this defendant in his present state to be a danger to society, we find the victim involved to be particularly vulnerable due to his age. Lesser sentence would be inappropriate. The victim is to be considered to be in a position of trust to this defendant and for other reasons before stated of record.

To the extent that this Court can enter terms of parole should this defendant be granted parole by the responsible body, it is the order of this Court that this defendant shall have no contact, direct or indirect, with  or any members of

their families or any other witness of the Commonwealth in this proceeding or any other of the proceedings presently pending against this defendant but which are about to be nolo prosequere, all of which have either been made known to this defendant or are ordered to be made known by Attorney Lucas. The same is excepting in communications with defendant's



The defendant shall seek and obtain mandatory counseling for matters pertaining to sexual offenses including sexual offenses with juveniles, nor is he to reside within 50 miles of or visit Cameron County or make any entry within the boundary limits thereof during his parole term. He will make restitution for any costs incurred by [REDACTED] or his family in relation to counseling expenses directly related to the crimes perpetrated against [REDACTED]. He will also maintain contact as deemed appropriate with the Cameron County Probation Office in regard to his whereabouts from time to time should he be released on parole.

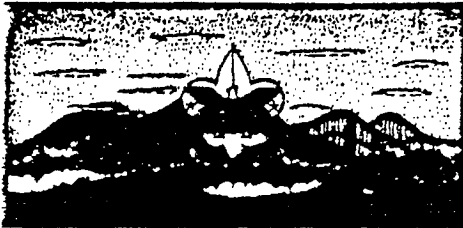
And any violation of the terms of this parole as hereinabove set forth, if same are adopted and approved by the determining authority, shall result in immediate revocation proceedings and possible immediate return upon revocation ordered to a state correctional institution.

Additionally, it is the recommendation of this Court that while he is incarcerated he shall be evaluated in regard to sexual offenses, the same should include diagnoses of pedophile. He shall upon his release from parole seek and obtain counseling with regard to same, which is mandatory. He shall abide with all conditions and recommendations of any counseling.

However, my suggestion is that Mr. Maxson be placed in your caution file as a precaution. Should [REDACTED] ever send a statement, or if someone else comes forward, I will, of course, alert your office immediately.

While we're at it, as a final report on Kevin Kriner, he pleaded guilty to one count of child sexual abuse and is now serving time for the conviction. I have requested that the Court Clerk send you, directly, a copy of the conviction record for your files.

I know these things sometimes drag on for a long time, but I would like a periodic update as material becomes available.

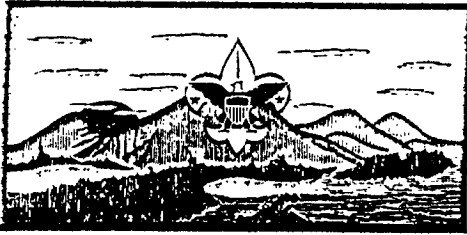

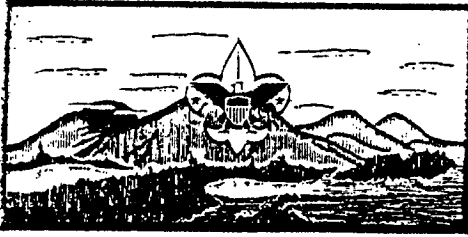

Dear Charlie,

has shared with you allegations of child sexual abuse raised against one of our Scouters, Kevin Kriner, Emporium, Pennsylvania, age thirty-five (35).

I have spoken to both the District Attorney and the investigating State Trooper. The District Attorney indicated only two (2) of the number of charges, corruption of minors and indecent assault.

The Trooper told me that the allegations go back to 1976 and, by Kevin's admission to date, involve at least nineteen (19) young people, some of whom are young adults now.

Kevin was registered as a Den Leader in Pack 3591; Committee Chairman of Troop 552; and Associate Advisor of Post 2500. He has also been involved in a number of other youth activities in his community. There is no doubt some boys in Scouting were involved as were other boys in his non-Scouting activities.

Specifically, the authorities have evidence of incidents of both oral and manual sex and that he showed pornographic movies, videos and computer-graphics as part of his illicit activities with the victims.

I have notified Paul Ernst to have Mr. Kriner removed from the files; we have done the same here.

I have also reviewed the situation with the District Chairman, our Council attorney, and the heads of the three sponsor organizations involved. They know what steps have been taken and understand that they are to contact me should they so desire in the future.

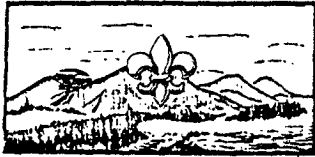

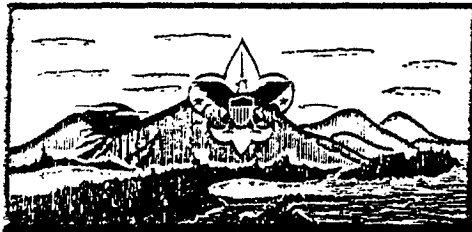


After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a Council Review Committee, please write to me within sixty (60) days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.
