



Dear Kurt:

The allegations from regarding the possible homosexual pass on Sunday night are indeed unfortunate. You understand, I am sure, that our concern at this point is for , for you, and for the camp in general.

For this reason and after discussion with Buford Hill our Scout Executive, we are requiring that you leave camp immediately with those possessions you absolutely need. You may return at a later date when things are resolved and clarified.

At present, you may consider your membership in the Boy Scouts of America as suspended pending further resolution and clarification of the situation. We will resolve some immediate concerns within the next 48 hours and will let you know of your status so your travel plans to the National Order of the Arrow Conference can be confirmed or adjusted. In addition, your summer camp salary will be suspended until this matter is resolved. You are fully entitled to be paid the portion of your honorarium you are due to receive after working up through August 9, 1988. Should this matter be resolved in your favor, you will be paid the balance of your honorarium and your travel bonus.

You may contact either me or Buford Hill if you have any questions. Again, our intentions are to protect your privacy, to safeguard the youth and staff at Lost Valley, and to mitigate any harm done to



Dear Ron;

As previously agreed, we took to start therapy to deal with a trauma he experienced at Lost Valley Scout Reservation while employed there this last summer. The therapist, Manuel Gonzalez, asked that the entire family come for the first visit which took place starting at 10:00 am January 21, 1989.

During discussions with and and were taken aback to learn that other incidents had occurred, and that a number of the older, more experienced staff members had warned new staff members to beware of Kurt's behavior.

Relative to my own family, it turns out that the experienced the most direct example of sexual child abuse by Kurt. It had told me of the incident, but I passed it off as so much kid play. On two occasions, Kurt touched while he was in the shower. On one occasion, Kurt came up behind and grabbed him around the waist. He placed his hands on stomach just above the hips. I elbowed him and velled at him to leave him alone. This incident led to a fight during which the bit Kurt. Many of the staff members were aware of this incident as Kurt went around camp to show the marks from the bite. A number of staff members are also aware of another fight in which this Kurt with a board and severely bruised his leg. This was also a warning from to Kurt to leave him and alone proved better equipped to handle such matters on his own than did

Because this story was told during therapy, the therapist is filing a separate report alleging sexual child abuse by Kurt toward . The therapist also asked that receive some counselling to put his feelings in proper perspective. It turns out he has probably handled his feelings better than but has a severe guilt complex because he believed he knew about Kurt's tendencies and he left alone. He claims he had a feeling that something would happen, and it did.

The therapist indicated that and both have excellent communicative and cognitive skills and should be able to put these events in proper perspective in short order. In the meantime, we request the Scouts also reimburse us for the cost of therapy for the we have investigated the possibility of using our Cigna Health Plan and determined that our plan will not permit us to have access to the specialist we believe is necessary. This opinion has been confirmed by our professional counsellor at work and by the representative we talked to from the Rape Crisis Hotline.
