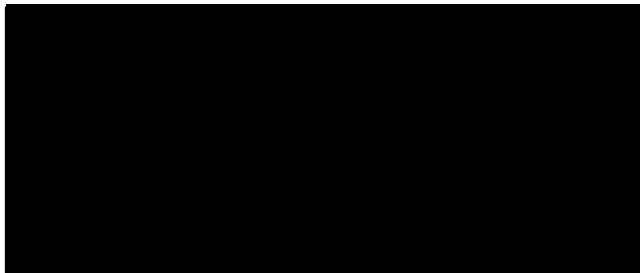
STATEMENT

In early October 1989, [redacted] and a friend was asked by Kyle Kuhn to go to the movies. After the movies, Kyle took [redacted] and his friend to a deserted field where he began a beer drinking party.

When the friend became ill, Kyle took him home and returned to the field with [redacted] to continue drinking. At the point where [redacted] was totally drunk, Kyle began to make sexual advances on him. These advances turned to sexual attacks as the night proceeded.

Kyle told [redacted] not to mention the episode to anyone. He said he needed help and wanted [redacted] to help him. He then continued to call and plead for [redacted] to go out with him but [redacted] refused to see him again.

As Kyle began to remove himself from Scouting, [redacted] felt like he did not need to say anything to anyone. [redacted] related this problem to me of his own free will on Tuesday, June 13, 1989. [redacted] being over 18 years of age, no police report was filed:
