

Dear Paul:

This letter is in regard to Larry Stidsen as per the attached confidential record.

He should be placed on the confidential list in that he did molest a scout in his troop.

The mother of the boy in question brought the information to the Scoutmaster who shared with me the problem, but refused to indicate the adult involved on instruction from his attorney.

The unit was due to re-register at the end of the month, and Larry was left off the charter. He, on his own, resigned as a Unit Commissioner (attached), and then called me at the suggestion of the mother and both came in.

He admitted that he had molested her older son (from a single parent family) and had started to do the same on one occasion with her other son. These were not truly cases deserving criminal prosecution, but could have led to more serious consequences.

The mother has been very realistic about the matter, by insisting that Larry receive professional help (is) and bringing it to my attention. He and she understand he can no longer ever be registered with the BSA.

This information should be sufficient to place him on the confidential list, but please let me know if you need anything else.
