

Scout leader asking exam in sex charges

CHARLOTTE — A 35-year-old Sunfield Boy Scout troop leader demanded pretrial examination Wednesday in Charlotte District Court on five felony counts of criminal sexual conduct involving four girls, including a relative, ages 9 to 13.

Named in the warrants was Larry William Shepard, 35, of 5251 Needmore Highway, Charlotte, an employee of the TRW plant in Portland and leader of Sunfield Boy Scout Troop 157.

Prosecutor Michael Hocking said his office was called into the investigation Nov. 7 after one of the victims mentioned some irregularities to her teacher at Sunfield Elementary School and the school principal contacted Eaton County's protective services representatives.

Hocking said he turned the investigation over to state police at the Lansing Post, and detectives

worked nearly two weeks before turning the results of their inquiries over to his office Tuesday.

Hocking said warrants were authorized Wednesday morning charging Shepard with three counts of second-degree criminal sexual conduct (involving fondling two older victims) and two counts of third-degree criminal sexual conduct (involving oral sex with two 9-year-olds).

Hocking said the warrants allege the crimes occurred on various trips Shepard took with the girls in Eaton County. The prosecutor said the investigation is continuing.

Shepard, Hocking said, voluntarily surrendered to state police at the Lansing post when they informed him they had warrants for his arrest. He demanded examination before District Judge Kenneth Hansen and was jailed in lieu of \$16,000 cash bond. His preliminary examination was set for Dec. 2 at 10 a.m.

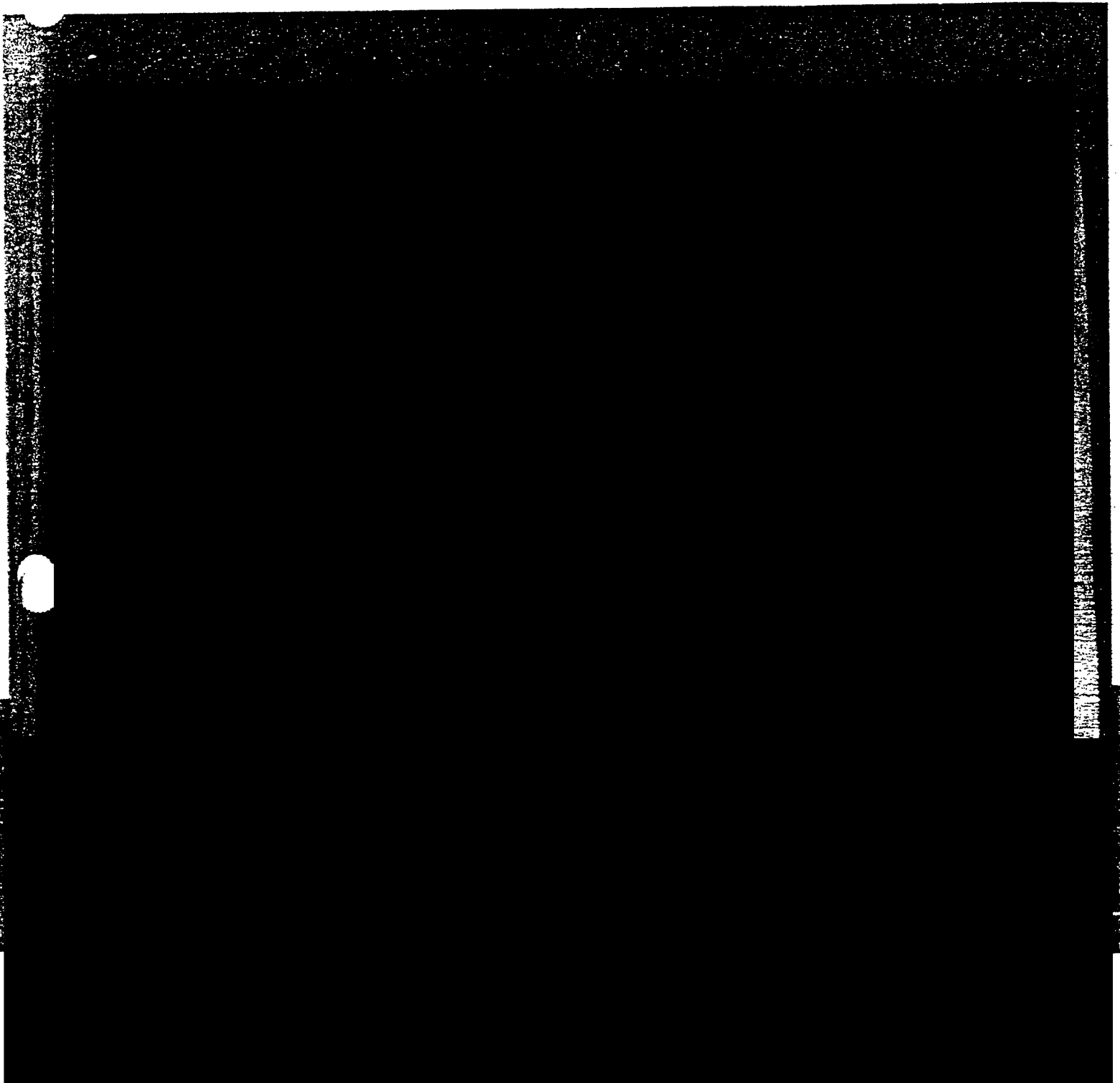
