District Court

The following defendants appeared Friday at Gardner District Court, Judge Thomas J. Carroll presiding.

Thomas R. Levier, 32, of 41 Greenwood St., was found not guilty of operating an uninsured motor vehicle. He was found guilty of attaching plates to a motor vehicle and fined \$62.50. He was found responsible for speeding and fined \$170.

Edwin Baker, age unlisted, of 1220 Main St., Athol, was found guilty of making annoying telephone calls and threatening to commit a crime. He was placed on probation for one year.

Arthur A. Osborne Jr., 31, of 1052 South Main St., Athol, was found guilty of operating a motor vehicle while under the influence of alcohol and was placed on probation for one year. He was found guilty of leaving an accident scene after property damage and fined \$250. Another charge against him, operating a motor vehicle negligently so as to endanger, was dismissed.

Lauri B. Long Jr., 51, of Hubbardston Road, Templeton, was found guilty of indecent assault and battery on a person 14 or over. He was sentenced to 2½ years at Massachusetts House of Correction, with the execution of sentence to be stayed for one year if specific conditions are met.
