2. NARRATIVE-DETAILS

Suspect: Bartelt, La Vern J., m/w, 03-15-29, [REDACTED] Janesville, 756-4473, arrested-NO

I made contact with [REDACTED] at his residence at [REDACTED] advised me that he was in the Medical Explorer Post that is run through Mercy Hospital. He states that he has gone to the meetings approximately three times and that the leader of the Explorer Post is a subject by the name of LaVern J. Bartelt. He states that he was contacted by Mr. Bartelt approximately one month ago and asked if he could come to the Mercy Hospital to his office to assist him in typesetting some projects. [REDACTED] did agree to do so and did go to Mr. Bartelt's office where he made contact with Mr. Bartelt. He states that while he was there at Mr. Bartelt's office that Mr. Bartelt kept leading the conversation to subjects about sex and his sexuality. He states that while he was at the office Mr. Bartelt did tell him that he had a, "nice ass". He states that Mr. Bartelt told him this several times. While there Mr. Bartelt received a phone call from a former scout who he called [REDACTED]. He states that while he talked to [REDACTED] Mr. Bartelt called him over to listen to the conversation. While [REDACTED] listened to the conversation he could hear the subject on the other end of the phone telling about a sexual experience he had had in the past. Mr. Bartelt after the conversation was over and he had hung up the phone, told [REDACTED] that he had a, "hard on", just from listening to the conversation from his former scout [REDACTED]. Mr. Bartelt then told [REDACTED] that his scouts and former scouts frequently tell him about their sexual activity and did tell him a story of two gay scouts and a sexual encounter and then told him a story about two male scouts and one female scout having a sexual relationship. He states that Mr. Bartelt also told him about his sexual experiences that he had while he was over seas in the military. He continued to tell [REDACTED] about the subject who had called on the phone who he told [REDACTED] was still in the military, he states that when [REDACTED] was younger that he had had a bad experience with his father and that he had excepted him as [REDACTED]. Mr. Bartelt told him that he had known [REDACTED] since he was fourteen years old. [REDACTED] believed that [REDACTED] was now approximately twenty years old. After approximately 3 to 3 1/2 hours [REDACTED] did decide to leave which he did do.

Approximately three weeks later which would be approximately one week ago Mr. Bartelt asked him if he could come up to the Hospital to assist him in stuffing some envelopes. [REDACTED] states that he could not recall the exact date of the encounter. He states that he did go up to the hospital and meet Mr. Bartelt in his office. He states that while in the office Mr. Bartelt continued to lead every conversation to some sexual aspect. He states that Mr. Bartelt asked him if he masturbated to which [REDACTED] replied no. He then told [REDACTED] that he should start masturbating and that if he did decide to try it that he should give Mr. Bartelt a call and tell him how it was. He then asked [REDACTED] if he knew what KY jelly was. Mr. Bartelt then got on the subject of his former scout [REDACTED] again. He stated that he took [REDACTED] to a store that sells sexually explicit materials and toys. He states that when he took [REDACTED] to the store that [REDACTED] bought some dilldos. At this point Mr. Bartelt did go to his desk and reach in the top right drawer of his desk and pull out three items. He told

12. NARRATIVE-DETAILS

██████████ that they were, "cock rings". ██████████ described two of the rings as brass and one is a black leather cock ring. He states that he told him that they were for prolonging erections and did tell him how to use them. He states that Mr. Bartelt referred to the male genital as a cock and balls. He then asked ██████████ to try them out stating that he would not watch ██████████ denied trying them and Mr. Bartelt put them away. Mr. Bartelt then asked ██████████ "how long is your dick". After speaking for awhile longer Mr. Bartelt did go to his briefcase which ██████████ described as a brown bag type briefcase with several partitions in it. He states that he pulled out a green check book style billfold which is approximately 8"x4" and from behind some papers that were inside the billfold, pulled out a poloroid photo. He states that Mr. Bartelt handed him the photo and told him that was a photo of ██████████ gentiallia. He described the poloroid as a male subject standing with his shorts pulled down with an erect penis holding a ruler next to his erect penis. After showing him the photograph Mr. Bartelt put the photograph away. ██████████ states that after approximately four hours of talking Mr. Bartelt asked him to go out for pizza and he did agree to do so. They went to Lisa's pizza and then ██████████ asked him to take him home which Mr. Bartelt did. ██████████ states that at no time did they do any work that he was requested to do.

██████████ states that he did not contact the Police Department immediately because he was not sure what to do. I asked him if Mr. Bartelt had ever confronted him with any sexually explicit comments or material with anyone else around and he stated no. He stated he thought it was because he was rather shy and did not know anyone else in the group. He states that he told his mother about the incident and that his mother thought that he should contact the Police so he did. He states that he wanted the Police to be aware of this in an attempt to prevent this from happening to any younger children. It should be noted that the Medical Explorer Group is run by Mr. Bartelt and that many juveniles and adults are in the program. The program also consists of male and female subjects.

This is the first report of any questionable incidents happening with the Explorer Program at Mercy Hospital. I suggest that follow up be completed by attempting to get a list of former members of the Medical Explorer Program and present members. It may be possible to determine who the former member Dwayne would be and he could be questioned about his encounters with Mr. Bartelt. Also Mercy Hospital administration could be contacted to determine how long Mr. Bartelt has ran the program and if he is involved with any other programs other than the Medical Explorer Post.

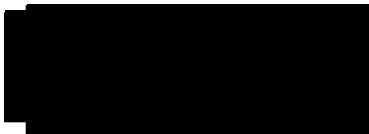
