THE ATTACHED STATEMENT RELATIVE TO ACTIVITIES OF ONE, LAVON MCKINLAY, CURRENTLY REGISTERED AS A COMMITTEEMAN, TROOP 97, SPONSORED BY THE RILEY SCHOOL P.T.A. IS SENT TO YOU FOR YOUR INFORMATION AND ACTION OF SEEING THAT A RECORD IS MADE SO THIS INDIVIDUAL MAY NOT BE REGISTERED AGAIN AS A SCOUT LEADER.

MR. MCKINLAY HAS BEEN CHARGED WITH AGGRAVATED ASSAULT AND [REDACTED] HE IS CURRENTLY BEING HELD AT THE COUNTY JAIL IN CROWN POINT, INDIANA. WE HAVE HELD OFF SENDING THIS INFORMATION IN THE HOPES THAT THE CASE WOULD HAVE BEEN HEARD AND A DECISION RENDERED AND UNTIL SUCH TIME AS WE WERE ABLE TO SECURE THE ATTACHED STATEMENT.

LAVON MCKINLAY IS 6' 2" IN HEIGHT; WEIGHS BETWEEN 175# AND 182#. HE IS A MEMBER OF THE CHURCH OF LATTER DAY SAINTS AND IS CURRENTLY LISTED AS HAVING HIS RESIDENCE AT 1375 LOUISIANA PLACE, GARY, INDIANA. MR. MCKINLAY IS 40 YEARS OF AGE. PRIOR TO HIS RESIDENCE IN GARY, INDIANA HE RESIDED IN CHICAGO, ILLINOIS.

CHARGES AGAINST MR. MCKINLAY WERE INSTITUTED BY HIS [REDACTED].

IF ADDITIONAL INFORMATION IS NEEDED I SHALL ENDEAVOR TO SUPPLY IT.

This is a statement made in the Juvenile Bureau of the Gary, Lake County, Indiana Police Department on Thursday, January 2, 1964 at 12:15 P.M. by Lavon McKINLAY, male, white, age 40 of [redacted] Gary, Indiana in the presence of Officers Steve BILLICK and Louis BRAVOS. Typed by Juvenile Officer Pauline HUDSON.

Q. What is your name, age and address?

A. Lavon McKINLAY, age 40 [redacted], Gary, Indiana.

Q. Do you read and write English and are you employed?

A. Yes, I read and write. I am employed at the EJ&E, Kirk Yard.

Q. Do you know why you are arrested and if so, tell us in your own words?

A. Yes, for molesting [redacted] and [redacted]. I heard [redacted]'s statement and I agree to what she said, and my statement would be the same.

Q. At any time did you make a penetration while you were trying to have intercourse with the girls?

A. No, I did not make penetration, but I tried.

Q. Did you at any time feel over their bodies and suck on their breasts and put my finger in their privates?

A. Yes, I told you I agreed to [redacted]'s statement and also to the contents of [redacted]'s statement, too.

Q. Is there anything more you would like to add to this statement?

A. Everything [redacted] said was true, but I would only go as far as [redacted] wanted me to.

Q. Did you ever tell the girls not to tell their [redacted]?

A. Not, really. I can't remember.
