

As we have records going back only four years he may have been registered prior to December 1955.

Since he was discharged as recently as June 1961, it may be that he hasn't gotten around to reregistering with this Council - we'll watch for any attempt to register with Troop #101 and let you know immediately if such papers come through.

Before his registration as a Troop Committeeman he was the scoutmaster of Troop 277. This man was assigned to the 81st A & E Sqn.

He joined the service in 1956. His discharge was ordered by Hq Third Air Force on 1 June 1961 under Air Force regulation 3566 which is homosexuality.

His date of birth was 16 October 1935, height 5'7", weight 180 lbs., hair brown, eyes blue, heavy build, does not wear glasses. This man is not married.

In Air Force records his home is listed as Rainbow Lake, Denville, New Jersey.

This man was an active scouter with scout basic and additional training courses and received the scouters award in 1960.

I am sorry for the delay in giving this information to you but it took me a little time to secure the information. It is recommended by the undersigned as well as the Neighborhood Commissioner on his base and all of the scouters in the Mayflower District that this man be put on the blacklist file of the Boy Scouts of America.
