In your letter to Sonny, dated April 5, 1991, you indicated that you hadn't heard from me in some time on this, which is correct, and I apologize for that. However, you must know, that I had a difficult time getting information and documentation from the City of Scottsdale on this subject, but finally was able to receive it.

The bottom line is this went before an arbitrator, and they ruled in favor of the Police Department removing Hauschild from the Explorer Post. Enclosed you will find the arbitrators ruling statement and a copy of the Ineligible Volunteer Record Sheet. Hopefully this will resolve matters related to Hauschild. If not, please let me know.

Paul, also you will find information related to Lawrence Meisner. Mr. Meisner is in Troop 114, and registered as a member of the committee. The incident he was charged with happened some time ago with [redacted]. To the best of my knowledge, this did not happen on a Scout activity of any type. I have included pictures of Meisner, copies of court documents and the Ineligible Volunteer Record Sheet. Please let me know if there is anything else you need.

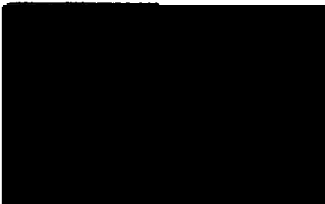


