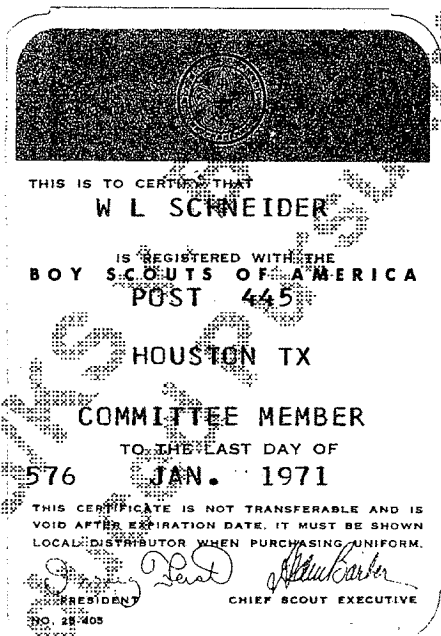

Compl came to Jay Div this date with his mother & stated the following:
 Compl's mother, [REDACTED] stated that approximately a year & a half ago, she applied to Big Brothers of Houston for a big brother for her son. At this time, the suspect was assigned to her son temporarily until some one could be assigned permanently. When they got a replacement, her son stated he had just as soon keep Roland, so they did. Suspect also is a scout master at Irvington Village. Compl's son has been with suspect three or four days a week since he first met [REDACTED]

Mrs. [REDACTED] stated that about 2 months ago, she found an obscene newspaper in her sons room & asked him if he got it. He stated that he got it from Roland. When she asked suspect about this, he admitted it, took the paper & promised not to do it again. After Christmas, her son got a letter dated 12-27-68, postmarked Houston, with several copies of a hard making an obscene gesture. Roland admitted sending it to him. She talked to Compl & found that suspect had been handling her & performing unnatural sex acts on him. When she confronted suspect with this, he readily admitted it & didn't deny anything that her son had told her. Statement taken from Compl's mother.

Compl told officer [REDACTED] that about a year and a half ago, his mother applied to Big Brothers for a big brother for him. He stated that suspect was sent to them & after talking to him, Compl liked him and suspect started taking him pin-up. Compl's mother said Compl's scout master at Irvington Village. Compl stated that he had known suspect about four months. Suspect began bringing magazines with pictures of nude women in them & showing them to him & asking him if he liked them. Compl said you like to have a picture. Suspect then began an laying his hands on Compl and playing with his private parts. Compl asked

suspect to stop, but he wouldn't. Compl stated that about two days later he was in Suspects old apt on 9900 Memorial Drive and suspect was showing him some films of nude women, then suspect started playing with compls private parts again, and performed oral sodomy on Compl.

Compl stated that suspect committed these acts on his person about two times a week since he started over a year ago. Compl also stated that on one trip to a boy about outing to Camp Strake, suspect committed oral sodomy on him & also placed his (suspects) privates on compls buttox, rubbing it up and down.

Compl stated that the last time suspect committed this offense was on 1-9-69 between 7 & 8 PM, in the bed room of compls apt. Compl stated that this apt was the scene of most of the activity described. Compl stated that on this date suspect came over & they went to compls bed room where suspect laid compl on the bed, pulled his pants down, & committed oral sodomy on him. Statements were taken from Compl by Hastings. Also statement was taken from mother by Fochner. Compl & his mother were taken before Judge Willard Felker where charges of Molesting a Minor by Indecent Fondling were filed. BEFORE ME, THE UNDERSIGNED AUTHORITY, THIS DAY PERSONALLY APPEARED **RICHARD CASEY BEE PEARSON** WHO IS A CREDIBLE PERSON AND WHO AFTER BEING FULLY SWORN DID DEPOSE AND SAY:

My name is [redacted] I am 13 years old and live at [redacted]. About a year and a half ago, my mother applied to Big Brothers for a big brother for me. That is how I met Richard. He took me on several camping trips with the boy scouts and took me several places around town. I have seen him three or four days out of every week since we met. After I had known Lee about four months, he started showing me magazines with nude women in them. These were magazines like Playboy and Sir. He asked me if I wouldn't like to have a piece and a lot of things like that. One evening when we were riding around in his car, he put his hand on my peter, keeping my peter where I go to the bathroom. I didn't say anything & I told him to stop it. He would say okay, but he wouldn't do it. He took me home that night. About two days after that he was in his old apt. on 9900 Memorial & he was showing me some films of nude women walking around. He laid his hand on my peter and started touching it off, by this I mean disturbing me. He took me home after we went and got a hamburger. Every time he put his hands on me, I told him to leave me alone, but he wouldn't listen. About a week later, we were at his apt and he grabbed my peter in his hand & sucked me off, meaning he did what is called oral sodomy on me. He asked me to do him, & I refused. Then he pushed me and he would usually take my pants down, but kept his on. He did this about twice a week since he started it. Most of the time he was at my apt in my bed room. The last time, on Thursday, January 23, 1969, Lee came to my apt and we went upstairs to my bed room & lay on the bed and took my pants down and put his hand on my private part and played with it. He then put it in his mouth and sucked it. I came to a climax & he cleaned me off with his handkerchief and pulled my pants back up and slipped them up. We then went downstairs and he left. Lee is also my contact after he has sucked me on scouting trips. My mother found a letter Lee had sent me and she started asking me about him & I told her everything. One time on a camping trip at Camp Stroke Lee tried to put his peter in my butt, between my buttox and not my rectum. I can read and write this and I have read the above statement and it is true and correct. [redacted] and Richard.

BEFORE ME, THE UNDERSIGNED AUTHORITY, THIS DATE PERSONALLY APPEARED MRS. [REDACTED] WHO IS A CREDIBLE PERSON AND WHO AFTER BEING DULY SWORN DID DEPOSE AND SAY:

My name is [REDACTED]. I am 36 years old. I live at [REDACTED] with my four children, [REDACTED] 13, [REDACTED] 15, [REDACTED] 14, and [REDACTED] who is 11. I am divorced from my husband at this time. My phone number is [REDACTED]. I do not work.

About a year and a half ago, I applied for an application to the Big Brothers, to see about getting a Big Brother for my son [REDACTED]. About 2 weeks later, they called and stated that they were sending a Mr. Leland Schneider to be a Big Brother for my son but that this was temporary. They said that they would have to check further to get someone to be a permanent Big Brother for my son. Mr. Schneider came out right away and introduced himself to me. He stated that his family was in Beaumont and that he had just transferred to a new job here in town with Allied Chemical Co. Mr. Schneider started coming to our home in the evenings to pick up [REDACTED] ([REDACTED] is the nickname that I call my son) He would take him mostly to the "Y" and they also went to shows. Mr. Schneider started coming over almost every afternoon to pick up my son. There were very few afternoons that he did not pick him up. I was always at home, when he came to the house to pick up [REDACTED]. This was in '67 and I think Mr. Schneider started picking up [REDACTED] sometime in July, because the children were out of school. About 2 months, the people [REDACTED] from the Big Brothers called me and said that they had found a permanent Big Brother for my son. We met him, and [REDACTED] did not like him, and stated that he would prefer Mr. Schneider to be his Big Brother. Mr. Schneider was coming over to the house so much, that I finally said something to him and to [REDACTED]. I told Mr. Schneider that he would have to cut down his visiting, to about 2 or 3 days, a week. He agreed, but eventually he got to where he was coming over to the house more and more. He moved his family to Houston, and I met his wife and got to be good friends with her. Mrs. Schneider had planned a camping trip for him and [REDACTED] in August of 1968, and at first I thought I would let [REDACTED] go. For some reason I changed my mind and told [REDACTED] and Mr. Schneider that they couldn't go. Then Mrs. Schneider called me at my home and asked me to reconsider because she was worried about her husband. She told me that her husband had gotten so attached to [REDACTED] that if I didn't let him go, that she was afraid that something would happen. I ask her what she meant by that, and she said that she thought that her husband might try to kill himself or [REDACTED] or he might try to kidnap [REDACTED]. So I decided to let [REDACTED] go with Mr. Schneider. The last part of 1967, Mr. Schneider had been at my house and had asked me if I knew a doctor that could recommend to him. He told me that he was very nervous and thought his blood pressure was high. I told him to go see a Dr. LaPere. Later he showed me the pills that the doctor had prescribed for him. He had some tranquilizers, and blood pressure pills and sleeping pills. During all this time, Mr. Schneider had gone to the school and made himself acquainted with the school officials. In fact, on several occasions when [REDACTED] got some awards at school, they had notified Mr. Schneider who was present when [REDACTED] got the awards. I did not know that he got the awards until he got home from school. Also Mr. Schneider told the school if anything happened or if there were any problems to call him. When I found out this, I got very upset and I informed [REDACTED], Mr. Schneider and the school, that I was [REDACTED]'s mother and I was responsible for him and I was to be the one to be notified.

Everything seemed to go all right for a while. Mr. Schneider kept coming over to see [REDACTED]. About 2 months ago, I was cleaning [REDACTED] room and found a dirty magazine underneath [REDACTED]'s pillow. I thought that one of the older boys had probably given it to [REDACTED], so when Mr. Schneider came over that evening I showed it to him, thinking that he would tell [REDACTED] that this was wrong. Mr. Schneider then told me that he was the one that bought the magazine for [REDACTED]. I got very mad, and chewed him out and he promised me that he would never do anything like that again. Mr. Schneider would send [REDACTED] letters in the mail, and I would usually open them. They would always be about scouting or something like that. On January 8, a letter came for [REDACTED], but I didn't open it. [REDACTED] came home from school and took it upstairs with him. The next day, my daughter, [REDACTED] brought the letter to me, after she had found it upstairs. She was pretty upset about it. The letter had five sheets of paper with a hand drawn, which was supposed to be the finger sign. The next day, on the 10th I started questioning [REDACTED] about the letter. Then he started telling me everything that had been happening. [REDACTED] told me that when Mr. Schneider would pick him up, he usually had some newspapers in his briefcase or glove compartment, and after they would get in the car, Mr. Schneider would let [REDACTED] read them. The newspapers would usually show naked women. [REDACTED] stated that Mr. Schneider also told him about the relationship that men and women have, and about going to a hot house. Also he stated that Mr. Schneider told him about the physical makeup of the males and females. Mr. After [REDACTED] some more, he told me that before Mr. Schneider's family had come to Houston, he would go with Mr. Schneider to his apartment on Westheimer. [REDACTED] stated that Mr. Schneider would unzip his pants. Also that he would commit oral sodomy on [REDACTED]. He told me that this happened a lot of times. In fact the last time that [REDACTED] told me that this happened was on the 10th of January. Mr. Schneider had come to our house and had gone with [REDACTED] to help him with his homework. [REDACTED] stated that Mr. Schneider closed the door and committed oral sodomy on him. [REDACTED] also told me that Mr. Schneider had told him not to tell anyone. On the 10th of January I called Mr. Schneider and told him that I had to talk with him and I wanted to see him away from my home. I met him at 5PM that afternoon and told him what [REDACTED] had told me. He admitted to me that this was true. He didn't appear ashamed but appeared to be upset that I had found out. He also told me that [REDACTED] was not the first boy that he had done this to. I then told him that he was forbidden to see [REDACTED] and he said ok. He was a Scout Master for the Boy Scouts and Wednesday a week ago, [REDACTED] went to the meeting and stayed 30 minutes later after the meeting was over with Mr. Schneider. [REDACTED] stated that Mr. Schneider just talked to him that night, and told him, he didn't blame [REDACTED] for telling me. I forgot to say that on that afternoon that I had confronted Mr. Schneider with what I had found out, he admitted to me that he was mentally sick, and needed help, and was going to seek help. Apparently he wasn't trying to hard to stay away from [REDACTED] because he would leave messages with [REDACTED]'s friends, to give to [REDACTED] since I had forbidden them to see each other. I finally called the Big Brothers and talked to Mr. Craig, who is the Director of the organization. He came out to my house and I told him everything thing that had been happening. He told me that he would talk to Mr. Schneider the next day. I talked later to Mr. Craig and he advised me that he had told Mr. Schneider to stay from Irvington Village. The Big Brothers organization would file on him.

THIS HAS BEEN ON MY mind so much, and I really didn't know what I should do about it. I finally went to talk to a lawyer and he advised me that I should report it to the Police Dept. I forgot to say earlier that when I had talked to Mrs. Schneider after she had moved to Houston, that she also told me that while she was still in Beaumont, her husband had written her and told her he thought it best that they file for a divorce, because he was involved in something in Houston. Also that he didn't think that they could make a go of the marriage. Mr. Schneider also bought [REDACTED] a lot of gifts. He would always bring something for [REDACTED] when he came to the house to pick him up. He wanted to buy him a lot of expensive things, and I finally had to put a stop to it. I never had an reason to doubt Mr. Schneider. He was very nice to my family, and everyone seemed to like him. In fact, the first I knew of all of this, was when I saw that letter and talked to my son about it.
