


Dear Mr. Morrison:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

LENNY MORRISON SUSPENSION FACTS

MARCH 15, 1991

Following is a chronology of events leading to suspension of Mr. Morrison as a volunteer leader.

1. District executive received information from Pack 14 leaders that there were suspicions and allegations that Mr. Morrison had falsified his leader application question 6c regarding charges of child abuse. Date: March 1, 1991.
2. Scout Executive received call of concern from Bonnie Simmons of Pack 14 alleging that Morrison had a criminal background (her husband is a policeman and had knowledge to this nature). Stone agreed to investigate as possible and suggested that Mr. Morrison be watched closely. Date: March 2-3, 1991.
3. Scout Executive learned from Troop 14 committee member (also a policeman) that Morrison had falsified application. Date: March 11, 1991.
4. District executive and district commissioner visited Mr. Morrison on March 4, 1991 at 1:30 PM. When confronted with the issue of falsifying the application, he indicated that he had been charged of 3 counts of abuse in 1973 - no convictions.

Morrison indicated "he forgot about it" when asked why he did not report charges as request on registration form. (Note: Morrison completed applications on 4/5/90 and 8/27/90).

This information was reported back to Scout Executive.

5. Mr. Morrison called Scout Executive to explain charges and encouraged him to contact his attorney in the case.
6. Stone contacted Director of local Big Brothers organization as Morrison represented himself as a Big Brother to a boy in Troop 14.

Big Brother Director was emphatic that Morrison was not a volunteer and would not be. Would provide no additional details.

7. Suspension letter send (certified mail) to Morrison on March 15, 1991.
