Recommended for Confidential File for following reasons:

*Between October 10 and October 10, 1961 Mrs. Levi Garland asked [redacted] negro - age 9 of [redacted] to accompany him over his car. Upon reaching a wooded area in the vicinity of the [redacted] he threw her to the ground, partially disrobed her and attempted to rape her. A witness to this fact was [redacted] negro - age 11 of [redacted] afterwards he advised the child not to mention this to her mother, but she did at 3:00 PM on October 11, 1961. He was subsequently arrested by the police at 5:00 PM same date and charged with rape and corrupting the morals of a minor. Examination of the girl revealed no bleeding or sperm within the girl stated he ejaculated on the outside of her person. Mrs. Garland on Nov. 5, 1961 reported over the Grand Jury on True Bill.*
