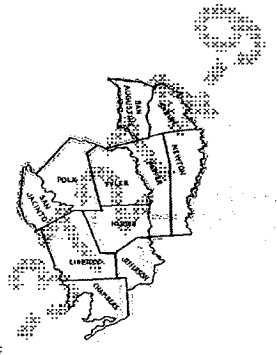

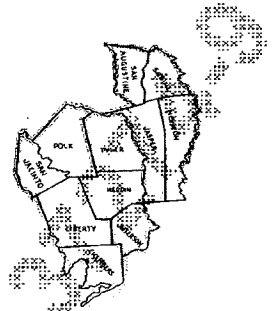

Dear Mr. Shoemaker:

Mr. Lindly Orr has resigned as advisor of Explorer Post 88. Mr. Orr had made a sexual proposition toward one of the Explorers in the post and the boy reported him to his High School Principal. It has been found also that Mr. Orr had propositioned an adult male not related to the Explorer program. Upon being exposed and confronted with the above facts, Mr. Orr has resigned his position as teacher in the Silsbee Public School System and has resigned as the Advisor of our Explorer Post 88.

Because of these homosexual advances, we believe that Mr. Orr should not be given the opportunity to reregister with the Boy Scouts of America.
