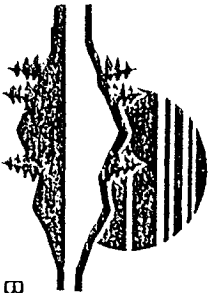

Upon our hearing of allegations against Mark Coulter a Registered Adult Leader in an Explorer Post, in our Council. We contacted the Winnebago Child Abuse and Neglect Access Unit and shared with them the names of witnesses. They were asked to investigate the complaints. Their findings were inconclusive and the Chartered Organization Representative was notified of the allegations and that no further action was to be taken by our Council. Mark Coulter investigation:

On September 7, 1989 the Winnebago Child Abuse and Neglect Access Unit was contacted to see what could be learned about the allegations against registered Boy Scout and Explorer Leader Mark Coulter. Gladys Farr contacted several parents and called me on September 11, 1989. She reported that their decision was that there wasn't enough there to press charges, but that his behavior seemed most inappropriate for a Scout Leader. She stated that parents felt he had huge mood swings, going from a "nice guy" to "raving maniac". He would explode and go on for hours at a time. The youth felt he was vindictive and anything they would do wrong, he would use against them. When the color guard was made to stand in 100° heat for punishment, 20 minutes every hour for several hours, one girl fainted. One boy was kicked but it was more of a humiliation than physical abuse. In concluding, the representative of the Child Abuse Unit said "I would never let my daughter belong to such a group". She agreed to share any other parents views that would further come in.
