Sex offender sentenced to prison

A foreign-exchange worker who faces deportation was ordered to spend three years in prison Tuesday on charges that he sexually assaulted a 14-year-old boy at a New Hartford camp.

Mark G. Drummond, 23, of Leeds, England, was charged with second-degree sexual assault and risk of injury to a minor after administrators at Camp Workcoeman on West Hill Pond in New Hartford complained to state police.

At Superior Court in Litchfield Tuesday, Drummond was sentenced to a total of eight years, to be suspended after three years.

Drummond was sentenced to three years on the charge of second-degree sexual assault and five years on the charge of risk of injury to a minor. He will face three years of probation after serving his prison term.

Cari B. Eisenman, public defender, asked Judge Walter M. Pickett Jr. to consider a lesser sentence than

the one recommended by John Dropick, state prosecutor. Dropick recommended that Drummond be sentenced to 10 years with suspension after five.

"My client is extremely remorseful for the act," Eisenman said. He added that Drummond knows he will never be able to pursue a career in education, his career choice.

"The career for which he aspired is no longer open to him," Eisenman told the court. Drummond graduated from Trent Polytechnic Institute in Nottingham, England, with a degree in chemistry.

Eisenman told the court that Drummond's offense is cause for deportation.

Drummond most likely will be deported by the U.S. Immigration and Naturalization Service at the end of his sentence and he will be unable to return to the country for at least five years, Eisenman said.

Eisenman added that he received five letters from England recommending Drummond's reputation, one of which was from Drummond's mother. Eisenman also received a

favorable letter on his behalf from a nurse at the camp.

"Based on all the factors we have mentioned, I suggest giving him a shorter sentence," Eisenman said.

Drummond, who was dressed in a white shirt with blue pin stripes and dark blue cotton pants, told Pickett, "I am very sorry for what's happened. I made a very serious mistake."

Suspect pleads not guilty in alleged assault case

LITCHFIELD — The man charged in connection with the alleged sexual assault of a 14-year-old boy at the Workcoeman Boy Scout camp earlier this month, pleaded not guilty yesterday in Superior Court.

Mark G. Drummond, charged with sexual assault and risk of injury to a minor, also requested a trial by jury, Carl Eisenman, the public defender chosen to represent Drummond, said.

Pretrial motions will be filed Sept. 3., and a hearing on the motions will be Sept. 14. The pretrial will be Sept. 21, the assistant court clerk said.

Drummond, 23, of 39 Wrenbury Resent, Leeds, England, was charged Aug. 16 police said. According to police, the charges stem from a complaint made by administrators at the camp on West Hill Pond.

Drummond came to the camp through a British exchange club that brings foreign students to Connecticut camps for summer jobs, a spokesman for the club said.

Jim Buck, director of the exchange program, said Drummond, a certified teacher in England, had an excellent track record at Workcoeman until the alleged incident.

Buck said Drummond was so appreciated at Workcoeman, that he was invited back by camp officials for the two following summers after his first stay in 1987.

Buck said Drummond's father recently arrived from England to handle details of his son's case.

Drummond is being held at the Litchfield Community Correctional Center on \$25,000 bond.

According to the assistant court clerk in Litchfield, if negotiations at the pretrial fail, the case will go to trial within two months.

Drummond was scheduled to leave the United States Aug. 27. However, his visa is valid until the middle of November, Buck said.

The name of the victim and a description of the incident was sealed by Judge Walter M. Pickett Jr. when Drummond was arraigned.

Camp Workcoeman Worker Charged with Sexual Assault

NEW HARTFORD -- Mark G. Drummond, 29, of 39 Wrenbury Crescent, Leeds, England, was charged with sexual assault and risk of injury to a minor Wednesday at 8:30 p.m., police said.

According to police, the investigation was a result of a complaint made by administrators at Camp Workcoeman on West Hill Pond in connection with the sexual assault of a 14-year-old boy.

According to police, Drummond worked on staff at the

camp for the summer as part of a foreign exchange program.

Drummond was scheduled to leave the United States on Aug. 27. The name of the victim and a description of the incident was sealed yesterday by Judge Waller M. Pickett Jr.

Drummond was arraigned in Superior Court in Litchfield yesterday and assigned a \$25,000 bond. Further action in the case is scheduled for Aug. 29.
