I (Cree) received a visit from two Norfolk police officers one of whom was D.L. Varnell regarding an arrest warrant that they had for Mark Miller, Scoutmaster of Troop 188. They informed me that the complaint involves a boy in the Troop who had been molested by Miller for some 18 months. The molesting charge indicates that Miller had the boy remove his pants and that he spanked his bare bottom while on a camping trip at the Presbyterian Church in 1987. The charge also indicated that Miller offered to get a girl for the boy to have sex with and that the boy said he wanted this. Miller indicated that he had the girl and blindfolded the boy and had the "girl" touch him. The boy reported that no female voice was heard. This happened twice in a row. The blindfold was removed after the "girl" left. The Scoutmaster then applied vaseline to the boy's penis.

The boy had also taken first aid merit badge under Miller. Miller had him give mouth to mouth resuscitation to him as part of the requirements.

The police officers were going to arrest Miller after leaving my office. They were to inform Cree of the status after the arrest so that Cree could hand deliver the suspension letter to him at the police station if possible.

11/15/89

I (Cree) called the home of Council President Larry Dougherty to inform him of the problem but there was no answer.

I called the office of the Council's legal counsel but found that Shields Parsons was out of town for the day. He is to return my call Thursday.

I called Area Director Paul Moore in order that the Region can be properly informed.

I had my secretary prepare the suspension letter and the appeal attachment for later hand delivery to Miller.

11/15/89

I (Cree) met with Council President Dougherty and explained the situation to him. He then signed the suspension letter. I received a phone call from the Norfolk police that the arrest had actually taken place. Assistant Scout Executive Mike Smith went to the jail to deliver the suspension letter but Miller had already been released. Smith called Miller's home and Miller's wife would not allow Miller to be contacted. Smith will try to deliver the letter to Miller on 11/16/89 during the hearing.

11/16/89

I (Cree) received a phone call from retired police officer ██████████ who informed me that problems regarding Miller had existed some years ago and that the Officer Crank was aware of the complaint. ██████████ was questioned by Crank but it seems that any problem at that time took place outside the jurisdiction of the Norfolk police department area. However, they did not notify the Council. He expressed concern regarding Assistant Scoutmaster Clayton H. Elliott, III of the same troop but had nothing firm to present.

11/16/89

Assistant Scout Executive Mike Smith notified Ocean View Presbyterian

Church pastor Jim Corriker of the suspension of Miller.

11/16/89 Mike Smith attempted to deliver the letter at the hearing but the hearing has been delayed. The letter will be send to Miller certified with deliver notification requested as no further delay is desired.

11/16/89 I(Cree) notified Council Legal Counsel Shields Parsons of the situation.

11/20/89

The delivery notification slip was received regarding the suspension letter that was mailed to Mark Miller.

6/ /90

Cree received letter from Paul Ernst asking for any further information.

6/25/90

Mike Smith contact Judge Charles E. Poston of the Juvenile and Domestic Relations Court of the Norfolk requesting information on Mark Miller. He informed Smith that Miller had been charged on 1/11/89 of taking taking indecent liberties with children, a felony. He is awaiting trail on this charge as of this date.

9/14/90

Mr. and Mrs. Mark Miller [REDACTED] asked for an appointment to see me which was done. They reported that all charges had been dropped against Mr. Miller and wanted to know what he could do to get back into Scouting. I told him that he must request a review but that it should have been done in the 90 day period as indicated in the original suspension letter. He also informed Cree that he was working to clear the record with social services. Cree gave him the address of the Regional office so Miller could request the review if he so desired.

10/10/90

Cree received a letter from Paul Ernst asking for current status. Cree asked Assistant Scout Executive Mike Smith to check with Judge Poston on the status.

1/12/91

Cree received a letter from Paul Ernst asking for status. Cree check with Smith who had been assigned the matter to follow up. Smith called Judge Poston and found that the charges had been dropped in August 1990 due to "weakness of witnesses" but the Judge advised Smith that this individual should not be associating with Scouting.

1/21/91

Cree reported by letter to Paul Ernst with a recommendation that the individual not be registered at this time and especially since Miller had not requested to reregistered since the charges were dropped.

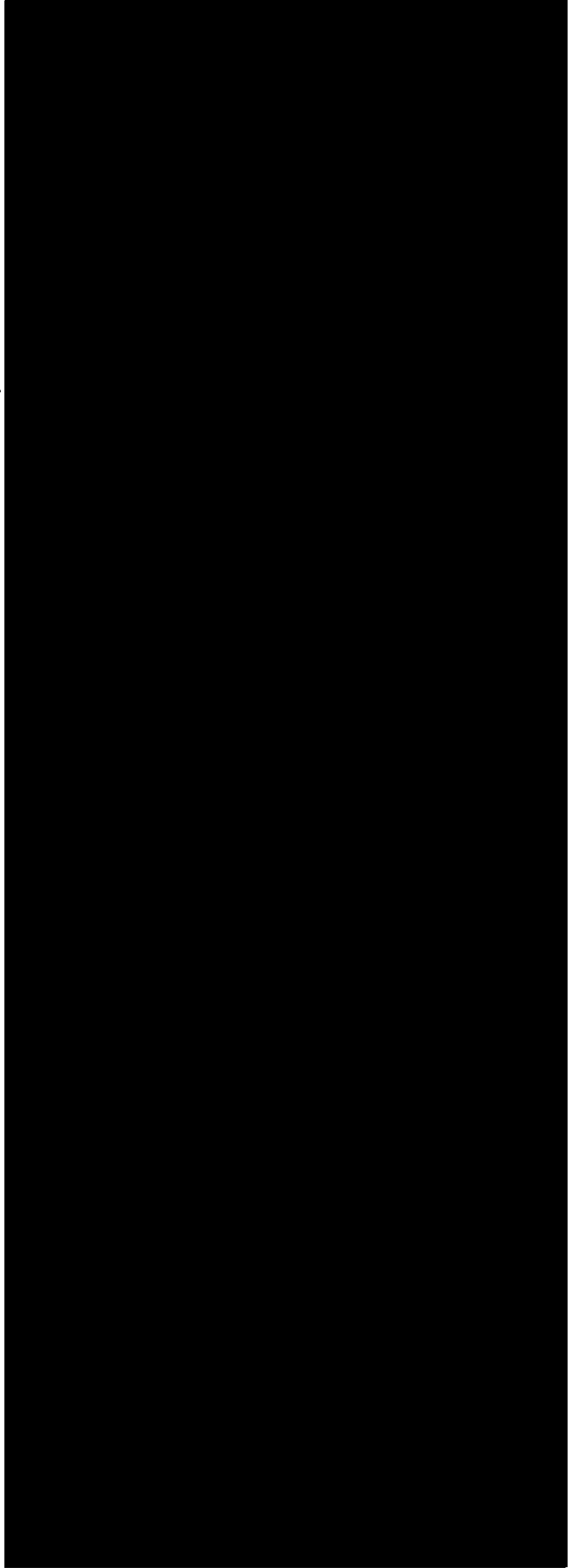

Dear Mr. Miller:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

The following information is provided should you desire a review by the Southeast Region, BSA, of the decision to deny your registration.

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to the regional director, Southeast Region, BSA. In your request you may include your version of what occurred in support of your claim that your registration should not have been denied.
2. Upon the receipt of your written request, a committee will be appointed to review the situation.
3. You may attend the review hearing, but it is not adversarial in nature and neither the committee nor you will be represented by legal counsel. If you wish, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you disagree with the decision of the committee, you may request a review of this decision by the National Council of the Boy Scouts of America.

## Boy Scout leader faces charges of proposing sex with 13-year-old

NORFOLK — A Boy Scout leader was charged Wednesday with taking indecent liberties with one of the boys in his troop, police reported.

The Scout leader, Mark Miller, 36, of the 8200 block of Barkwood Drive, was arrested at 1:20 p.m. at W.B. Goode Co. Inc. in Chesapeake, where he is a supervisor, police said. He was charged with one count of taking indecent liberties with a minor.

Miller is free on bail. The amount of the bail could not be determined.

Miller proposed having sex with the 13-year-old Norfolk boy in July, police said. The incident took place in Miller's home, and not during a

Scouting function, police said.

Police said they are also investigating reports of incidents that occurred during Scout functions. Investigators D.E. Varnell and M.R. Crank of the Youth Division are handling the case.

Robert Cree, director of the Tidewater Council Boy Scouts of America, said Miller's membership has been suspended until the matter is resolved.

Miller was leader of Troop 188, sponsored by the Ocean View Presbyterian Church in the 9200 block of Tidewater Drive. He had been involved with the troop in some capacity since 1971, Cree said.

No complaints against Miller had been made to the Tidewater Council during Miller's 18-year association with the troop, Cree said.
