Fremont man enters guilty plea

A city man pleaded guilty in Sandusky County Common Pleas Court Monday to gross sexual imposition.

Mark S. Zimmerman, 34, 1021 Garfield St., Fremont, was charged with the third degree felony for having sexual intercourse with someone under 13 years of age. The felony is punishable by one to two years in jail and up to a \$5,000 fine.

Zimmerman was released on his own recognizance and was referred by the court to the Sandusky County Adult Probation Department.

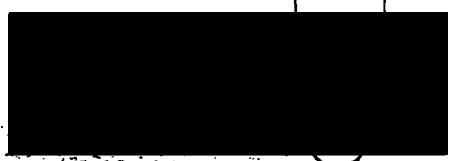

Remonter pleads guilty to gross sexual imposition

News-Messenger reports

A Fremont man was placed on five years probation after pleading guilty in Sandusky County Common Pleas Court to gross sexual imposition of a minor under 13 years of age.

Mark Stephan Zimmerman, 34, 721 Garfield St., was sentenced to the Ohio Department of Rehabilitation and Corrections for two years, but his sentence was de-

ferred and he was placed on probation.

Conditions of his probation require that he serve 90 days in the Sandusky County Jail with work release privileges, pay a \$500 fine, reimburse the county for legal fees, continue receiving counseling with the Sandusky Valley Center and that he have no contact with the victim. Zimmerman waived an indict-

ment on the third-degree felony charge last November and pleaded guilty. Sentencing was deferred pending an evaluation by the Sandusky County Adult Probation Department.

Jeffrey Smith was released on a \$10,000 unsecured appearance bond. Trial date was set for March 10.

The charges stem from a February incident when a Woodville Police officer discovered Smith carrying a loaded .38-caliber handgun. Smith had previously been convicted of carrying a concealed weapon in 1984.
